18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 25-18-201 is repealed.

21 ~~25-18-201. Messages, reports, and other documents—Distribution.~~

22 ~~(a)(1) Before the commencement of each regular session of the General~~
23 ~~Assembly, there shall be printed and delivered to the Secretary of State two~~
24 ~~thousand (2,000) copies each of the Governor's message and Secretary of~~
25 ~~State's report, one thousand (1,000) copies each of the reports of the~~
26 ~~Auditor of State, Treasurer of State, and University of Arkansas, and five~~
27 ~~hundred (500) copies each of all other reports and public documents required~~
28 ~~by law to be published.—~~

29 ~~(2)(A) One half (1/2) of all these documents are to be for the~~
30 ~~use of the General Assembly and the other half for distribution by the~~
31 ~~Secretary of State.—~~

32 ~~(B) However, one half (1/2) of the reports of the~~
33 ~~University of Arkansas shall be delivered to the trustees thereof for~~
34 ~~distribution, and only the balance is to be divided as provided for in this~~
35 ~~section.—~~

36 ~~(b)(1) No greater number of these reports and public documents shall~~

1 ~~be printed, except by resolution of the General Assembly.~~

2 ~~(2) However, this subsection shall not prevent either house from~~

12 ~~his office.~~
