10 AN ACT TO AUTHORIZE THE SUSAN G. KOMEN BREAST
11 CANCER EDUCATION, RESEARCH, AND AWARENESS LICENSE
12 PLATE; AND FOR OTHER PURPOSES.

14 AN ACT TO AUTHORIZE THE SUSAN G. KOMEN
15 BREAST CANCER EDUCATION, RESEARCH, AND
16 AWARENESS LICENSE PLATE.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code Title 27, Chapter 15, is amended to add an
23 additional subchapter to read as follows:

24 Subchapter 39. Susan G. Komen Breast Cancer Education, Research, and
25 Awareness License Plate.

26 27-15-3901. Susan G. Komen Breast Cancer Education, Research, and
27 Awareness license plate authorized.

28 The Director of the Department of Finance and Administration shall
29 provide for and issue Susan G. Komen Breast Cancer Education, Research, and
30 Awareness special license plates in the manner and subject to the conditions
31 under this subchapter.
32

33 27-15-3902. Plate design.

34 (a)(1) The special motor vehicle license plates shall be designed by
35 the Arkansas affiliate of the Susan G. Komen Foundation.

36 (2) The design shall be submitted for design approval by the



1 Director of the Department of Finance and Administration under rules and
2 regulations of the director.

3 (3) The Arkansas affiliate of the Susan G. Komen Foundation may
4 periodically submit a newly designed license plate for approval and issue by
5 the director, with not more than one (1) license plate new design issued per
6 calendar year.

7 (b)(1) Upon approval of the design by the director, the Arkansas
8 affiliate of the Susan G. Komen Foundation shall remit to the department a
9 fee in the amount of six thousand dollars (\$6,000) to cover the cost of the
10 initial order of each newly designed license plate.

11 (2) This fee shall be deposited to the State Central Services
12 Fund for the benefit of the Revenue Division of the Department of Finance and
13 Administration and shall be credited as supplemental and in addition to all
14 other funds as may be deposited for the benefit of the division.

15 (3) The fee shall not be considered or credited to the division
16 as direct revenues.

17 (c) The director shall promulgate reasonable rules and regulations and
18 prescribe any forms as the director determines to be necessary to carry out
19 the intent and purposes of this subchapter.

20
21 27-15-3903. Fees.

22 (a) Upon payment of the fee required by law for the registration of
23 the vehicle, payment of twenty-five dollars (\$25.00) to cover the design use
24 contribution and payment of an additional ten dollars (\$10.00) handling and
25 administrative fee for the issuance of the special Susan G. Komen Breast
26 Cancer Education, Research, and Awareness license plate, the Department of
27 Finance and Administration shall issue to the vehicle owner a Susan G. Komen
28 Breast Cancer Education, Research, and Awareness license plate which shall
29 bear the approved design.

30 (b)(1) The handling and administrative fee of ten dollars (\$10.00)
31 shall be deposited to the State Central Services Fund for the benefit of the
32 Revenue Division of the Department of Finance and Administration and shall
33 not be considered or credited to the division as direct revenues.

34 (2) The design use contribution of twenty-five dollars (\$25.00)
35 shall be deposited to the Breast Cancer Research Fund to be used by the
36 University of Arkansas for Medical Sciences, Arkansas Cancer Research Center

1 for the purpose of breast cancer education, outreach, and research.

2 (3) The funds shall be distributed from the fund as follows:

3 (A) Fifty percent (50%) of the funds shall be retained in
4 the fund to be used by the University of Arkansas for Medical Sciences,
5 Arkansas Cancer Research Center Breast Program; and

6 (B) Fifty (50%) of the funds shall be distributed to the
7 Arkansas affiliate of the Susan G. Komen Foundation.

8
9 27-15-3905. Renewal.

10 (a)(1) Special Susan G. Komen Breast Cancer Education, Research, and
11 Awareness license plates issued under this subchapter may be renewed annually
12 under the procedures and upon payment of the fees under § 27-15-3903 and
13 under §§ 27-14-1012 and 27-14-1013.

14 (2) Registration may continue from year to year as long as it is
15 renewed each year within the time and manner required by law.

16 (3) A motor vehicle owner who was previously issued a plate with
17 the Susan G. Komen Breast Cancer Education, Research, and Awareness design
18 authorized by this subchapter and who does not pay a design use contribution
19 of twenty-five dollars (\$25.00) at the subsequent time of registration shall
20 be issued a new plate which does not bear the Susan G. Komen Breast Cancer
21 Education, Research, and Awareness design.

22 (b) If the special Susan G. Komen Breast Cancer Education, Research,
23 and Awareness license plate is replaced with a new license plate, the owner
24 shall be required to pay the additional administrative costs for issuance
25 under § 27-15-3903.

26 (c) Upon expiration, or if the special Susan G. Komen Breast Cancer
27 Education, Research, and Awareness license plate is lost, it may be replaced
28 with a regular license plate at the fee specified in § 27-14-602(b)(6).

29
30 27-15-3906. Transfer to another vehicle.

31 Special Susan G. Komen Breast Cancer Education, Research, and Awareness
32 license plates issued under this subchapter may be transferred from one
33 vehicle to another under § 27-14-914.

34
35 27-15-3907. Compliance with other laws.

36 The special Susan G. Komen Breast Cancer Education, Research, and

1 Awareness license plates shall comply with all other state motor vehicle laws
2 relating to registration and licensing of motor vehicles, including the
3 minimum number of license plate applications required under § 27-15-4004,
4 except as specifically provided otherwise in this subchapter.
