19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 12-8-203 is amended to read as follows:
22 12-8-203. Probationary period.

23 Each person who is selected as a member of the Arkansas State Police
24 shall be for a period of one (1) year after completion of the Arkansas State
25 Police recruit academy and prescribed field training program a probationer
26 and during that time may be discharged by the Director of the Department of
27 Arkansas State Police with the approval of the Arkansas State Police
28 Commission with or without cause and, provided further, that the probationary
29 period shall not apply to those who have theretofore served a probationary
30 period.

32 SECTION 2. Arkansas Code § 12-8-211 is repealed.

34 ~~The Department of Arkansas State Police is authorized to reimburse~~
35 ~~uniformed personnel of the department, from moneys appropriated for the~~
36 ~~maintenance and operation of the department, for an amount expended in~~



1 ~~obtaining a rider to any motor vehicle liability insurance policy which any~~
2 ~~individual uniformed employee of the department may purchase on his private~~
3 ~~motor vehicle to provide additional motor vehicle liability coverage in the~~

12 SECTION 3. Arkansas Code § 12-8-215(c)(2), concerning additional
13 salary payments for employees of the Department of Arkansas State Police, is
14 amended to read as follows:

15 (2) Payment of such funds may be made monthly, quarterly,
16 semiannually, or annually depending upon the availability of revenues and
17 shall be restricted to the following classifications:

- 18 (A) Director of the Department of Arkansas State Police;
- 19 (B) ~~Assistant Director of the Department of Arkansas State~~
20 ~~Police~~ Arkansas State Police Lieutenant Colonel;
- 21 (C) Arkansas State Police major;
- 22 (D) Arkansas State Police captain;
- 23 (E) Arkansas State Police lieutenant;
- 24 (F) Arkansas State Police sergeant;
- 25 (G) Arkansas State Police corporal;
- 26 (H) Arkansas State Police trooper, first class;
- 27 (I) Arkansas State Police trooper;
- 28 (J) Manager, Diversion Investigation Unit; and
- 29 (K) Drug diversion investigator.
