21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
24 established for the Arkansas State Building Services for the 2003-2005
25 biennium, the following maximum number of regular employees whose salaries
26 shall be governed by the provisions of the Uniform Classification and
27 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
28 all laws amendatory thereto. Provided, however, that any position to which a
29 specific maximum annual salary is set out herein in dollars, shall be exempt
30 from the provisions of said Uniform Classification and Compensation Act. All
31 persons occupying positions authorized herein are hereby governed by the
32 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
33 Code §21-5-101), or its successor.

26 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
28 OF FUNDS. Arkansas State Building Services may from time to time as may be
29 necessary and in such amounts as may be necessary and with the approval of
30 the Chief Fiscal Officer of the State, request a transfer of funds from the
31 State Central Services Fund to the Arkansas State Building Services
32 Maintenance Fund for operation of the Justice Building for actual
33 expenditures, in an amount not to exceed the dollar amount appropriated in
34 Section 7 for each of the fiscal years. Upon his approval, the Chief Fiscal
35 Officer of the State shall then initiate the necessary transfer documents to
36 reflect the transfer upon the fiscal records of the State Auditor, the State

1 Treasurer, the Chief Fiscal Officer of the State and Arkansas State Building
 2 Services. The provisions of this section shall be in effect only from ~~July~~
 3 ~~1, 2001~~ July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

 5 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 7 FORWARD-CRITICAL MAINTENANCE. At the close of the fiscal year ending June 30,
 8 ~~2002~~ 2004, any unexpended appropriation and funds provided for Critical
 9 Maintenance shall be carried forward and made available for the same purposes
 10 for the fiscal year ending ~~June 30, 2003~~ June 30, 2005. The provisions of
 11 this section shall be in effect only from ~~July 1, 2001~~ July 1, 2003 through

 16 RESTRICTIONS. Arkansas State Building Services shall not demolish the Aegon
 17 building but shall retain the building as suitable office space to be used by
 18 state agencies, boards, commissions, offices and departments. The provisions
 19 of this section shall be in effect only from ~~July 1, 2001~~ July 1, 2003
 20 through ~~June 30, 2003~~ June 30, 2005.

 22 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 24 OF FUNDS. The Arkansas State Building Services is hereby authorized, after
 25 seeking the approval of the Chief Fiscal Officer of the State and the
 26 Arkansas Legislative Council or Joint Budget Committee to request transfer
 27 from the appropriation made in Section 5 for Building Maintenance to the
 28 APPROPRIATION-ACQUISITION AND MAINTENANCE appropriation in Section 10 and to
 29 receive from another state agency that seeks like approvals its authority,
 30 appropriation and the transfer of funds to be deposited into the State
 31 Building Services Real Estate Fund to become part of the APPROPRIATION -
 32 ACQUISITION AND MAINTENANCE appropriation, and to be used for any purposes as
 33 set forth by law for said Real Estate Fund.

34
 35 Determining the maximum number of employees and the maximum amount of
 36 appropriation and general revenue funding for a state agency each fiscal year

1 is the prerogative of the General Assembly. This is usually accomplished by
 2 delineating such maximums in the appropriation act(s) for a state agency and
 3 the general revenue allocations authorized for each fund and fund account by
 4 amendment to the Revenue Stabilization law. Further, the General Assembly
 5 has determined that the Arkansas State Building Services may operate more
 6 efficiently if some flexibility is provided to the Arkansas State Building
 7 Services authorizing broad powers under this section. Therefore, it is both
 8 necessary and appropriate that the General Assembly maintain oversight by
 9 requiring prior approval of the Legislative Council or Joint Budget Committee
 10 as provided by this section. The requirement of approval by the Legislative
 11 Council or Joint Budget Committee is not a severable part of this section.
 12 If the requirement of approval by the Legislative Council or Joint Budget
 13 Committee is ruled unconstitutional by a court of competent jurisdiction,
 14 this entire section is void.
 15 The provisions of this section shall be in effect only from July 1, 2003
 16 through June 30, 2005.

17
 18 *SECTION 15. FACILITIES MANAGEMENT CONTINGENCY APPROPRIATION. There is*
 19 *hereby appropriated, to the Arkansas State Building Services, to be payable*
 20 *from revenues collected and transferred to the Arkansas State Building*
 21 *Services for any program as set out in Section 17 of this Act, as designated*
 22 *by the Chief Fiscal Officer of the State, for use in responding to the*
 23 *infrastructure needs of Arkansas State Government, for the biennial period*
 24 *ending June 30, 2005, the sum of\$250,000.*

25
 26 *SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
 27 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE*
 28 *BUILDING SERVICES CONTINGENCY APPROPRIATION TRANSFER AUTHORITY. The Arkansas*
 29 *State Building Services may transfer appropriation and funds as needed from*
 30 *the Facilities Management Contingency Appropriation in Section 15 of this Act*
 31 *to any appropriation authorized for the Arkansas State Building Services for*
 32 *the 2003-05 biennium. The provisions of this section shall be in effect only*
 33 *from July 1, 2003 through June 30, 2005.*

34
 35 *SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
 36 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER*

1 TO FACILITIES MANAGEMENT CONTINGENCY APPROPRIATION AUTHORITY. (a) In order to
2 provide a more cost effective method to address the emerging infrastructure
3 needs of Arkansas State Government, appropriations and funds transferred to
4 the Facilities Management Contingency Appropriation are to be used in the
5 event that the Arkansas State Building Services executes one or more building
6 contracts or maintenance agreements with State Agencies, and the
7 appropriations or funds otherwise provided for the Arkansas State Building
8 Services are not sufficient to address those needs, and it is more cost
9 effective for the Arkansas State Building Services to execute these services.
10 Any State Agency may transfer or deposit funds and appropriations to the
11 Arkansas State Building Services - Facilities Management Contingency
12 Appropriation authorized in Section 15 of this Act to execute one or more
13 building contracts or maintenance agreements with said State Agencies. The
14 Arkansas State Building Services shall provide justification to the Chief
15 Fiscal Officer of the State for the need of such appropriations and funds
16 transfers and seek and receive approval of the Chief Fiscal Officer of the
17 State. Arkansas State Building Services shall then seek and receive the
18 approval of the Arkansas Legislative Council or Joint Budget Committee. The
19 requirement of approval by the Arkansas Legislative Council or Joint Budget
20 Committee is not a severable part of the section. If the requirement of
21 approval by the Arkansas Legislative Council or Joint Budget Committee is
22 ruled unconstitutional by a court of competent jurisdiction, this entire
23 section is void.

24 (b) The Chief Fiscal Officer of the State shall make the necessary
25 adjustments on his or her books and the books of the Auditor of the State for
26 the transfer or deposit of the funds and appropriations from each State
27 Agency to the appropriation authorized in Section 15 of this Act and to the
28 various Arkansas State Building Services accounts to be used exclusively by
29 the Arkansas State Building Services for each fiscal year of the 2003-2005
30 biennium. The provisions of this section shall be in effect only from July
31 1, 2003 through June 30, 2005.

32
33 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
34 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. POSITION POOL.
35 To address the emerging infrastructure needs of Arkansas state government,
36 the Arkansas State Building Services shall establish and maintain for the

1 2003-2005 biennium a pool of twenty (20) classified positions, payable from
2 funds appropriated herein for such purposes. These positions are to be used
3 in the event the Arkansas State Building Services executes one or more
4 building contracts or maintenance agreements with state agencies, and the
5 number and level of positions regularly authorized for the Arkansas State
6 Building Services are not sufficient to address these needs. The Arkansas
7 State Building Services shall provide justification to the Department of
8 Finance and Administration's Office of Personnel Management (OPM) for the
9 need to allocate titles from this position pool. No classifications will be
10 assigned to the pool until such time as specific positions are requested and
11 justified by the Arkansas State Building Services, recommended by OPM and
12 approved by the Arkansas Legislative Council. The Arkansas State Building
13 Services may transfer positions from this pool to any appropriation/pay
14 schedule the agency currently maintains or any appropriation/pay schedule the
15 agency receives for the 2003-2005 biennium. If the agency requests
16 continuation of a "Growth Pool" position(s) as established herein during the
17 next biennium, the position(s) must be requested as a new position(s) in the
18 agencies biennial budget request. Determining the number of personnel to be
19 employed by a state agency is the prerogative of the General Assembly and is
20 usually accomplished by delineating the maximum number of personnel by
21 identifying job titles and the maximum grade or salary attached to those
22 titles. The General Assembly has determined that the Arkansas State Building
23 Services could be operated more efficiently if some flexibility is given to
24 that agency. That flexibility is being accomplished by providing growth
25 pools as in the section and since the General Assembly has granted the agency
26 broad powers under the growth pool concept, it is both necessary and
27 appropriate that the General Assembly maintain oversight of the utilization
28 of the growth pool by requiring prior approval of the Legislative Council in
29 the utilization of the growth pool. Therefore, the requirement of approval
30 by the Legislative Council is not a severable part of this section. If the
31 requirement of approval by the Legislative Council is ruled unconstitutional
32 by a court of competent jurisdiction, this entire section is void.

33
34 SECTION 19. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
35 by this act shall be limited to the appropriation for such agency and funds
36 made available by law for the support of such appropriations; and the

1 restrictions of the State Purchasing Law, the General Accounting and
2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
3 Procedures and Restrictions Act, or their successors, and other fiscal
4 control laws of this State, where applicable, and regulations promulgated by
5 the Department of Finance and Administration, as authorized by law, shall be
6 strictly complied with in disbursement of said funds.

7
8 SECTION 20. LEGISLATIVE INTENT. It is the intent of the General Assembly
9 that any funds disbursed under the authority of the appropriations contained
10 in this act shall be in compliance with the stated reasons for which this act
11 was adopted, as evidenced by the Agency Requests, Executive Recommendations
12 and Legislative Recommendations contained in the budget manuals prepared by
13 the Department of Finance and Administration, letters, or summarized oral
14 testimony in the official minutes of the Arkansas Legislative Council or
15 Joint Budget Committee which relate to its passage and adoption.

16
17 SECTION 21. EMERGENCY CLAUSE. It is found and determined by the General
18 Assembly, that the Constitution of the State of Arkansas prohibits the
19 appropriation of funds for more than a two (2) year period; that the
20 effectiveness of this Act on July 1, 2003 is essential to the operation of
21 the agency for which the appropriations in this Act are provided, and that in
22 the event of an extension of the Regular Session, the delay in the effective
23 date of this Act beyond July 1, 2003 could work irreparable harm upon the
24 proper administration and provision of essential governmental programs.
25 Therefore, an emergency is hereby declared to exist and this Act being
26 necessary for the immediate preservation of the public peace, health and
27 safety shall be in full force and effect from and after July 1, 2003.
