28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

30 SECTION 1. Arkansas Code § 25-1-106 is amended to read as follows:
31 25-1-106. Evaluation of necessity of various commissions and boards.

32 (a) Any part-time state board or commission which has not convened a
33 meeting or has convened without a quorum for two (2) consecutive, regularly
34 scheduled meeting dates within a two-year period shall vote to elect a new
35 chair and vice chair.

36 (b) If a part-time state board or commission has not convened a



1 regularly scheduled meeting or has convened without a quorum for four (4)
2 consecutive, regularly scheduled meeting dates within a two-year period, the
3 Joint Performance Review Committee shall reevaluate the purpose, need, and
4 effectiveness of the board or commission. The committee shall report its
5 findings and any recommendations concerning the existence of the board or
6 commission to the Legislative Council no later than December 1 of each even
7 numbered year and shall draft legislation to implement the recommendations.

8 (c)~~(1)~~ Each part-time board and commission shall, no later than August
9 1 of each even numbered year, provide the committee with a list of the
10 regularly scheduled meeting dates for the board or commission for the
11 previous two (2) fiscal years, including the attendance record of each member
12 and the number of meetings which were convened.

13 ~~(2) This information shall be submitted to the committee~~
14 ~~biannually beginning January 1, 2000.~~
