27 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29 SECTION 1. Arkansas Code § 20-77-102, concerning the program for long-
30 term care facility care, is amended to add an additional subsection to read
31 as follows:

32 (e) To the extent not prohibited by federal law or regulation, the
33 Department of Human Services shall promulgate rules concerning prior
34 authorization for Medicaid ElderChoices, a community based service, that is
35 identical to those in effect for nursing homes on the effective date of this
36 subsection.
