## For An Act To Be Entitled

9 AN ACT TO MAKE AN APPROPRIATION FOR OPERATING  
10 EXPENSES FOR THE ARKANSAS LIVESTOCK AND POULTRY  
11 COMMISSION WHICH SHALL BE SUPPLEMENTAL AND IN  
12 ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 759  
13 OF 2001; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE ARKANSAS LIVESTOCK AND  
16 POULTRY COMMISSION - OPERATING EXPENSES

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. APPROPRIATION - LARGE ANIMAL AND POULTRY - SPECIAL. There is  
25 hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be  
26 payable from the Livestock and Poultry Fund Account, for operating expenses  
27 of the Arkansas Livestock and Poultry Commission - Large Animals and Poultry  
28 which shall be supplemental and in addition to those funds appropriated in  
29 Section 14 of Act 759 of 2001, the following:

5 SECTION 2. APPROPRIATION - SWAMP FEVER TESTING PROGRAM - SPECIAL. There is  
 6 hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be  
 7 payable from the Livestock and Poultry Fund Account, for Swamp Fever Testing  
 8 expenses of the Arkansas Livestock and Poultry Commission - Swamp Fever  
 9 Testing Program which shall be supplemental and in addition to those funds  
 10 appropriated in Section 11 of Act 759 of 2001, the following:

17 SECTION 3. APPROPRIATION - SMALL ANIMAL TESTING PROGRAM - SPECIAL. There  
 18 is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to  
 19 be payable from the Livestock and Poultry Fund Account, for operating  
 20 expenses of the Arkansas Livestock and Poultry Commission - Small Animal  
 21 Testing Program which shall be supplemental and in addition to those funds  
 22 appropriated in Section 12 of Act 759 of 2001, the following:

34 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
 35 by this act shall be limited to the appropriation for such agency and funds  
 36 made available by law for the support of such appropriations; and the

1 restrictions of the State Purchasing Law, the General Accounting and  
2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
3 Procedures and Restrictions Act, or their successors, and other fiscal  
4 control laws of this State, where applicable, and regulations promulgated by  
5 the Department of Finance and Administration, as authorized by law, shall be  
6 strictly complied with in disbursement of said funds.

7  
8 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly  
9 that any funds disbursed under the authority of the appropriations contained  
10 in this act shall be in compliance with the stated reasons for which this act  
11 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
12 and Legislative Recommendations contained in the budget manuals prepared by  
13 the Department of Finance and Administration, letters, or summarized oral  
14 testimony in the official minutes of the Arkansas Legislative Council or  
15 Joint Budget Committee which relate to its passage and adoption.

16  
17 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
18 Assembly, that funds provided by the General Assembly for the operations of  
19 the Arkansas Livestock and Poultry Commission are, due to unforeseen  
20 circumstances, insufficient for the Arkansas Livestock and Poultry Commission  
21 to continue to provide essential governmental services; that the provisions  
22 of this act will provide the necessary monies for the Arkansas Livestock and  
23 Poultry Commission to continue such services; and that a delay in the  
24 effective date of this Act could work irreparable harm upon the proper  
25 administration and provision of essential governmental programs. Therefore,  
26 an emergency is hereby declared to exist and this Act being necessary for the  
27 immediate preservation of the public peace, health and safety shall be in  
28 full force and effect from and after the date of its passage and approval.

29 If the bill is neither approved nor vetoed by the Governor, it shall become  
30 effective on the expiration of the period of time during which the Governor  
31 may veto the bill. If the bill is vetoed by the Governor and the veto is  
32 overridden, it shall become effective on the date the last house overrides  
33 the veto.
