10 AN ACT TO AMEND ARKANSAS CODE § 27-16-805 TO
11 AUTHORIZE THE DEPARTMENT OF FINANCE AND
12 ADMINISTRATION TO ISSUE IDENTIFICATION CARDS TO
13 PERSONS WHO ARE FIVE (5) YEARS OF AGE AND OLDER;
14 AND FOR OTHER PURPOSES.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 27-16-805 is amended to read as follows:
26 27-16-805. Identification purposes only.

27 (a)(1) The office may issue an identification card to those Arkansas
28 residents ~~fourteen (14)~~ five (5) years of age or older who are not licensed
29 drivers.

30 (2) The fee for such a card shall be five dollars (\$5.00).

31 (b)(1)(A) ~~The~~ For those persons under age sixty (60), the card shall
32 be valid for either four (4) years or two (2) years depending on the person's
33 age and be is renewable upon expiration.

34 (B) For persons age fourteen (14) and older, the card shall
35 be valid for four (4) years from the date of issue.

36 (C) For persons age five (5) to thirteen (13), the card



1 shall be valid for two (2) years from the date of issue, and a parent or
2 legal guardian must accompany the applicant to the issuing location and sign
3 the electronic application.

4 (2) Those persons who are sixty (60) years old or older who
5 qualify for this card shall be issued such card to be valid for life of the
6 holder.

7 (c) Each card shall contain:

- 8 (1) A color photograph of the applicant;
- 9 (2) A physical description;
- 10 (3) The birthdate;
- 11 (4) The address;
- 12 (5) The date of issue; and
- 13 (6) The expiration date.

14 (d)(1) Any person who applies for such a card shall be required to
15 show proof of identity.

16 (2) Refusal of an applicant to show such proof shall result in
17 denial of the application.
