19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 19-6-201(6) is amended to reflect current
22 General Revenues Enumerated to read as follows:

24 as enacted by Act 546 of 1977, known as the "Arkansas Tobacco Products Tax
25 Act of 1977", and all laws amendatory thereto, § 26-57-201 et seq.;

 24 SECTION 23. EMERGENCY CLAUSE. It is hereby found and determined by
 25 the Eighty-fourth General Assembly that various laws have been enacted since
 26 the passage of the Revenue Classification Law which have changed or created
 27 various revenues collected by the State, and that this amendment to the
 28 Revenue Classification Law is necessary in order to reflect the various
 29 taxes, licenses, fees and other revenues levied and collected for the support
 30 of and use by State Government as they currently exist and from which
 31 appropriations which become effective July 1, 2003 have been made by the
 32 Eighty-fourth General Assembly. Therefore, an emergency is declared to
 33 exist and this act being immediately necessary for the preservation of the
 34 public peace, health and safety shall become effective on July 1, 2003.
