22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
25 the Arkansas Science and Technology Authority for the 2003-2005 biennium, the
26 following maximum number of regular employees whose salaries shall be
27 governed by the provisions of the Uniform Classification and Compensation Act
28 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
29 thereto. Provided, however, that any position to which a specific maximum
30 annual salary is set out herein in dollars, shall be exempt from the
31 provisions of said Uniform Classification and Compensation Act. All persons
32 occupying positions authorized herein are hereby governed by the provisions
33 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
34 101), or its successor.

21 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the
 22 Arkansas Science and Technology Authority for the 2003-2005 biennium, the
 23 following maximum number of part-time or temporary employees, to be known as
 24 "Extra Help", payable from funds appropriated herein for such purposes: two
 25 (2) temporary or part-time employees, when needed, at rates of pay not to
 26 exceed those provided in the Uniform Classification and Compensation Act, or
 27 its successor, or this act for the appropriate classification.

29 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby appropriated,
 30 to the Arkansas Science and Technology Authority, to be payable from the
 31 State General Services Fund Account, for personal services and operating
 32 expenses of the Arkansas Science and Technology Authority for the biennial
 33 period ending June 30, 2005, the following:

10 SECTION 6. APPROPRIATION - WINTHROP ROCKEFELLER FOUNDATION GRANT. There

11 is hereby appropriated, to the Arkansas Science and Technology Authority, to

12 be payable from the cash fund deposited in the State Treasury as determined

13 by the Chief Fiscal Officer of the State, for science grants to middle-

14 schools by the Arkansas Science and Technology Authority for the biennial

15 period ending June 30, 2005, the following:

21 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY

23 FORWARD. The Arkansas Science and Technology Authority ("Authority") is

24 authorized to carry forward any obligated but unexpended balance of

25 appropriations and funds authorized for the Authority for making grants under

26 the Authority's Basic and Applied Research Grants Program, which remains at

27 the close of the first year of a biennium to the second year of the biennium,

28 there to be used for the same purpose. The amount authorized to be carried

29 forward shall be limited to ten percent (10%) of the amount appropriated and

30 funded for grants under the Authority's Basic and Applied Research Grant

31 Program. The provisions of this section shall be in effect only from ~~July 1,~~

32 ~~2001~~ July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

34 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized

35 by this act shall be limited to the appropriation for such agency and funds

36 made available by law for the support of such appropriations; and the

1 restrictions of the State Purchasing Law, the General Accounting and
 2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 3 Procedures and Restrictions Act, or their successors, and other fiscal
 4 control laws of this State, where applicable, and regulations promulgated by
 5 the Department of Finance and Administration, as authorized by law, shall be
 6 strictly complied with in disbursement of said funds.

7
 8 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
 9 that any funds disbursed under the authority of the appropriations contained
 10 in this act shall be in compliance with the stated reasons for which this act
 11 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 12 and Legislative Recommendations contained in the budget manuals prepared by
 13 the Department of Finance and Administration, letters, or summarized oral
 14 testimony in the official minutes of the Arkansas Legislative Council or
 15 Joint Budget Committee which relate to its passage and adoption.

16
 17 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the General
 18 Assembly, that the Constitution of the State of Arkansas prohibits the
 19 appropriation of funds for more than a two (2) year period; that the
 20 effectiveness of this Act on July 1, 2003 is essential to the operation of
 21 the agency for which the appropriations in this Act are provided, and that in
 22 the event of an extension of the Regular Session, the delay in the effective
 23 date of this Act beyond July 1, 2003 could work irreparable harm upon the
 24 proper administration and provision of essential governmental programs.
 25 Therefore, an emergency is hereby declared to exist and this Act being
 26 necessary for the immediate preservation of the public peace, health and
 27 safety shall be in full force and effect from and after July 1, 2003.
