## For An Act To Be Entitled

9 AN ACT TO ALLOW REGISTRATION OF OLDER ALL TERRAIN  
10 CYCLES WITH A STATEMENT OF OWNERSHIP; AND FOR  
11 OTHER PURPOSES.

## Subtitle

14 TO ALLOW REGISTRATION OF OLDER ALL  
15 TERRAIN CYCLES WITH A STATEMENT OF  
16 OWNERSHIP.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code § 27-20-202 is amended to read as follows:  
22 27-20-202. Registration required.

23 (a) All owners of three-wheeled or four-wheeled all-terrain cycles  
24 which are not otherwise required to be registered by law shall, within thirty  
25 (30) calendar days of acquiring the three-wheeled or four-wheeled cycles,  
26 register them with the Director of the Department of Finance and  
27 Administration.

28 (b)(1) The owners shall offer proof of ownership satisfactory to the  
29 department.

30 (2)(A) If the person seeking to register the all-terrain cycle  
31 cannot offer satisfactory proof of ownership, the department may register the  
32 all-terrain cycle if the person seeking registration posts a bond equal to at  
33 least one and one-half (1 1/2) times the market value of the all-terrain  
34 cycle.

35 ~~(A)~~(i) The bond shall be a cash bond, a letter of  
36 credit, a surety bond issued by a fidelity or surety company authorized to do



1 business in Arkansas, or a personal bond signed by at least two (2) property  
2 owners in this state.

3 ~~(B)(ii)~~ The bond shall be for a period of three (3)  
4 years and made payable to the Department of Finance and Administration to be  
5 used by the department to pay any valid claim arising from the disputed  
6 ownership of the all-terrain cycle.

7 (B)(i) If the three-wheeled or four-wheeled all-terrain  
8 cycle was manufactured on or before December 31, 1992, then proof of  
9 ownership shall not be required to obtain registration, and a statement of  
10 ownership shall be accepted as proof of ownership.

11 (ii) The statement of ownership may be prepared by  
12 the person and shall contain the following information:

13 (a) The person's name;

14 (b) A description of the cycle;

15 (c) A statement that the cycle was  
16 manufactured on or before December 31, 1992;

17 (d) A statement of ownership; and

18 (e) The person's signature.

19 (c) The cost of registration shall be five dollars (\$5.00).
