13 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
14 APPROPRIATED BY ACT 1309 OF 2003; AND FOR OTHER

18 AN ACT FOR THE DEPARTMENT OF WORKFORCE
19 EDUCATION SUPPLEMENTAL APPROPRIATION.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. REGULAR SALARIES. There is hereby established for the
26 Department of Workforce Education the following maximum number of regular
27 employees which shall be supplemental and in addition to those positions
28 authorized in Section 1 of Act 1309 of 2003 and whose salaries shall be
29 governed by the provisions of the Uniform Classification and Compensation Act
30 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
31 thereto. Provided, however, that any position to which a specific maximum
32 annual salary is set out herein in dollars, shall be exempt from the
33 provisions of said Uniform Classification and Compensation Act. All persons
34 occupying positions authorized herein are hereby governed by the provisions
35 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
36 101), or its successor.

SECTION 2. APPROPRIATION - VOCATIONAL, TECHNICAL AND ADULT EDUCATION.
 There is hereby appropriated, to the Department of Workforce Education, to be payable from the Department of Workforce Education Fund Account, for personal services and operating expenses of the Department of Workforce Education - Vocational, Technical and Adult Education which shall be supplemental and in addition to those funds appropriated in Section 3 of Act 1309 of 2003, the following:

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be

1 strictly complied with in disbursement of said funds.

3 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly
4 that any funds disbursed under the authority of the appropriations contained
5 in this act shall be in compliance with the stated reasons for which this act
6 was adopted, as evidenced by the Agency Requests, Executive Recommendations
7 and Legislative Recommendations contained in the budget manuals prepared by
8 the Department of Finance and Administration, letters, or summarized oral
9 testimony in the official minutes of the Arkansas Legislative Council or
10 Joint Budget Committee which relate to its passage and adoption.

12 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
13 Assembly, that funds provided by the General Assembly for the operations of
14 the Department of Workforce Education are, due to unforeseen circumstances,
15 insufficient for the Department of Workforce Education to continue to provide
16 essential governmental services; that the provisions of this act will provide
17 the necessary monies for the Department of Workforce Education to continue
18 such services; and that a delay in the effective date of this Act could work
19 irreparable harm upon the proper administration and provision of essential
20 governmental programs. Therefore, an emergency is hereby declared to exist
21 and this Act being necessary for the immediate preservation of the public
22 peace, health and safety shall be in full force and effect from and after the
23 date of its passage and approval.

24 If the bill is neither approved nor vetoed by the Governor, it shall become
25 effective on the expiration of the period of time during which the Governor
26 may veto the bill. If the bill is vetoed by the Governor and the veto is
27 overridden, it shall become effective on the date the last house overrides
28 the veto.
