## For An Act To Be Entitled

10 AN ACT TO ESTABLISH A "GROWTH POOL" OF POSITIONS  
11 FOR PUBLIC UNIVERSITIES IN ARKANSAS; AND FOR  
12 OTHER PURPOSES.

### Subtitle

14 AN ACT TO ESTABLISH "GROWTH POOL" OF  
15 POSITIONS FOR PUBLIC UNIVERSITIES IN  
16 ARKANSAS.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Establishment of a growth pool.

23 (a)(1) The Department of Higher Education shall establish and maintain  
24 for the 2005 – 2007 biennium a pool of one hundred fifty (150) nonclassified  
25 positions at a salary not to exceed ninety thousand dollars (\$90,000) per  
26 year.

27 (2) These positions may be used by the four-year institutions of  
28 higher education if the personal service needs of the universities during the  
29 2005 – 2007 biennium because of enrollment growth exceeds the number of  
30 positions allocated by the General Assembly.

31 (3) The four-year institutions of higher education shall provide  
32 justification to the Department of Higher Education for the need to allocate  
33 titles from this growth pool.

34 (4) No classifications will be assigned to the pool until such  
35 time as specific positions are requested by the four-year institutions of



1 higher education, approved by the institution's board, recommended by the  
2 Department of Higher Education, and reviewed by the Legislative Council.

3 (b)(1) The Office of Personnel Management of the Department of Finance  
4 and Administration shall establish and maintain for the 2005 – 2007 biennium  
5 a pool of one hundred fifty (150) classified positions at a maximum grade of  
6 twenty-six (26).

7 (2) These positions are to be used by the four-year institutions  
8 of higher education if the personal service needs of the universities during  
9 the 2005 – 2007 biennium because of enrollment growth exceeds the number of  
10 positions in a classification allocated to the four-year institutions of  
11 higher education allocated by the General Assembly.

12 (3) The four-year institutions of higher education shall provide  
13 justification to the Office of Personnel Management for the need to allocate  
14 titles from this growth pool.

15 (4) No classifications will be assigned to the pool until such  
16 time as specific positions are requested by the four-year institutions of  
17 higher education and by the institution's board, recommended by the Office of  
18 Personnel Management, and reviewed by the Legislative Council.

19  
20 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the  
21 General Assembly that universities are still growing at an unprecedented  
22 rate, that if the growth pool is not created the colleges will be unable to  
23 serve the students enrolled for the 2005-2006 academic year, that this act is  
24 immediately necessary to prevent unnecessary delay in the education of  
25 students. Therefore, an emergency is declared to exist and this act being  
26 immediately necessary for the preservation of the public peace, health, and  
27 safety shall become effective on July 1, 2005.
