19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 *SECTION 1. Arkansas Code § 6-14-102(c), concerning school elections,*
22 *is amended to read as follows:*

23 *(c)(1) In any election year, if no more than one (1) candidate for*
24 *school district director presents a petition or notice in writing to the*
25 *county board of election commissioners as required by § 6-14-111 and if there*
26 *are no other ballot issues to be submitted to district electors for*
27 *consideration, the board of directors of any school district, by resolution*
28 *duly adopted, may request the county board of election commissioners to*
29 *reduce the number of polling places or to open no polling places on election*
30 *day so that the election can be conducted by absentee ballot and early voting*
31 *only.*

32

33 *(2) The county board of election commissioners may provide that*
34 *no polling places be open on election day so that the election can be*
35 *conducted by absentee ballot and early voting only, if no more than one (1)*
candidate for school district director presents a petition or notice in



1 writing to the county board of election commissioners as required by § 6-14-
2 111, and if there are no other ballot issues to be submitted to district
3 electors for consideration, if requested by resolution adopted by the board
4 of directors of any school district.

5 (3) In a county that uses voting machines or electronic ~~voting~~
6 vote tabulating devices, the county board of election commissioners may
7 choose to use paper ballots ~~for the election~~ counted by hand in combination
8 with voting machines equipped for use by individuals with disabilities.

9
10 SECTION 2. Arkansas Code § 7-1-101 is amended to read as follows:

11 7-1-101. Definitions.

12 As used in this title, unless the context or chapter otherwise
13 requires:

14 (1) "Administrator" means the administrative head of a long-term
15 care or residential care facility licensed by the state who is authorized in
16 writing by a patient of the long-term care or residential care facility to
17 deliver the application for an absentee ballot and to obtain or deliver the
18 absentee ballot to the county clerk;

19 (2) "Audit log" means an electronically stored record of events
20 and ballot images from which election officials may produce a permanent paper
21 record with a manual audit capacity for a voting system using voting
22 machines;

23 ~~(2)(3)~~ "Authorized agent" means a person who is identified and
24 authorized by an applicant who is medically unable to cast a ballot at a
25 polling site due to unforeseen medical necessity as set forth in an affidavit
26 from the administrative head of a hospital or long-term or residential care
27 facility to deliver the application, obtain a ballot, and deliver the ballot
28 on the day of the election to the county clerk;

29 ~~(3) "Automatic tabulating equipment" means apparatus necessary~~
30 ~~to automatically examine and count votes as designated on vote cards and data~~
31 ~~processing machines which can be used for counting votes and tabulating~~
32 ~~results but shall not include those voting machines authorized under this~~
33 ~~title;~~

34 ~~(4) "Candidate and issue labels" means the cards, paper,~~
35 ~~booklet, pages, or other material containing the names of offices and~~
36 ~~candidates and statements of measures to be voted on;~~

1 ~~(5)~~(4) "Canvassing" means examining and counting the returns of
2 votes cast at a public election to determine authenticity;

3 ~~(6)~~(5) "Constitutional officers of this state" means the offices
4 of the Governor, Lieutenant Governor, Secretary of State, Attorney General,
5 Auditor of State, Treasurer of State, and Commissioner of State Lands;

6 ~~(7)~~(6) "Counting location" means a location selected by the
7 county board of election commissioners with respect to all elections for the
8 automatic processing or counting or both of votes;

9 ~~(8)~~(7) "Designated bearer" means any person who is identified
10 and authorized by the applicant to obtain from the county clerk or to deliver
11 to the county clerk the applicant's ballot;

12 ~~(9)~~(8) "Election official" or "election officer" means a person
13 who is a member of the county board of election commissioners or a person who
14 is a poll worker, having been designated by a county board of election
15 commissioners to be an election clerk, election judge, or election sheriff;

16 ~~(10)~~(9) "~~Electronic voting system~~ vote tabulating device" means
17 a ~~system of casting votes by use of marking devices and tabulating votes by~~
18 ~~use of automatic tabulating equipment or data processing equipment but shall~~
19 ~~not include those voting machines authorized under this title~~ device used to
20 electronically scan a marked paper ballot for the purposes of tabulation;

21 ~~(11)~~(10) "Fail-safe voting" means the mechanism established
22 under the National Voter Registration Act of 1993 that allows voters who have
23 moved within the same county to vote at their new precinct without having
24 updated their voter registration records;

25 ~~(12)~~(11) "First-time voter" means any registered voter who has
26 not previously voted in a federal election in the state;

27 ~~(13)~~(12) "General or special election" means the regular
28 biennial or annual elections for election of United States, state, district,
29 county, township, and municipal officials and the special elections to fill
30 vacancies therein and special elections to approve any measure. The term as
31 used in this act shall not apply to school elections for officials of school
32 districts;

33 ~~(14)~~(13) "Majority party" means that political party in the
34 State of Arkansas whose candidates were elected to a majority of the
35 constitutional offices of this state in the last-preceding general election;

36 ~~(15)~~(14) "Marking device" means ~~either an apparatus in which~~

1 ~~vote cards are inserted and used in connection with a punch apparatus for~~
2 ~~piercing of vote cards by the voter or any approved device for marking a~~
3 ~~paper vote sheet~~ ballot with ink or other substances which will enable the
4 votes to be tabulated by means of ~~automatic tabulating equipment~~ an
5 electronic vote tabulating device;

6 ~~(16)~~(15) "Minority party" means that political party whose
7 candidates were elected to less than a majority of the constitutional offices
8 of this state in the last-preceding general election or the political party
9 which polled the second-greatest number of votes for the office of Governor
10 in the last-preceding general election if all of the elected constitutional
11 officers of this state are from a single political party;

12 ~~(17)~~(16) "Party certificate" means a written statement or
13 receipt signed by the secretary or chair of the county committee or of the
14 state committee, as the case may be, of the political party evidencing the
15 name and title proposed to be used by the candidate on the ballot, the
16 position the candidate seeks, payment of the fees, and filing of the party
17 pledge, if any, required by the political party;

18 ~~(18)~~(17)(A) "Political party" means any group of voters which at
19 the last-preceding general election polled for its candidate for Governor in
20 the state or nominees for presidential electors at least three percent (3%)
21 of the entire vote cast for the office.

22 (B) No group of electors shall assume a name or
23 designation which is so similar in the opinion of the Secretary of State to
24 that of an existing political party as to confuse or mislead the voters at an
25 election.

26 (C) When any political party fails to obtain three percent
27 (3%) of the total votes cast at an election for the office of Governor or
28 nominees for presidential electors, it shall cease to be a political party;

29 ~~(19)~~(18) "Polling site" means a location selected by the county
30 board of election commissioners where votes are cast;

31 ~~(20)~~(19) "Precinct" means the geographical boundary lines
32 dividing a county, municipality, township, or school district for voting
33 purposes;

34 ~~(21)~~(20) "Primary election" means any election held by a
35 political party in the manner provided by law for the purpose of selecting
36 nominees of the political party for certification as candidates for election

1 at any general or special election in this state;

2 ~~(22)~~(21) "Qualified elector" means a person who holds the
3 qualifications of an elector and who is registered pursuant to Arkansas
4 Constitution, Amendment 51;

5 ~~(23)~~(22) "Vacancy in election" means the vacancy in an elective
6 office created by death, resignation, or other good and legal cause, arising
7 prior to election to the office at a general or special election but arising
8 subsequent to the certification of the ballot;

9 ~~(24)~~(23) "Vacancy in nomination" means the circumstances in
10 which the person who received the majority of votes at the preferential
11 primary election or general primary election cannot accept the nomination due
12 to death or notifies the party that he or she will not accept the nomination
13 due to serious illness, moving out of the area from which the person was
14 elected as the party's nominee, or filing for another office preceding the
15 final date for certification of nominations;

16 ~~(25)~~(24)(A) "Vacancy in office" means the vacancy in an elective
17 office created by death, resignation, or other good and legal cause arising
18 subsequent to election to the office at a general or special election or
19 arising subsequent to taking office and prior to the expiration of the term
20 of office in those circumstances wherein the vacancy must be filled by a
21 special election rather than by appointment.

22 (B) The phrase "vacancy in office" shall not apply to the
23 election of a person at a general election to fill an unexpired portion of a
24 term of office; ~~and~~

25 ~~(26) "Vote card" means a card upon which the voter casts his or~~
26 ~~her votes by the process of punching~~

27 (25) "Voting machine" means either:

28 (A) A direct recording electronic voting machine that:

29 (i) Records votes by means of a ballot display
30 provided with mechanical or electro-optical components that may be actuated by
31 the voter;

32 (ii) Processes the data by means of a computer
33 program;

34 (iii) Records voting data and ballot images in
35 internal and external memory components; and

36 (iv) Produces a tabulation of the voting data stored

1 in a removable memory component and in a printed copy; or

2 (B) An electronic device for marking a paper ballot to be
3 electronically scanned;

4 (26) "Voter-verified paper audit trail" means a contemporaneous
5 paper record of a ballot printed for the voter to confirm his or her votes
6 before the voter casts his or her ballot that:

7 (A) Allows the voter to verify the voter verified paper
8 audit trail before the casting of the voter's ballot;

9 (B) Is not retained by the voter;

10 (C) Does not contain individual voter information;

11 (D) Is produced on paper that is sturdy, clean, and
12 resistant to degradation; and

13 (E) Is readable in a manner that makes the voter's ballot
14 choices obvious to the voter without the use of computer or electronic code;
15 and

16 (27) "Voting system" means:

17 (A) The total combination of mechanical,
18 electromechanical, or electronic equipment, including the software, firmware,
19 and documentation required to program, control, and support the equipment
20 that is used:

21 (i) To define ballots;

22 (ii) To cast and count votes;

23 (iii) To report or display election results; and

24 (iv) To maintain and produce any audit trail

25 information; and

26 (B) The practices and documentation used to:

27 (i) Identify system components and versions of
28 components;

29 (ii) Test the system during its development and
30 maintenance;

31 (iii) Maintain records of system errors and defects;

32 (iv) Determine specific system changes to be made to
33 a system after the initial qualification of the system; and

34 (v) Make available any materials to the voter,
35 including, but not limited to, notices, instructions, forms, or paper
36 ballots.

SECTION 3. Arkansas Code § 7-5-208 is amended to read as follows:

7-5-208. Paper ballots - Form.

(a) All election ballots provided by the county board of election commissioners of any county in this state for any election shall be alike and shall be printed in plain type.

(b) Each ballot shall be printed on paper with a perforated portion capable of being detached for use as the ballot stub.

(c) As ballots are printed, the portion that shall be used as the ballot stub shall be numbered consecutively from one (1) to the number which is the total amount of ballots provided for the election.

(d) On the back or outside of the ballot shall be printed the words "OFFICIAL BALLOT for ", followed by the appropriate designation for the particular election and its date.

(e)(1) The heading on the front or inner side of each ballot shall be: "OFFICIAL BALLOT ELECTION , ~~19~~ 20

Vote by placing an appropriate mark opposite the person for whom you wish to vote."

(2) If the ballot contains an initiated or referred amendment, act, or measure, the heading shall also contain these words - "Vote on amendments, acts, and measures by placing an appropriate mark above the amendment (or act or measure) either FOR or AGAINST."

(f) Beneath the heading on each paper ballot that will be counted by hand or on an electronic vote tabulating device at the courthouse or other central location there shall be printed instructions that inform the voter:

- (1) Of the effect of casting multiple votes for an office; and
- (2) How to correct the ballot before it is cast and counted, including, but not limited to, instructions on how to correct an error through the issuance of a replacement ballot if the voter was otherwise unable to change the ballot or correct an error.

~~(f)~~(g)(1) Every ballot shall contain the name of each candidate who has been nominated or has qualified in accordance with law for each office. The names of the candidates shall be listed in a perpendicular column under the name of each office to be filled.

1 (2)(A) However, the names of all unopposed candidates for
2 offices for which no notice has been filed within the time prescribed in § 7-
3 5-205, except the names of all unopposed candidates for the office of mayor
4 or circuit clerk, shall be grouped together on the ballot indicating the
5 office and the name of the unopposed candidate for each office in a single
6 column. At the top of the list of the names of all unopposed candidates there
7 shall appear on the ballot the words "Unopposed Candidates", and to the right
8 thereof there shall be a square in which the voter may cast a vote for all
9 the candidates by placing an appropriate mark, so that the votes may be
10 separately counted and tabulated as required in § 7-5-205.

11 (B) The names of unopposed candidates for the office of
12 mayor or circuit clerk shall be separately printed from any grouping of
13 unopposed candidates, with a place in which the voter may cast a vote for
14 each unopposed candidate for the office of mayor or circuit clerk by placing
15 an appropriate mark, so that the votes may be separately counted and
16 tabulated as required in § 7-5-315.

17 (3) In all elections except primary elections and municipal
18 elections, at the bottom of each list of names for each position or office
19 appearing on the ballot, there shall be a blank line or lines for possible
20 write-in votes for that position or office. However, the blank line shall not
21 appear on the ballot with respect to those offices and candidates for
22 positions in which no person has qualified as a write-in candidate by filing
23 his intentions to be a write-in candidate within the time prescribed in § 7-
24 5-205.

25 (4) The order in which the names of the respective candidates
26 shall appear on the ballots shall be determined by lot at a public meeting of
27 the county board not less than thirty-five (35) days prior to the general
28 elections. It is expressly understood and provided that the selection on the
29 order of the ballot in all other elections shall be and remain as provided by
30 law. For runoff elections, the ballot order for eligible candidates shall
31 stay the same as for the previous election.

32 (5) Beside or adjacent to the name of each candidate in the
33 general election shall be his or her party designation or the name
34 "INDEPENDENT" if he or she represents no officially recognized party.

35 ~~(g)(h) At the right~~ Adjacent to the name of each candidate and on the
36 same line there shall be a square, a circle, or other method of marking a

1 vote for the candidate. Above each act, amendment, or measure to be voted on
 2 there shall be the words "FOR" and "AGAINST" – one (1) above the other with a
 3 square ~~to the right of~~, a circle, or other method of marking a vote for the
 4 act, amendment, or measure adjacent to each word and on the same line. With
 5 respect to all offices and the candidates for those offices who are unopposed
 6 and have been grouped together in the manner provided in subsection ~~(f)~~(g) of
 7 this section, the names of all those candidates and their respective offices
 8 shall appear under the heading of "Unopposed Candidates". The elector shall
 9 vote on each and all such candidates by casting a single vote in a square
 10 ~~placed to the right of~~, a circle, or other method of marking a vote for the
 11 act, amendment, or measure adjacent to the heading "Unopposed Candidates" as
 12 provided in subdivision.

13 ~~(f)~~(g)(2) of this section.

14 ~~(h)~~(i) Opposite the designation of each office there shall appear
 15 these words: "VOTE FOR". The number of persons required to
 16 fill the vacancy in office shall be placed in the blank space as:

20 SECTION 4. Arkansas Code § 7-5-301 is amended to read as follows:

21 7-5-301. ~~Inspection of election supplies~~ Acquisition, use, and cost of
 22 voting systems.

23 ~~The election officials shall inspect the election supplies prior to the~~
 24 ~~opening of the polls.~~

25 (a) The casting and counting of votes in all elections shall be by:

26 (1) Voting machines selected by the Secretary of State;

27 (2) Electronic vote tabulating devices in combination with
 28 voting machines accessible to voters with disabilities to be selected by the
 29 Secretary of State; or

30 (3) Paper ballots counted by hand in combination with voting
 31 machines accessible to voters with disabilities selected by the Secretary of
 32 State.

33 (b)(1) All direct recording electronic voting machines in use on or
 34 after January 1, 2006, shall include a voter-verified paper audit trail,
 35 except for those direct recording electronic voting machines in use during
 36 the 2004 general election that may include a voter-verified paper audit trail

1 at the discretion of the county election commission.

2 (2) All direct recording electronic voting machines purchased on
3 or after the effective date of subsection shall include a voter verified
4 paper audit trail.

5 (c)(1) The quorum court of each county shall by resolution choose a
6 voting system containing voting machines or electronic vote tabulating
7 devices, or both, or voting machines in combination with paper ballots
8 counted by hand for use in all elections in the county.

9 (2) Any voting machine or electronic vote tabulating devices
10 chosen by the quorum court shall be those selected by the Secretary of State.

11 (3) Any voting system used in elections for federal office shall
12 comply with the requirements of the federal Help America Vote Act of 2002.

13 (d)(1) Voting machines and electronic vote tabulating devices shall be
14 purchased pursuant to a competitive bidding process with consideration given
15 to:

16 (A) Price;

17 (B) Quality; and

18 (C) Adaptability to Arkansas ballot requirements.

19 (2) The Secretary of State shall use a portion of the funds
20 provided by the federal government and the state for the purpose of complying
21 with the requirements of the federal Help America Vote Act of 2002 to
22 purchase and distribute voting machines and electronic vote tabulating
23 devices and other equipment necessary to the administration of elections.

24 (3) Each county shall bear the cost of acquiring any additional
25 voting machines or electronic vote tabulating devices or other equipment
26 necessary to the administration of elections.

27 (e) The Secretary of State or the county board of election
28 commissioners shall not purchase or procure any voting machine or electronic
29 vote tabulating device unless the party selling the machine or device shall:

30 (1) Guarantee in writing the machines for a period of one (1)
31 year; and

32 (2) Provide, if deemed necessary by the county, personnel for
33 supervision and training of county personnel for at least two (2) elections,
34 one (1) primary and one (1) general.

35 (f) Each county shall provide polling places that are adequate for the
36 operation of the voting system, including, but not limited to, access, if

1 necessary, to a sufficient number of electrical outlets and telephone lines.

2 (g) Each county shall provide or contract for adequate technical
3 support for the installation, set up, and operation of the voting system for
4 each election.

5 (h)(1) The Secretary of State shall be responsible for the
6 development, implementation, and provision of a continuing program to educate
7 voters and election officials in the proper use of the voting system.

8 (2) Each county shall bear the cost, including transportation,
9 subsistence, and lodging, incurred by its election and registration officials
10 in attending courses taught by or arranged by the Secretary of State for
11 instruction in the use of the voting system.

12 (i) Electronic vote tabulating devices and voting machines, authorized
13 as provided under this subchapter, may be acquired and used in any election
14 upon the adoption of an ordinance by the quorum court of the county.

15 (j) The costs of using electronic vote tabulating devices and voting
16 machines at all general and special elections, including, but not limited to,
17 costs of supplies, technical assistance, and transportation of the systems to
18 and from the polling places, shall be paid in accordance with § 7-5-104.

19 (k) The county board of election commissioners shall have complete
20 control and supervision of voting machines and electronic vote tabulating
21 devices at all elections.

22 (l) The county clerk shall have supervision of voting machines and
23 electronic vote tabulating devices used for early voting in the clerk's
24 designated early voting location.

25 (m)(1) The county board of election commissioners shall have the care
26 and custody of all voting machines and all electronic vote tabulating devices
27 while not in use.

28 (2) The county board of election commissioners shall be
29 responsible for the proper preparation, use, maintenance, and care of the
30 voting machines and the electronic vote tabulating devices during the period
31 of time required for that election.

32
33 SECTION 5. Arkansas Code § 7-5-302 is amended to read as follows:

34 7-5-302. Documents to be posted in polling area Inspection of supplies
35 and posting of documents.

36 (a) The election officials shall inspect the election supplies before

1 the opening of the polls.

2 ~~(a)~~(b) Before the polls open, the election officials shall post the
3 following in a conspicuous place in the polling area:

4 (1) At least two (2) copies of instructions to voters, including
5 instructions for fail-safe voting procedures; ~~and~~

6 (2) In general elections, at least two (2) copies of all
7 constitutional amendments and acts to be voted upon; and

8 (3) Clear, written instructions suitable for the instruction of
9 voters illustrating the manner of voting on the voting machine.

10
11 SECTION 6. Arkansas Code § 7-5-310 is amended to read as follows:

12 7-5-310. Privacy - Assistance to ~~disabled~~ voters with disabilities.

13 (a) Each voter shall be provided the privacy to mark his or her
14 ballot. Privacy shall be provided by each county board of election
15 commissioners to ensure that voters desiring privacy are not singled out.

16 (b)(1) A voter shall inform the election officials at the time that
17 the voter presents himself or herself to vote that he or she is unable to
18 mark the ballot because he or she cannot read or write or because of
19 physical, sensory, or other disability or other legal cause, ~~or that he or~~
20 ~~she is unable to complete the ballot without help.~~

21 (2) The ~~person~~ voter shall be directed to a voting machine
22 equipped for use by persons with disabilities where he or she may elect to
23 cast his or her ballot without assistance or may ~~be assisted~~ request
24 assistance with either the paper ballot or the voting machine by:

25 (A) Two (2) election officials; or

26 (B) A person named by the voter.

27 ~~(2)~~(3) If the voter is assisted by two (2) election officials,
28 one (1) of the election officials shall observe the voting process and one
29 (1) may assist the voter in marking the ballot according to the wishes of the
30 voter without comment or interpretation.

31 ~~(3)~~(4) If the voter is assisted by one (1) person named by the
32 voter, he or she may assist the voter in marking the ballot according to the
33 wishes of the voter without any comment or interpretation.

34 ~~(4)~~(5) It shall be the duty of the election officials at the
35 polling site to make and maintain a list of the names of all persons
36 assisting voters.

1 (c) Any voter because of physical, sensory, or other disability who
2 presents himself or herself for voting and who then informs an election
3 official at the polling site that he or she is unable to stand in line for
4 extended periods of time shall be entitled to and assisted by an election
5 official to advance to the head of any line of voters then waiting in line to
6 vote at the polling site.

7
8 SECTION 7. Arkansas Code § 7-5-319 is amended to read as follows:
9 7-5-319. Recount.

10 (a)(1) Any candidate voted for who may be dissatisfied with the
11 returns from any precinct shall have a recount of the votes cast therein upon
12 the candidate's presenting the county board of election commissioners with a
13 petition requesting the recount.

14 (2) When the number of outstanding absentee ballots of overseas
15 voters is not sufficient to change the results of the election, the candidate
16 must present the petition no later than two (2) days after the county board
17 declares preliminary and unofficial results of the election, including a
18 statement of the number of outstanding absentee ballots of overseas voters.

19 (3) When the number of outstanding absentee ballots of overseas
20 voters is sufficient to potentially change the results of the election, the
21 candidate must present the petition at any time before the county board
22 finally completes the canvass of the returns of the election and certifies
23 the result.

24 (b) At the time that the petition requesting the recount is presented,
25 the county board shall provide to the candidate requesting the recount a copy
26 of the test results on the voting machines and the electronic vote tabulating
27 devices performed pursuant to §§ 7-5-504(20) and 7-5-611(e) and (d) to the
28 candidate requesting the recount. Only one (1) recount per candidate per
29 election shall be permitted. The county board shall certify the results of
30 the last recount. The county board may upon its own motion conduct a recount
31 of the returns from any or all precincts.

32 (c) For any recount of an election in which ballots are cast using a
33 direct recording electronic voting machine with a voter-verified paper audit
34 trail, the voter-verified paper audit trail shall serve as the official
35 ballot to be recounted.

36 ~~(e)(d)~~ The For the recount of an election in which paper ballot are

1 used, the county board shall open the package containing the ballots and
2 recount the ballots in the manner prescribed by law for the count to be made
3 by the election officials in the first instance or, if there is a
4 determination by the county board that the voting machine or ~~automated~~
5 ~~tabulating equipment~~ electronic vote tabulating device may be malfunctioning,
6 it may recount the ballots by any manner prescribed by law.

7 ~~(d)~~(e) The result as found upon the recount, if it differs from that
8 certified by the election officials, shall be included in the canvass as the
