17 AN ACT CONCERNING THE TERMINATION,

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:


26 *SECTION 1. Intent.*

27 *(a) The General Assembly finds that:*

28 *(1) The actions of state government have produced a substantial*  
29 *increase in the number of agencies, departments, boards, commissions,*  
30 *institutions, and programs of this state, growth of pre-existing programs,*  
31 *and the proliferation of rules;*

32 *(2) The growth of state government has developed without*  
33 *sufficient legislative oversight, regulatory accountability, or a system of*  
34 *checks and balances; and*

35 *(3) By establishing a system for the termination, study, review,*



1 continuation, or re-establishment of such agencies, it will be in a better  
2 position to evaluate the need for the continued existence of existing and  
3 future agencies, departments, boards, commissions, institutions, and programs  
4 of the state government.

5 (b) The intent of this act is to establish an orderly schedule for the  
6 abolishment of all existing state agencies during a twelve-year period, but  
7 to make provision for review by the Government Efficiency and Accountability  
8 Review Subcommittee of the House and Senate Interim Committees on State  
9 Agencies and Governmental Affairs to enable the General Assembly to have the  
10 benefit of recommendations for the continuation of those state agencies which  
11 are deemed to be essential for the necessary and efficient operation of  
12 government prior to the abolishment.

13  
14 SECTION 2. (a) The following state agencies, and all departments,  
15 boards, commissions, institutions, divisions, programs, services, advisory  
16 committees, and councils of the state agencies, shall be abolished on June  
17 30, 2007, unless continued by action of the General Assembly or transferred

34 SECTION 4. This act shall become effective only if House Bill 2623 of  
35 the Regular Session of the Eighty-fifth General Assembly, dealing with the  
36 creation of the Government Efficiency and Accountability Review Subcommittee

1 of the House and Senate Interim Committees on State Agencies and Governmental  
2 Affairs, is approved by the Governor, becomes law upon the expiration of the  
3 period of time during which the Governor may veto the bill, or becomes law by  
4 an override of a veto by the General Assembly.
