19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 27-24-206(c), regarding fees and
22 limitations for special license plates issued for military service and
23 veterans, is amended to read as follows:

24 (c)(1) An eligible applicant, including a surviving spouse under § 27-
25 24-208, for the issuance or renewal of any one (1) of the following special
26 license plates that existed before April 13, 2005, may obtain one (1)
27 additional special license plate under this subchapter upon payment of the
28 fee for licensing a motor vehicle as provided under § 27-14-601:

29 ~~(A) Disabled Veteran;~~

30 ~~(B) Disabled Veteran—World War I;~~

31 (A) Purple Heart Recipient;

32 (B) Ex-Prisoner of War; and

33 (C) Pearl Harbor Survivor.

34 (2) The Adjutant General of the State of Arkansas or the
35 Director of the Department of Veterans' Affairs may submit a written request



1 to the Director of the Department of Finance and Administration to allow a
2 qualified applicant for a special license plate not stated in subdivision
3 (c)(1) of this section to obtain one (1) additional special license plate
4 upon payment of the fee for licensing a motor vehicle as provided under § 27-
5 14-601.

6 (3) An eligible applicant for the issuance or renewal of any of
7 the following special license plates may obtain (1) additional special
8 license plate under this subchapter upon payment of fee not to exceed one
9 dollar (\$1.00):

10 (A) Disabled Veteran; or

11 (B) Disabled Veteran – World War I.
