It is the intent of the General Assembly 26 that any funds disbursed under the authority of the appropriations contained 27 in this act shall be in compliance with the stated reasons for which this act 28 was adopted, as evidenced by the Agency Requests, Executive Recommendations 29 and Legislative Recommendations contained in the budget manuals prepared by 30 the Department of Finance and Administration, letters, or summarized oral 31 testimony in the official minutes of the Arkansas Legislative Council or 32 Joint Budget Committee which relate to its passage and adoption. 33 34 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General 35 Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the 36
