9 AN ACT TO TRANSFER THE STREET ROD SPECIAL LICENSE
10 PLATE LAW TO THE SPECIAL LICENSE PLATE ACT OF
11 2005; TO MODIFY THE LAW AS NECESSARY BECAUSE OF
12 INDUSTRY ADVANCEMENTS AND THE GROWING POPULARITY
13 OF STREET RODS AND CUSTOM VEHICLES; TO REPEAL THE
14 LAW REGARDING STREET RODS UNDER ARKANSAS CODE §
15 27-15-4003; AND FOR OTHER PURPOSES.

18 TO TRANSFER THE STREET ROD SPECIAL
19 LICENSE PLATE LAW TO THE SPECIAL LICENSE
20 PLATE ACT OF 2005 AND MODIFY THE LAW
21 BECAUSE OF INDUSTRY ADVANCEMENT AND
22 RISING POPULARITY OF STREET RODS AND
23 CUSTOM VEHICLES.

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27

28 SECTION 1. Arkansas Code Title 27, Chapter 24, is amended to add an
29 additional subchapter to read as follows:

30 27-24-1501. Purpose.

31 The purpose of this subchapter is to:

32 (1) Continue the street rod special license plates that existed
33 before the effective date of this act; and

34 (2) Make modifications that are necessary to the law because of
35 industry advancements and the growing popularity of street rods.

2 27-24-1502. Definitions.

3 As used in this subchapter:

4 (1) "Blue dot tail light" means a red lamp installed in the rear
5 of a motor vehicle containing a blue or purple insert that is not more
6 than one inch (1") in diameter.

7 (2) "Custom vehicle" means a motor vehicle that:

8 (A)(i) Is at least 25 years old and of a model year after
9 1948; or

10 (ii) Was manufactured to resemble a vehicle 25 or
11 more years old and of a model year after 1948; and

12 (B)(i) Has been altered from the manufacturers original
13 design; or

14 (ii) Has a body constructed from non-original
15 materials.

16 (3) "Street rod" means a motor vehicle that:

17 (A) Is a 1948 or older vehicle or the vehicle was
18 manufactured after 1948 to resemble a vehicle manufactured before 1949; and

19 (B) Has been altered from the manufacturer's original
20 design or has a body constructed from nonoriginal materials; and

22 27-24-1503. Application — Issuance — Renewal — Replacement.

23 (a)(1) The owner of a street rod or a custom vehicle who is a resident
24 of the State of Arkansas may apply for and annually renew a special license
25 plate or a special license plate that bears a decal that is issued under this
26 subchapter.

27 (2) The application for registration of a street rod or a custom
28 vehicle under this subchapter shall include an affidavit to be completed by
29 the owner of the vehicle which states that the vehicle:

30 (A) Will be maintained for occasional transportation,
31 exhibitions, club activities, parades, tours, or similar uses; and

32 (B) Will not be used for general daily transportation.

33 (b)(1) An applicant for a special license plate or for a special
34 license plate that bears a decal under this subchapter shall remit to the
35 office payment of a one-time initial fee of fifty dollars (\$50.00) for each
36 vehicle.

1 (2) An applicant for renewal of a special license plate issued
2 under § 27-15-4003 shall not be required to resubmit this initial fee.

3 (c) The Office of Motor Vehicle shall furnish to the owner of a street
4 rod or custom vehicle who complies with the requirements of subsections (a)
5 and (b) of this section a special license plate or special license plate that
6 bears a decal to be displayed on the street rod or custom vehicle in lieu of
7 the usual license plate.

8 (d) To renew a special license plate or a special license plate that
9 bears a decal issued under this subchapter or under prior law, the owner of
10 the motor vehicle shall remit an annual fee of twenty-five dollars (\$25.00).

11 (e) To replace a special license plate or a special license plate that
12 bears a decal issued under this subchapter, the owner of the street rod or
13 custom vehicle shall remit to the office a fee of ten dollars (\$10.00) if the
14 registration has not expired; or

15 (2) The owner of the street rod or custom vehicle shall remit to
16 the office the fees stated in subsection (d) of this section if the
17 registration has expired.

18 (f)(1) The fee remitted to the office under subdivision (e) of this
19 section shall be deposited into the State Central Services Fund for the
20 benefit of the Revenue Division of the Department of Finance and
21 Administration.

22 (2) The fee shall be credited as supplemental and in addition to
23 all other funds deposited for the benefit of the division.

24 (3) The fee shall not be considered or credited to the division
25 as direct revenue.

26 (g) The registration of a special license plate or a special license
27 plate that bears a decal issued under this subchapter may:

28 (1) Continue from year to year as long as it is renewed each
29 year within the time and manner required by law; and

30 (2) Be renewed as provided under §§ 27-14-1012 and 27-14-1013.

31 (h) A street rod or custom vehicle shall not be eligible for any other
32 licensing of a motor vehicle except as provided in this subchapter.

33 (i) The Office of Motor Vehicle shall consult with the street rod
34 community and custom vehicle community in the state before changing the
35 design of the special license plate or special license plate decal issued
36 under this subchapter.

1
2 27-24-1504. Titling.

3 (a) The model year and the year of manufacture that are listed on the
4 certificate of title of a street rod or custom vehicle shall be the model
5 year and year of manufacture that the body of the street rod or custom
6 vehicle resembles.

7 (b) If a street rod or custom vehicle is a replica or reproduction of
8 an original production vehicle, the certificate of title shall include the
9 term "Replica" in the remarks section.

10
11 27-24-1505. Equipment.

12 (a)(1) Unless the presence of the equipment was specifically required
13 by the law of this state as a condition of sale in the year listed as the
14 year of manufacture on the certificate of title, the presence of any specific
15 equipment, including without limitation emission controls, is not required
16 for the operation of a vehicle registered under this subchapter.

17 (b) A street rod or custom vehicle may use blue dot tail lights for
18 stop lamps, rear turning indicator lamps, rear hazard lamps, and rear
19 reflectors.

21 SECTION 2. Arkansas Code § 27-15-4003 is repealed.

22 ~~27-15-4003. Street rods.~~

23 ~~(a) Definitions. As used in this section, unless the context otherwise~~
24 ~~requires:~~

25 ~~(1) "Office" means the Office of Motor Vehicle; and~~

26 ~~(2) "Street rod" means any modified antique automobile or truck~~
27 ~~produced by an American manufacturer in 1948 or earlier which has undergone~~
28 ~~some type of modification, including the modernization of the engine,~~
29 ~~transmission, drivetrain, interior refinements, and other modifications the~~
30 ~~builder may desire, which vehicle is to be driven under its own power and is~~
31 ~~to be used as a safe, nonracing vehicle for family enjoyment.~~

32 ~~(b) Registration Fee.~~

33 ~~(1)(A) Any person who is the owner of a motor vehicle qualified~~
34 ~~as a street rod may, upon application, register it as a street rod upon the~~
35 ~~payment of a one-time initial fee of fifty dollars (\$50.00) for each vehicle,~~
36 ~~and thereafter the payment of an annual renewal fee of twenty-five dollars~~

1 ~~(\$25.00), and be furnished a license plate of distinctive design to be~~
2 ~~displayed on each vehicle in lieu of the usual license plates.~~

3 ~~(B) These plates shall have the same legal significance as~~
4 ~~ordinary license plates.~~

5 ~~(C) The special license plate shall bear the inscription~~
6 ~~"Street Rod—Arkansas" and shall have displayed on it the number assigned to~~
7 ~~the vehicle by the office.~~

8 ~~(D) The registration shall be valid while the vehicle is~~
9 ~~owned by the applicant upon the payment of the annual renewal fee.~~

10 ~~(2) Application for these plates shall be made to the office on~~
11 ~~special application forms prescribed by the Director of the Department of~~
12 ~~Finance and Administration.~~

13 ~~(3) Each person applying for a plate under this section must own~~
14 ~~and have registered one (1) or more vehicles with regular plates which he or~~
15 ~~she uses for regular transportation.~~

16 ~~(c) Affidavit—Vehicle safety equipment required.~~

17 ~~(1) Any person making application for a street rod motor vehicle~~
18 ~~license plate under subsection (b) of this section shall transmit to the~~
19 ~~office an affidavit signed by the applicant stating that the motor vehicle~~
20 ~~described in the application is modified in a manner as prescribed in the~~
21 ~~definition of street rod, is capable of operating under its own power, is~~
22 ~~equipped as is otherwise required by law for operation on the public streets~~
23 ~~and highways of Arkansas, and is to be used as a safe, nonracing vehicle for~~
24 ~~family enjoyment.~~

25 ~~(2) Modifications of the vehicle in accordance with the~~
26 ~~definition of a street rod under this section shall not preclude the vehicle~~
27 ~~from meeting the vehicle equipment standards for brakes, lights, turn~~
28 ~~signals, if any, horns and sound devices, glass, mirrors, exhaust systems,~~
29 ~~windshield wipers, tires, and other items of equipment as required under~~
30 ~~Arkansas law to make a vehicle roadworthy.~~

31 ~~(d) Regulations. The director may adopt reasonable regulations~~
32 ~~necessary to carry out the purposes of this section.~~
