9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
10 SERVICES AND OPERATING EXPENSES FOR THE ARKANSAS  
11 COMMISSION ON LAW ENFORCEMENT STANDARDS AND  
12 TRAINING FOR THE BIENNIAL PERIOD ENDING JUNE 30,  
13 2009; AND FOR OTHER PURPOSES.

16 AN ACT FOR THE ARKANSAS COMMISSION ON  
17 LAW ENFORCEMENT STANDARDS AND TRAINING  
18 APPROPRIATION FOR THE 2007-2009

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. REGULAR SALARIES. There is hereby established for the Arkansas  
26 Commission on Law Enforcement Standards and Training for the 2007-2009  
27 biennium, the following maximum number of regular employees whose salaries  
28 shall be governed by the provisions of the Uniform Classification and  
29 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and  
30 all laws amendatory thereto. Provided, however, that any position to which a  
31 specific maximum annual salary is set out herein in dollars, shall be exempt  
32 from the provisions of said Uniform Classification and Compensation Act. All  
33 persons occupying positions authorized herein are hereby governed by the  
34 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas  
35 Code §21-5-101), or its successor.

34 SECTION 4. APPROPRIATION - DRUG DETECTION TRAINING - FEDERAL. There is  
 35 hereby appropriated, to the Arkansas Commission on Law Enforcement Standards  
 36 and Training, to be payable from the federal funds as designated by the Chief

1 Fiscal Officer of the State, for operating expenses of the Arkansas  
 2 Commission on Law Enforcement Standards and Training - Drug Detection for the  
 3 biennial period ending June 30, 2009, the following:

15 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY  
 17 FORWARD. Any unexpended balances of appropriation and funds authorized for  
 18 Capital Outlay in Section 2 of this Act on June 30, ~~2006~~ 2008, shall be  
 19 carried forward and made available for the same purpose during the fiscal  
 20 year ending June 30, ~~2007~~ 2009.

21 Any carry forward of unexpended balance of appropriation and/or funding as  
 22 authorized herein, may be carried forward under the following conditions:

23 (1) Prior to June 30, 2008 the Agency shall by written statement set forth  
 24 its reason(s) for the need to carry forward said appropriation and/or funding  
 25 to the Department of Finance and Administration Office of Budget;

26 (2) The Department of Finance and Administration Office of Budget shall  
 27 report to the Arkansas Legislative Council all amounts carried forward from  
 28 the first fiscal year of the biennium to the second fiscal year of the  
 29 biennium by the September Arkansas Legislative Council or Joint Budget  
 30 Committee meeting in the second fiscal year of the biennial period which  
 31 report shall include the name of the Agency, Board, Commission or Institution  
 32 and the amount of the appropriation and/or funding carried forward from the  
 33 first fiscal year to the second fiscal year, the program name or line item,  
 34 the funding source of that appropriation and a copy of the written request  
 35 set forth in (1) above;

36 (3) Each Agency, Board, Commission or Institution shall provide a written

1 report to the Arkansas Legislative Council or Joint Budget Committee  
2 containing all information set forth in item (2) above, along with a written  
3 statement as to the current status of the project, contract, purpose etc. for  
4 which the carry forward was originally requested no later than thirty (30)  
5 days prior to the time the Agency, Board, Commission or Institution presents  
6 its budget request to the Arkansas Legislative Council/Joint Budget  
7 Committee; and

8 (4) Thereupon, the Department of Finance and Administration shall include  
9 all information obtained in item (3) above in the biennial budget manuals  
10 and/or a statement of non-compliance by the Agency, Board, Commission or  
11 Institution.

12 The provisions of this section shall be in effect only from July 1, 2005  
13 2007 through June 30, ~~2007~~ 2009.

14  
15 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
16 by this act shall be limited to the appropriation for such agency and funds  
17 made available by law for the support of such appropriations; and the  
18 restrictions of the State Procurement Law, the General Accounting and  
19 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
20 Procedures and Restrictions Act, or their successors, and other fiscal  
21 control laws of this State, where applicable, and regulations promulgated by  
22 the Department of Finance and Administration, as authorized by law, shall be  
23 strictly complied with in disbursement of said funds.

24  
25 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly  
26 that any funds disbursed under the authority of the appropriations contained  
27 in this act shall be in compliance with the stated reasons for which this act  
28 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
29 and Legislative Recommendations contained in the budget manuals prepared by  
30 the Department of Finance and Administration, letters, or summarized oral  
31 testimony in the official minutes of the Arkansas Legislative Council or  
32 Joint Budget Committee which relate to its passage and adoption.

33  
34 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General  
35 Assembly, that the Constitution of the State of Arkansas prohibits the  
36 appropriation of funds for more than a two (2) year period; that the

1 effectiveness of this Act on July 1, 2007 is essential to the operation of  
2 the agency for which the appropriations in this Act are provided, and that in  
3 the event of an extension of the Regular Session, the delay in the effective  
4 date of this Act beyond July 1, 2007 could work irreparable harm upon the  
5 proper administration and provision of essential governmental programs.  
6 Therefore, an emergency is hereby declared to exist and this Act being  
7 necessary for the immediate preservation of the public peace, health and  
8 safety shall be in full force and effect from and after July 1, 2007.
