14 AN ACT TO REPEAL SECTION 4 OF ACT 2315

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Section 4 of Act 2315 of 2005 is hereby repealed.
21

22 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
23 by this act shall be limited to the appropriation for such agency and funds
24 made available by law for the support of such appropriations; and the
25 restrictions of the State Procurement Law, the General Accounting and
26 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
27 Procedures and Restrictions Act, or their successors, and other fiscal
28 control laws of this State, where applicable, and regulations promulgated by
29 the Department of Finance and Administration, as authorized by law, shall be
30 strictly complied with in disbursement of said funds.

32 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
33 that any funds disbursed under the authority of the appropriations contained
34 in this act shall be in compliance with the stated reasons for which this act
35 was adopted, as evidenced by the Agency Requests, Executive Recommendations



1 and Legislative Recommendations contained in the budget manuals prepared by
2 the Department of Finance and Administration, letters, or summarized oral
3 testimony in the official minutes of the Arkansas Legislative Council or
4 Joint Budget Committee which relate to its passage and adoption.

6 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
7 Assembly, that the Constitution of the State of Arkansas prohibits the
8 appropriation of funds for more than a two (2) year period; that the
9 effectiveness of this Act on the date of its passage and approval is
10 essential to the operation of the agency for which the appropriations in this
11 Act are provided, and that in the event of an extension of the Regular
12 Session, the delay in the effective date of this Act beyond the date of its
13 passage and approval could work irreparable harm upon the proper
14 administration and provision of essential governmental programs. Therefore,
15 an emergency is hereby declared to exist and this Act being necessary for the
16 immediate preservation of the public peace, health and safety shall be in
17 full force and effect from and after the date of its passage and approval.
18 If the bill is neither approved nor vetoed by the Governor, it shall become
19 effective on the expiration of the period of time during which the Governor
20 may veto the bill. If the bill is vetoed by the Governor and the veto is
21 overridden, it shall become effective on the date the last house overrides
22 the veto.
