19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 14-14-1204 is amended to read as follows:
22 14-14-1204. Compensation of elected county officers.

23 (a) The quorum court of each county shall fix by ordinance the annual
24 salaries of the following county officers within the minimums and maximums
25 provided in this section:

- 26 (1) The county judge;
- 27 (2) The sheriff and ex officio collector of taxes;
- 28 (3) The collector of taxes, where established by law;
- 29 (4) The circuit clerk;
- 30 (5) The county clerk, where established by law;
- 31 (6) The assessor;
- 32 (7) The treasurer;
- 33 (8) The coroner; and
- 34 (9) The surveyor.

35 (b) For purposes of determining the salaries of the elected county



1 officers, unless otherwise specifically provided in this section, the
 2 counties shall be classified on the basis of population, as determined by the
 3 preceding federal decennial census, according to the following
 4 classifications:

 19 services performed as provided by the Arkansas Constitution, by law, or by
 20 county ordinance.

 8 delinquent tax collector in those counties where that office is combined with
 9 the office of sheriff, and for all other services performed as provided by
 10 the Arkansas Constitution, by law, or by county ordinance.

11 (B) In any county in which the offices of sheriff and
 12 collector are combined into a single office, the maximum and minimum salaries
 13 of the county shall be one thousand three hundred ninety-two dollars (\$1,392)
 14 greater than those prescribed for the appropriate class of county in
 15 subdivision (d)(2) of this section, with the additional sum of one thousand
 16 three hundred ninety-two dollars (\$1,392) being paid to all combined sheriffs
 17 and collectors.

 34 class of county in subdivision (g)(2) of this section, with the additional
 35 sum of one thousand three hundred ninety-two dollars (\$1,392) being paid to
 36 all combined circuit clerks and ex officio recorders and county and probate

 26 all combined treasurers and collectors.

36 SECTION 2. Arkansas Code § 14-14-1205 is amended to read as follows:

1 14-14-1205. Compensation of township officers.

2 (a)(1)(A) The per diem compensation for justices of the peace
3 attending any official, regular, special, or committee meeting of a quorum
4 court shall be fixed by ordinance in each county.

5 (B) The per diem compensation of justices shall be not less than
6 ~~one hundred twenty dollars (\$120)~~ one hundred twenty-five dollars (\$125) per
7 diem for each regular meeting nor exceed:

8 (i) ~~Seven thousand dollars (\$7,000)~~ Seven thousand
9 five hundred thirty-four dollars (\$7,534) per calendar year in counties
10 having a population of less than seventy thousand (70,000);

11 (ii) ~~Eight thousand five hundred ninety-five dollars~~
12 ~~(\$8,595)~~ Nine thousand one hundred seventy-six dollars (\$9,176) per calendar
13 year in counties having a population of at least seventy thousand (70,000)
14 and less than two hundred thousand (200,000); and

15 (iii) ~~Eleven thousand four hundred dollars (\$11,400)~~
16 Twelve thousand one hundred nineteen dollars (\$12,119) per calendar year in
17 counties having a population of two hundred thousand (200,000) or more.

18 (2) Per Diem Compensation Defined. (A) Per diem compensation is
19 defined as a per calendar day allowance, exclusive of allowable expenses,
20 which shall be paid a justice for attending meetings of the county quorum
21 court. This compensation shall be based on attending meetings of a quorum
22 court during any single calendar day without regard to the duration of the
23 meetings.

24 (B) However, a member of the quorum court may receive per
25 diem compensation for one (1) meeting per year for which the member is absent
26 due to an emergency or for personal reasons.

27 (3) In addition to any other compensation expense reimbursement
28 or expense allowances provided members of the quorum court, counties may
29 provide medical insurance coverage for members of the quorum court.

30 (b) Justices of the Peace Serving in Judicial Capacity. The
31 compensation of all justices of the peace serving in a judicial capacity
32 shall be fixed by ordinance of the quorum court in each county. This basis of
33 compensation shall not be computed on a percentage of the dollar amount of
34 fines levied by a justice of the peace.

35 (c) Justice of the Peace as County Employee or Deputy. No justice of
36 the peace shall receive compensation as a county employee or deputy, nor

1 shall any justice receive compensation or expenses from funds appropriated by
2 the quorum court for any services performed within the county, other than as
3 provided by this subchapter.

4 (d) Constables. The compensation of all constables serving in any
5 official capacity established by law shall be fixed by ordinance of the
6 quorum court in each county.
