23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. REGULAR SALARIES. There is hereby established for the
26 Department of Education - Educational Television Division for the 2007-2009
27 biennium, the following maximum number of regular employees whose salaries
28 shall be governed by the provisions of the Uniform Classification and
29 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
30 all laws amendatory thereto. Provided, however, that any position to which a
31 specific maximum annual salary is set out herein in dollars, shall be exempt
32 from the provisions of said Uniform Classification and Compensation Act. All
33 persons occupying positions authorized herein are hereby governed by the
34 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
35 Code §21-5-101), or its successor.

19 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 21 HELP – STATE OPERATIONS. There is hereby authorized, for the Department of
 22 Education - Educational Television Division – State Operations for the ~~2005-~~
 23 ~~2007~~ 2007-2009 biennium, the following maximum number of part-time or
 24 temporary employees, to be known as "Extra Help", payable from funds
 25 appropriated herein for such purposes: five (5) temporary or part-time
 26 employees, when needed, at rates of pay not to exceed those provided in the
 27 Uniform Classification and Compensation Act, or its successor, for the
 28 appropriate classification. Many of these positions are related to specific
 29 projects, and those positions so related are specifically exempt from
 30 limitations of hours, either by act or regulation.

 19 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 21 HELP – CASH OPERATIONS. There is hereby authorized, for the Department of
 22 Education - Educational Television Division - Cash Operations for the ~~2005-~~
 23 ~~2007~~ 2007-2009 biennium, the following maximum number of part-time or
 24 temporary employees, to be known as "Extra Help", payable from funds
 25 appropriated herein for such purposes: forty six (46) ~~thirty six (36)~~
 26 temporary or part-time employees, when needed, at rates of pay not to exceed
 27 those provided in the Uniform Classification and Compensation Act, or its
 28 successor, for the appropriate classification. Many of these positions are
 29 related to specific projects, and those positions so related are specifically
 30 exempt from limitations of hours, either by act or regulation.

 32 appropriated, to the Department of Education - Educational Television
 33 Division, to be payable from the Educational Television Fund Account, for
 34 personal services and operating expenses for the "Honoring Arkansas' War
 35 Heroes - Documenting Stories of Arkansas' World War II Veterans"
 36 documentation project of the Department of Education - Educational Television

7 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 9 PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall establish
 10 upon request for the Department of Education - Educational Television
 11 Division a special appropriation line item not to exceed \$25,000 each fiscal
 12 year to be used in the acquisition of promotional items. When the Department
 13 of Education - Educational Television Division wishes to transfer monies from
 14 its operating expenses appropriation to the promotional items line, for
 15 Educational Purposes the AETN Commission shall approve the request and
 16 forward it to the Chief Fiscal Officer of the State for processing and for
 17 prior approval by the Arkansas Legislative Council or Joint Budget Committee.
 18 Determining the maximum number of employees and the maximum amount of
 19 appropriation and general revenue funding for a state agency each fiscal year
 20 is the prerogative of the General Assembly. This is usually accomplished by
 21 delineating such maximums in the appropriation act(s) for a state agency and
 22 the general revenue allocations authorized for each fund and fund account by
 23 amendment to the Revenue Stabilization law. Further, the General Assembly
 24 has determined that the Department of Education - Educational Television
 25 Division may operate more efficiently if some flexibility is provided to the
 26 Department of Education - Educational Television Division authorizing broad
 27 powers under this Section. Therefore, it is both necessary and appropriate
 28 that the General Assembly maintain oversight by requiring prior approval of
 29 the Legislative Council or Joint Budget Committee as provided by this
 30 section. The requirement of approval by the Legislative Council or Joint
 31 Budget Committee is not a severable part of this section. If the requirement
 32 of approval by the Legislative Council or Joint Budget Committee is ruled
 33 unconstitutional by a court of competent jurisdiction, this entire section is
 34 void.

35 The provisions of this section shall be in effect only from July 1, ~~2005~~
 36 2007 through June 30, ~~2007~~ 2009.

2 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HONORING
4 ARKANSAS' WAR HEROES. The appropriation authorized in this Act for Honoring
5 Arkansas' War Heroes is authorized for the 2007-2009 biennium only and is not
6 intended to be carried forward into the base level for the purposes of
7 biennial budget preparation for the 2009-2011 biennium. Any appropriation
8 request for this purpose for the 2009-2011 biennium shall be considered a new
9 appropriation request, and therefore will be considered a change level budget
10 request.

11 Notwithstanding any law pertaining to the transfer of year-end fund
12 balances or any law to the contrary, any funds provided to the Educational
13 Television Fund Account for the purpose of funding the Honoring Arkansas' War
14 Heroes Appropriation which remain in the Education Television Fund Account at
15 the end of a fiscal year shall remain in the Educational Television Fund
16 Account and shall continue to be allocated to the Honoring Arkansas' War
17 Heroes Appropriation in the following fiscal year.

19 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
20 by this act shall be limited to the appropriation for such agency and funds
21 made available by law for the support of such appropriations; and the
22 restrictions of the State Procurement Law, the General Accounting and
23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
24 Procedures and Restrictions Act, or their successors, and other fiscal
25 control laws of this State, where applicable, and regulations promulgated by
26 the Department of Finance and Administration, as authorized by law, shall be
27 strictly complied with in disbursement of said funds.

28
29 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General Assembly
30 that any funds disbursed under the authority of the appropriations contained
31 in this act shall be in compliance with the stated reasons for which this act
32 was adopted, as evidenced by the Agency Requests, Executive Recommendations
33 and Legislative Recommendations contained in the budget manuals prepared by
34 the Department of Finance and Administration, letters, or summarized oral
35 testimony in the official minutes of the Arkansas Legislative Council or
36 Joint Budget Committee which relate to its passage and adoption.
