13 ASSESSMENT FOR ALL 11TH GRADE STUDENTS; TO

15 CURRICULUM; AND FOR OTHER PURPOSES.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
26

27 SECTION 1. Arkansas Code Title 6, Chapter 18 is amended to add an
28 additional subchapter to read as follows:

29 SUBCHAPTER 16 – VOLUNTARY UNIVERSAL ACT ASSESMENT PROGRAM ACT

30
31 6-18-1601. Title.

32 This subchapter shall be known and may be cited as the "Voluntary
33 Universal ACT Assessment Program Act".
34

35 6-18-1602. Definitions.



1 As used in this subchapter:

2 (1) "ACT Assessment" means a test of student educational
3 development that measures student readiness for future learning and that may
4 be used by institutions of higher education as part of their admissions,
5 placement, and scholarship processes and high schools to improve college and
6 workforce readiness; and

7 (2) "Smart Core" means the required curriculum that is part of
8 Next Step, a state initiative focused on improving Arkansas public schools
9 for all students so they are prepared for life beyond graduation.

10
11 6-18-1603. Creation.

12 There is created in the Department of Education the Voluntary Universal
13 ACT Assessment Program to be developed, implemented, and administered by the
14 Department of Education as provided in this subchapter.

15
16 6-18-1604. Purpose.

17 The purpose of the Voluntary Universal ACT Assessment Program is to:

18 (1) Improve the college readiness of all students in grade
19 eleven (11);

20 (2) To prevent or minimize the continued remediation of nearly
21 fifty percent (50%) of all students entering Arkansas institutions of higher
22 education in one (1) or more subjects because they do not meet the college
23 readiness score of nineteen (19) or higher on the ACT Assessment;

24 (3) Advance the number of students including students of low-
25 income, English language learners, and minority students taking the ACT
26 Assessment while in grade eleven (11) to increase the number of first
27 generation college students;

28 (4) Increase the college participation rates among all racial
29 and ethnic groups;

30 (5) Improve preparation for college and the workforce;

31 (6) Improve the course selection patterns of high school
32 students;

33 (7) Increase the early identification of college ready students;

34 (8) Support students participating in the Smart Core by
35 providing a baseline for their college and workforce readiness and an
36 opportunity to benefit from earlier remediation such as the College

1 Preparatory Enrichment Program or course selection review; and

2 (9) Provide a link between what students have learned, what they
3 need to learn, and what is necessary in order to be college or workforce
4 ready or both by providing expectations and measuring their progress.

5
6 6-18-1605. Smart Core and ACT Assessment.

7 (a) The General Assembly finds that students who take the recommended
8 Smart Core courses or students who take additional courses after completing
9 the Smart Core continue to perform better on the ACT Assessment than students
10 who take less than the recommended core.

11 (b) The recommended core courses according to ACT Assessment officials
12 include:

13 (1) Four (4) years or more of English;

14 (2) Three (3) years or more of mathematics;

15 (3) Three (3) years or more of social studies; and

16 (4) Three (3) years or more of natural sciences.

17
18 6-18-1606. Implementation.

19 Beginning with the 2008-2009 school year, the Voluntary Universal ACT
20 Assessment Program may provide each student in grade eleven (11) with the
21 opportunity to take the ACT Assessment while in grade eleven (11) without any
22 charge by using school district funding, including National School Lunch Act
23 funds, to pay for the exams as approved by the Department of Education.

24
25 6-18-1607. Rules.

26 The Arkansas Department of Higher Education and the Arkansas Department
27 of Education shall develop rules for the administration of this subchapter.

28
29 6-18-1608. Reporting.

30 The Arkansas Department of Higher Education and the Arkansas Department
31 of Education shall submit a combined annual report to Legislative Council by
32 December 1 of each year that establishes compliance with this subchapter,
33 provides data on the number of participants in the Voluntary Universal ACT
34 Assessment Program, and outlines the impact of this program on the college-
35 readiness of high school seniors and the remediation rates at institutions of
36 higher education.
