24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. REGULAR SALARIES - CHILD ABUSE PREVENTION OPERATIONS. There is
27 hereby established for the State Child Abuse and Neglect Prevention Board -
28 Operations for the 2010-2011 fiscal year, the following maximum number of
29 regular employees whose salaries shall be governed by the provisions of the
30 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et
31 seq.), or its successor, and all laws amendatory thereto. Provided, however,
32 that any position to which a specific maximum annual salary is set out herein
33 in dollars, shall be exempt from the provisions of said Uniform
34 Classification and Compensation Act. All persons occupying positions
35 authorized herein are hereby governed by the provisions of the Regular
36 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its

SECTION 3. EXTRA HELP - CHILD ABUSE PREVENTION - CHILDREN'S TRUST FUND. There is hereby authorized, for the State Child Abuse and Neglect Prevention Board for the 2010-2011 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: one (1) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uni form Classi fication and Compensation Act, or its successor, or this act

1 for the appropriate classification.

3 SECTION 4. APPROPRIATION - CHILD ABUSE PREVENTION OPERATIONS. There is
4 hereby appropriated, to the State Child Abuse and Neglect Prevention Board,
5 to be payable from the Children's Trust Fund, for personal services and
6 operating expenses, and grants or loans for the development or operation of
7 child abuse prevention programs of the State Child Abuse and Neglect
8 Prevention Board - Operations for the fiscal year ending June 30, 2011, the

26 SECTION 5. APPROPRIATION - COMMUNITY GRANTS. There is hereby appropriated,
27 to the State Child Abuse and Neglect Prevention Board, to be payable from the
28 federal funds as designated by the Chief Fiscal Officer of the State, for
29 personal services and operating expenses, and community grants for the
30 development or operation of child abuse prevention programs of the State
31 Child Abuse and Neglect Prevention Board - Community Grants for the fiscal
32 year ending June 30, 2011, the following:

11 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
12 by this act shall be limited to the appropriation for such agency and funds
13 made available by law for the support of such appropriations; and the
14 restrictions of the State Procurement Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal
17 control laws of this State, where applicable, and regulations promulgated by
18 the Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

20

21 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly
22 that any funds disbursed under the authority of the appropriations contained
23 in this act shall be in compliance with the stated reasons for which this act
24 was adopted, as evidenced by the Agency Requests, Executive Recommendations
25 and Legislative Recommendations contained in the budget manuals prepared by
26 the Department of Finance and Administration, letters, or summarized oral
27 testimony in the official minutes of the Arkansas Legislative Council or
28 Joint Budget Committee which relate to its passage and adoption.

30 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
31 Assembly, that the Constitution of the State of Arkansas prohibits the
32 appropriation of funds for more than a one (1) year period; that the
33 effectiveness of this Act on July 1, 2010 is essential to the operation of
34 the agency for which the appropriations in this Act are provided, and that in
35 the event of an extension of the legislative session, the delay in the
36 effective date of this Act beyond July 1, 2010 could work irreparable harm

1 upon the proper administration and provision of essential governmental
2 programs. Therefore, an emergency is hereby declared to exist and this Act
3 being necessary for the immediate preservation of the public peace, health
4 and safety shall be in full force and effect from and after July 1, 2010.
