

18 SECTION 12. APPROPRIATION - REAPPROPRIATION - STATE CENTRAL SERVICES. 19 There is hereby appropriated, to the Arkansas House of Representatives, to be 20 payable from the State Central Services Fund, for the balance remaining on 21 June 30, 2010 in the appropriations enacted to defray the necessary expenses 22 of the House of Representatives of the Eighty-Seventh General Assembly, 23 Sections 3, 5, 7, 9, 10, and 12 of Act 612 of 2009, there to be used for the 24 same purposes for the Arkansas House of Representatives of the Eighty-seventh 25 General Assembly, in a sum in the aggregate not to exceed......\$3,448,000. 26

27 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USES OF 28 29 FUNDS. The funds appropriated in this Act shall be used to defray the 30 necessary expenses of the operation of the Office of the Speaker of the House 31 of Representatives, the Office of the Coordinator of House Legislative 32 Services, the Office of Parliamentarian, the Chief Clerk's Office, House 33 Constituency Services Office and other reasonable and necessary expenses of the House of Representatives of the General Assembly incurred during the 34 35 fiscal year ending June 30, 2011. Any balance remaining on June 30, 2010 in the funds provided by this Act shall be made available for the fiscal year 36

1 ending June 30, 2011 and for the same purposes.

3 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 5 AUTHORITY. If the Speaker of the House and the Coordinator of House 6 Legislative Services determine that any item or portion thereof appropriated 7 herein for a specific purpose is not needed for such purpose, they may 8 certify such fact to the State Auditor and the State Auditor shall cause a 9 transfer to be made from one item to another.

10

11 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARIES. 13 In order that exceptionally well-qualified personnel may be recruited and 14 retained, the House of Representatives may exceed the maximum salary levels 15 by no more than twenty percent (20%) for no more than one-third (1/3) of the 16 positions authorized in their operation appropriation act, may exceed the 17 maximum salary levels for the purpose of merit adjustments for all positions, 18 and may promote a maximum of two grades for no more than one-third (1/3) of 19 the classified positions authorized in its operation appropriation act. 20

SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
<u>AUDIO/VISUAL POLICY.</u> The appropriations provided herein to produce audio or
video materials by or under the direction of the House of Representatives
<u>shall not be used for the following:</u>

26	<u>(a)</u>	A person may not use audio or video materials produced by or under
27		the direction of the House of Representatives in political or
28		<u>campaign advertising.</u>
29	<u>(b)</u>	A person may not use audio or video materials produced by or under
30		the direction of the House of Representatives for a commercial
31		purpose.
32		(1) In this section, "commercial purpose" means a purpose that is
33		intended to result in a profit or other tangible benefit.
34	<u>(c)</u>	The House Management Committee may give permission to an entity to
35		use the audio or video materials for public education governmental
36		broadcast which shall not conflict with subsection (b).

1 The provisions of this section shall be in effect only through June 30, 2 2011.

SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 4 5 by this act shall be limited to the appropriation for such agency and funds 6 made available by law for the support of such appropriations; and the 7 restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 8 9 Procedures and Restrictions Act, or their successors, and other fiscal 10 control laws of this State, where applicable, and regulations promulgated by 11 the Department of Finance and Administration, as authorized by law, shall be 12 strictly complied with in disbursement of said funds.

SECTION 18. LEGISLATIVE INTENT. It is the intent of the General Assembly 14 15 that any funds disbursed under the authority of the appropriations contained 16 in this act shall be in compliance with the stated reasons for which this act 17 was adopted, as evidenced by the Agency Requests, Executive Recommendations 18 and Legislative Recommendations contained in the budget manuals prepared by 19 the Department of Finance and Administration, letters, or summarized oral 20 testimony in the official minutes of the Arkansas Legislative Council or 21 Joint Budget Committee which relate to its passage and adoption.

23 SECTION 19. EMERGENCY CLAUSE. It is found and determined by the General 24 Assembly, that the Constitution of the State of Arkansas prohibits the 25 appropriation of funds for more than a one (1) year period; that the 26 effectiveness of this Act on July 1, 2010 is essential to the operation of 27 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 28 effective date of this Act beyond July 1, 2010 could work irreparable harm 29 30 upon the proper administration and provision of essential governmental 31 programs. Therefore, an emergency is hereby declared to exist and this Act 32 being necessary for the immediate preservation of the public peace, health 33 and safety shall be in full force and effect from and after July 1, 2010. 34 35
