19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. REAPPROPRIATION - CENTRAL ADMINISTRATION - CONSERVATION TAX
22 PROJECTS - AMENDMENT 75. There is hereby appropriated, to the Department of
23 Arkansas Heritage, to be payable from the Arkansas Department of Heritage
24 Fund Account, for the Department of Arkansas Heritage, the following:

25 (A) Effective July 1, 2009, the balance of the appropriation provided in
26 Item (A) of Section 2 of Act 504 of 2007 and Item (06) of Section 5 of Act
27 793 of 2007, for Department of Arkansas Heritage Museum/Facility
28 Construction, in a sum not to exceed\$4,277,084.

29 (B) Effective July 1, 2009, the balance of the appropriation provided in
30 Item (B) of Section 2 of Act 504 of 2007 and Item (07) of Section 5 of Act
31 793 of 2007, for Special Maintenance, in a sum not to exceed...\$1,714,355.
32

33 SECTION 2. REAPPROPRIATION - CENTRAL ADMINISTRATION - GENERAL IMPROVEMENT
34 FUNDS. There is hereby appropriated, to the Department of Arkansas Heritage,
35 to be payable from the General Improvement Fund or its successor fund or fund



1 accounts, for the Department of Arkansas Heritage, the following:

2 (A) Effective July 1, 2009, the balance of the appropriation provided in
3 Item (A) of Section 3 of Act 504 of 2007, for major maintenance, renovation
4 and repairs of various facilities within the Department of Arkansas Heritage,
5 in a sum not to exceed\$5,466.

6 (B) Effective July 1, 2009, the balance of the appropriation provided in
7 Item (B) of Section 3 of Act 504 of 2007, for construction, purchase, and
8 acquisition of materials to build a permanent music stage and for the
9 development of a music sound studio for tourism, education, and cultural
10 enrichment and for other costs in Helena, Arkansas, in a sum not to exceed
11\$5,860.

12

13 SECTION 3. REAPPROPRIATION - DELTA CULTURAL CENTER. There is hereby
14 appropriated, to the Department of Arkansas Heritage - Delta Cultural Center,
15 to be payable from the Arkansas Natural and Cultural Resources Grant and
16 Trust Fund, for the Department of Arkansas Heritage - Delta Cultural Center,
17 the following:

18 (A) Effective July 1, 2009, the balance of the appropriation provided in
19 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
20 management, stewardship or preservation of state owned lands, historic sites,
21 buildings, structures or objects by the Department of Arkansas Heritage -
22 Natural and Cultural Resources Council, in a sum not to exceed ...\$596,600.

23

24 SECTION 4. REAPPROPRIATION - DELTA CULTURAL CENTER. There is hereby
25 appropriated, to the Department of Arkansas Heritage - Delta Cultural Center,
26 to be payable from the General Improvement Fund or its successor fund or fund
27 accounts, for the Department of Arkansas Heritage - Delta Cultural Center,
28 the following:

29 (A) Effective July 1, 2009, the balance of the appropriation provided in
30 Item (A) of Section 6 of Act 504 of 2007, for land purchase for a museum and
31 research buildings, in a sum not to exceed\$1,253.

32

33 SECTION 5. REAPPROPRIATION - MOSAIC TEMPLARS CULTURAL CENTER. There is
34 hereby appropriated, to the Department of Arkansas Heritage - Mosaic Templars
35 of America Center for African-American Culture and Business Enterprise, to be
36 payable from the Arkansas Natural and Cultural Resources Grant and Trust

1 Fund, for the Department of Arkansas Heritage - Mosaic Templars of America
2 Center for African-American Culture and Business Enterprise, the following:

3 (A) Effective July 1, 2009, the balance of the appropriation provided in
4 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
5 management, stewardship or preservation of state owned lands, historic sites,
6 buildings, structures or objects by the Department of Arkansas Heritage -
7 Natural and Cultural Resources Council, in a sum not to exceed ...\$250,000.
8

9 SECTION 6. REAPPROPRIATION - OLD STATE HOUSE COMMISSION. There is hereby
10 appropriated, to the Department of Arkansas Heritage - Old State House, to be
11 payable from the Arkansas Natural and Cultural Resources Grant and Trust
12 Fund, for the Department of Arkansas Heritage - Old State House, the
13 following:

14 (A) Effective July 1, 2009, the balance of the appropriation provided in
15 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
16 management, stewardship or preservation of state owned lands, historic sites,
17 buildings, structures or objects by the Department of Arkansas Heritage -
18 Natural and Cultural Resources Council, in a sum not to exceed ...\$1,350,000.
19

20 SECTION 7. REAPPROPRIATION - HISTORIC PRESERVATION. There is hereby
21 appropriated, to the Department of Arkansas Heritage - Historic Preservation,
22 to be payable from the General Improvement Fund or its successor fund or fund
23 accounts, for the Department of Arkansas Heritage - Historic Preservation,
24 the following:

25 (A) Effective July 1, 2009, the balance of the appropriation provided in
26 Item (A) of Section 1 of Act 1469 of 2007, for construction and various
27 operating expenses of the Mosaic Templar, in a sum not to exceed
28\$2,275,000.

29 (B) Effective July 1, 2009, the balance of the appropriation provided in
30 Item (A) of Section 1 of Act 1752 of 2007, for renovation and preservation of
31 Veterans' Memorial Park, in a sum not to exceed\$11,429.

32 (C) Effective July 1, 2009, the balance of the appropriation provided in
33 Item (A) of Section 1 of Act 1271 of 2007, for renovations and improvements
34 to Historic Bridges, in a sum not to exceed\$20,000.
35

36 SECTION 8. REAPPROPRIATION - HISTORIC PRESERVATION. There is hereby

1 appropriated, to the Department of Arkansas Heritage - Historic Preservation,
2 to be payable from the Arkansas Natural and Cultural Resources Grant and
3 Trust Fund, for the Department of Arkansas Heritage - Historic Preservation,
4 the following:

5 (A) Effective July 1, 2009, the balance of the appropriation provided in
6 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
7 management, stewardship or preservation of state owned lands, historic sites,
8 buildings, structures or objects by the Department of Arkansas Heritage -
9 Natural and Cultural Resources Council, in a sum not to exceed ...\$972,978.

10

11 SECTION 9. REAPPROPRIATION - NATURAL HERITAGE COMMISSION. There is hereby
12 appropriated, to the Department of Arkansas Heritage - Natural Heritage
13 Commission, to be payable from the Arkansas Natural and Cultural Resources
14 Grant and Trust Fund, for the Department of Arkansas Heritage - Natural
15 Heritage Commission, the following:

16 (A) Effective July 1, 2009, the balance of the appropriation provided in
17 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
18 management, stewardship or preservation of state owned lands, historic sites,
19 buildings, structures or objects by the Department of Arkansas Heritage -
20 Natural and Cultural Resources Council, in a sum not to exceed...\$1,732,146.

21

22 SECTION 10. REAPPROPRIATION - NATURAL HERITAGE COMMISSION. There is hereby
23 appropriated, to the Department of Arkansas Heritage - Natural Heritage
24 Commission, to be payable from the Arkansas Department of Heritage Fund
25 Account, for the Department of Arkansas Heritage - Natural Heritage
26 Commission, the following:

27 (A) Effective July 1, 2009, the balance of the appropriation provided in
28 Item (A) of Section 13 of Act 504 of 2007 and Section 25 of Act 793 of 2007,
29 for the system of Natural Areas: Land Acquisition, Public Access and
30 Inventory capital project of the Department of Arkansas Heritage, in a sum
31 not to exceed\$186,110.

32

33 SECTION 11. REAPPROPRIATION - HISTORIC ARKANSAS MUSEUM COMMISSION. There
34 is hereby appropriated, to the Department of Arkansas Heritage - Historic
35 Arkansas Museum, to be payable from the Arkansas Natural and Cultural
36 Resources Grant and Trust Fund, for the Department of Arkansas Heritage -

1 Historic Arkansas Museum, the following:

2 (A) Effective July 1, 2009, the balance of the appropriation provided in
3 Item (01) of Section 30 of Act 793 of 2007, for grants for the acquisition,
4 management, stewardship or preservation of state owned lands, historic sites,
5 buildings, structures or objects by the Department of Arkansas Heritage -
6 Natural and Cultural Resources Council, in a sum not to exceed ...\$779,728.

7
8 SECTION 12. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
9 obligations otherwise incurred in relation to the project or projects
10 described herein in excess of the State Treasury funds actually available
11 therefor as provided by law. Provided, however, that institutions and
12 agencies listed herein shall have the authority to accept and use grants and
13 donations including Federal funds, and to use its unobligated cash income or
14 funds, or both available to it, for the purpose of supplementing the State
15 Treasury funds for financing the entire costs of the project or projects
16 enumerated herein. Provided further, that the appropriations and funds
17 otherwise provided by the General Assembly for Maintenance and General
18 Operations of the agency or institutions receiving appropriation herein shall
19 not be used for any of the purposes as appropriated in this act.

20 (B) The restrictions of any applicable provisions of the State Purchasing
21 Law, the General Accounting and Budgetary Procedures Law, the Revenue
22 Stabilization Law and any other applicable fiscal control laws of this State
23 and regulations promulgated by the Department of Finance and Administration,
24 as authorized by law, shall be strictly complied with in disbursement of any
25 funds provided by this act unless specifically provided otherwise by law.

26
27 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General Assembly
28 that any funds disbursed under the authority of the appropriations contained
29 in this act shall be in compliance with the stated reasons for which this act
30 was adopted, as evidenced by the Agency Requests, Executive Recommendations
31 and Legislative Recommendations contained in the budget manuals prepared by
32 the Department of Finance and Administration, letters, or summarized oral
33 testimony in the official minutes of the Arkansas Legislative Council or
34 Joint Budget Committee which relate to its passage and adoption.

35
36 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the General

1 Assembly, that the Constitution of the State of Arkansas prohibits the
2 appropriation of funds for more than a one (1) year period; that the
3 effectiveness of this Act on July 1, 2009 is essential to the operation of
4 the agency for which the appropriations in this Act are provided, and that in
5 the event of an extension of the Regular Session, the delay in the effective
6 date of this Act beyond July 1, 2009 could work irreparable harm upon the
7 proper administration and provision of essential governmental programs.
8 Therefore, an emergency is hereby declared to exist and this Act being
9 necessary for the immediate preservation of the public peace, health and
10 safety shall be in full force and effect from and after July 1, 2009.
