9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL
10 SERVICES AND OPERATING EXPENSES FOR THE ARKANSAS
11 STATE UNIVERSITY - BEEBE WHICH SHALL BE
12 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
13 APPROPRIATED BY ACT 1251 OF 2007; AND FOR OTHER
14 PURPOSES.

18 AN ACT FOR THE ARKANSAS STATE
19 UNIVERSITY - BEEBE SUPPLEMENTAL

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. APPROPRIATION - STATE OPERATIONS - HEBER SPRINGS. There is
26 hereby appropriated, to the Arkansas State University - Beebe, to be payable
27 from the Arkansas State University - Beebe Fund, for personal services and
28 operating expenses of the Arkansas State University - Beebe - ASU - Heber
29 Springs which shall be supplemental and in addition to those funds
30 appropriated in Section 6 of Act 1251 of 2007, the following:

9 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
10 by this act shall be limited to the appropriation for such agency and funds
11 made available by law for the support of such appropriations; and the
12 restrictions of the State Procurement Law, the General Accounting and
13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
14 Procedures and Restrictions Act, the Higher Education Expenditures
15 Restrictions Act, or their successors, and other fiscal control laws of this
16 State, where applicable, and regulations promulgated by the Department of
17 Finance and Administration, as authorized by law, shall be strictly complied
18 with in disbursement of said funds.

19

20 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
21 that any funds disbursed under the authority of the appropriations contained
22 in this act shall be in compliance with the stated reasons for which this act
23 was adopted, as evidenced by the Agency Requests, Executive Recommendations
24 and Legislative Recommendations contained in the budget manuals prepared by
25 the Department of Finance and Administration, letters, or summarized oral
26 testimony in the official minutes of the Arkansas Legislative Council or
27 Joint Budget Committee which relate to its passage and adoption.

29 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
30 Assembly, that funds provided by the General Assembly for the operations of
31 the Arkansas State University - Beebe are, due to unforeseen circumstances,
32 insufficient for the Arkansas State University - Beebe to continue to provide
33 essential governmental services; that the provisions of this act will provide
34 the necessary monies for the Arkansas State University - Beebe to continue
35 such services; and that a delay in the effective date of this Act could work
36 irreparable harm upon the proper administration and provision of essential

1 governmental programs. Therefore, an emergency is hereby declared to exist
2 and this Act being necessary for the immediate preservation of the public
3 peace, health and safety shall be in full force and effect from and after the
4 date of its passage and approval.

5 If the bill is neither approved nor vetoed by the Governor, it shall become
6 effective on the expiration of the period of time during which the Governor
7 may veto the bill. If the bill is vetoed by the Governor and the veto is
8 overridden, it shall become effective on the date the last house overrides
9 the veto.
