4 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRYOVER

6 OF CLAIMS. Any state agency which is affected by the allowed claim(s)

7 provided for in this Act, and whose fund for the 2008-2009 fiscal year are

8 insufficient to allow for the payment of said claim(s) before June 30, 2009,

9 is hereby authorized, upon certification by the Chief Fiscal Officer of the

10 State, to make payment of said claim(s) after July 1, 2009, from funds

11 appropriated for the 2009-2010 fiscal year.

13 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

15 DISBURSING OFFICER. The Clerk of the State Claims Commission is hereby made

16 the disbursing officer for the purpose of paying the claims appropriated by

17 this Act. The Clerk of the State Claims Commission is hereby authorized to

18 receive all warrants prepared under the provisions of this Act from the

19 Auditor of the State and to distribute same to the claimants.

20

21 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS

23 DEPARTMENT OF HUMAN SERVICES CLAIMS. For any claims in this Act appropriated

24 to the Department of Human Services, the Clerk of the State Claims Commission

25 shall consult with the Department of Human Services and the Chief Fiscal

26 Officer of the State to determine the division and funds to which liability

27 should be assigned and from which the warrants shall be drawn. The Clerk of

28 the State Claims Commission shall initiate the appropriate transfers as may

29 be required and as approved by the Chief Fiscal Officer of the State.

30

31 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS

33 DEPARTMENT OF HEALTH CLAIMS. For any claims in this Act appropriated to the

34 Department of Health, the Clerk of the State Claims Commission shall consult

35 with the Department of Health and the Chief Fiscal Officer of the State to

36 determine the division and funds to which liability should be assigned and

1 from which the warrants shall be drawn. The Clerk of the State Claims
2 Commission shall initiate the appropriate transfers as may be required and as
3 approved by the Chief Fiscal Officer of the State.
4

5 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
7 FROM CASH FUNDS. In the event that any claim authorized herein is determined
8 to be a valid claim against the State and the claim is to be paid from funds
9 not in the State Treasury, the Clerk of the State Claims Commission shall
10 notify the agency against which the claim is to be charged of the amount of
11 such claims. Upon receipt of such notification, the state agency shall
12 forthwith deliver a check to the Clerk of the State Claims Commission who
13 shall deposit the same as a non-revenue receipt into the Miscellaneous
14 Revolving Fund from which he shall disburse the amount of the claim to the
15 claimant.
16

17 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
19 EMPLOYMENT COMPENSATION CLAIMS. The Clerk of the State Claims Commission
20 shall not distribute any warrants prepared under the provisions of this Act
21 for awards made by the Arkansas State Claims Commission for employment
22 compensation claims. Upon the award by the State Claims Commission of an
23 employment compensation claim, the Clerk of the State Claims Commission shall
24 notify the affected state agency and the Department of Finance and
25 Administration - Office of Personnel Management of such amounts that are due
26 and payable. The affected state agency shall then process the award through
27 the State Mechanized Payroll System.
28

29 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
31 AWARD REPORTING. It is the intent of the General Assembly that when any
32 state agency, board, commission or institution of higher education admits
33 liability to a claim filed with the State Claims Commission and the claim
34 involves a contract with a state agency, board, commission or institution of
35 higher education or the claim exceeds ten thousand dollars (\$10,000) that
36 such agency, board, commission or institution of higher education file a

1 written report thereof to the Litigation Subcommittee of the Legislative
2 Council. Such a report shall include a concise statement of facts with an
3 explanation of the agency's liability. Provided further, such report shall be
4 filed with the Litigation Subcommittee within thirty (30) days after the
5 claim has been adjudicated by the State Claims Commission.

6
7 SECTION 19. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
8 by this act shall be limited to the appropriation for such agency and funds
9 made available by law for the support of such appropriations; and the
10 restrictions of the State Procurement Law, the General Accounting and
11 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
12 Procedures and Restrictions Act, or their successors, and other fiscal
13 control laws of this State, where applicable, and regulations promulgated by
14 the Department of Finance and Administration, as authorized by law, shall be
15 strictly complied with in disbursement of said funds.

16
17 SECTION 20. LEGISLATIVE INTENT. It is the intent of the General Assembly
18 that any funds disbursed under the authority of the appropriations contained
19 in this act shall be in compliance with the stated reasons for which this act
20 was adopted, as evidenced by the Agency Requests, Executive Recommendations
21 and Legislative Recommendations contained in the budget manuals prepared by
22 the Department of Finance and Administration, letters, or summarized oral
23 testimony in the official minutes of the Arkansas Legislative Council or
24 Joint Budget Committee which relate to its passage and adoption.

25
26 SECTION 21. EMERGENCY CLAUSE. It is found and determined by the General
27 Assembly, that payees listed in this Act may be entitled to the sums
28 appropriated and transferred to herein, and that they have been deprived of
29 the use of these funds for a long period of time, and that further delay in
30 paying these just debts of the State would do harm to the reputation of the
31 State of Arkansas. Therefore, an emergency is hereby declared to exist and
32 this Act being necessary for the immediate preservation of the public peace,
33 health and safety shall be in full force and effect from and after the date
34 of its passage and approval.

35 If the bill is neither approved nor vetoed by the Governor, it shall
36 become effective on the expiration of the period of time during which the

1 Governor may veto the bill. If the bill is vetoed by the Governor and the
2 veto is overridden, it shall become effective on the date the last house
3 overrides the veto.
