11 TO THE DEPARTMENT OF CORRECTION; TO ENSURE THAT
12 ORDERS BY MEDICAL PROVIDERS FOR RESTRICTIONS ON
13 WORK BY INMATES ARE FOLLOWED BY THE DEPARTMENT OF
14 CORRECTION; AND FOR OTHER PURPOSES.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code § 12-29-403 is amended to read as follows:
28 12-29-403. Disabled convicts – Duty of physician.

29 (a)(1) ~~In the case of any convict claiming to be unable to labor by~~
30 ~~reason of sickness, it shall be the duty of the physician to examine the~~
31 ~~convict~~ Each new inmate committed to the Department of Correction shall be
32 given a medical examination during the intake process.

33 (2)(A) ~~If in the opinion of the physician the convict is unable~~
34 ~~to labor, the physician shall immediately certify his or her opinion to the~~
35 ~~Director of the Department of Correction~~ During the medical examination



1 required under subdivision (a)(1) of this section, the medical provider shall
2 determine what restrictions if any shall be placed upon the inmate's work
3 assignments.

4 (B) ~~The convict shall then be relieved from labor and sent~~
5 ~~to his or her cell or admitted to the hospital or elsewhere for medical~~
6 ~~treatment, as the physician may direct, with due regard being given to the~~
7 ~~safekeeping of the convict~~ Restrictions placed upon an inmate's work
8 assignments under subdivision (a)(2)(A) of this section shall be updated as
9 medically necessary.

10 (b) ~~The convict shall not be required to labor so long as the~~
11 ~~disability continues~~ The department shall not assign an inmate to a work
12 assignment that conflicts with a restriction determined by the medical
13 provider for the department under subdivision (a)(2) of this section.

14 (c) ~~Whenever the physician shall certify that the convict has~~
15 ~~recovered, he shall be returned to labor and not before~~ medical provider
16 updates the restrictions under subdivision (a)(2) of this section, the
17 department shall adjust the inmate's work assignments as necessary to comply
18 with the updated restrictions.
