21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 23-2-315 is amended to read as follows:
24 23-2-315. Reports by commission.

25 The ~~commission~~ Arkansas Public Service Commission shall make and submit
26 to the Governor during the month of ~~April~~ June of each year a report
27 containing a full and complete account of its transactions and proceedings
28 for the preceding calendar year, together with such other facts, suggestions,
29 and recommendations as it may deem of value to the people of the state.
30

31 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
32 General Assembly of the State of Arkansas that the April date for the
33 submission of the Arkansas Public Service Commission's annual report to the
34 Governor precludes the commission from including full and complete public
35 utility data for the preceding calendar year; that changing the submission



1 date of the annual report from April to June will allow the commission to
2 include in its annual report full and complete public utility data for the
3 preceding calendar year; that this act is immediately necessary because the
4 commission's next annual report is required to be submitted in the month of
5 April 2009. Therefore, an emergency is declared to exist and this act being
6 immediately necessary for the preservation of the public peace, health, and
7 safety shall become effective on:

8 (1) The date of its approval by the Governor;

9 (2) If the bill is neither approved nor vetoed by the Governor,
10 the expiration of the period of time during which the Governor may veto the
11 bill; or

12 (3) If the bill is vetoed by the Governor and the veto is
13 overridden, the date the last house overrides the veto.
