19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 10-2-215 is amended to read as follows to
22 further subdivide and reorganize the section for clarity and to make
23 stylistic changes:

24 10-2-215. Additional compensation for committee chairs and cochairs.

25 (a) ~~(1) In addition to the expense allowance provided by § 10-2-212 and~~
26 ~~all laws amendatory and supplemental thereto, the~~ The following members of
27 the General Assembly are eligible to receive three thousand six hundred
28 dollars (\$3,600) per year in addition to the expense allowance provided by §
29 10-2-212:

30 (1) The chair of each of the standing, select, and joint
31 committees of either house of the General Assembly;

32 (2) ~~the~~ The cochairs of the Legislative Council;

33 (3) ~~and the~~ The ~~chairs~~ chair of each subcommittee of the

 31 subsection is obsolete.

21 ~~(a) There is created the Arkansas Legislative Task Force on Higher~~
 22 ~~Education Remediation, Retention, and Graduation Rates.~~

23 ~~(b) The task force shall consist of the following fifteen (15)~~
 24 ~~members:~~

25 ~~(1) The Governor or the Governor's designee;~~

26 ~~(2) The Chair of the House Interim Committee on Education or the~~
 27 ~~chair's designee;~~

28 ~~(3) The Chair of the Senate Interim Committee on Education or the~~
 29 ~~chair's designee;~~

30 ~~(4) The Chair of the Higher Education Subcommittee of the Arkansas~~
 31 ~~Legislative Council or the chair's designee;~~

32 ~~(5) The Director of the Department of Higher Education or the~~

7 ~~education with one (1) member from each of the four (4) congressional~~

9 ~~(11) A vice president or provost of academic affairs appointed by the~~

4 ~~(2) Summarize data on rates of remediation, types of testing used to~~
 5 ~~determine college readiness, and characteristics of programs that are most~~
 6 ~~effective in addressing skill deficits, and data on effectiveness of~~
 7 ~~remediation for students with entering skill deficits;~~

8 ~~(3) Create a definition of remediation to assure consistency in~~
 9 ~~reporting of remediation among colleges and universities throughout Arkansas;~~

10 ~~(4) Identify the underlying factors that contribute to the number of~~
 11 ~~students who are not ready for collegiate level classes in certain~~
 12 ~~disciplines at the time of high school graduation;~~

13 ~~(5) Identify best practices examples of school systems and colleges~~
 14 ~~that are having success in reducing the need for remedial education;~~

15 ~~(6) Brainstorm new approaches that may be effective in producing~~
 16 ~~increased levels of college readiness;~~

17 ~~(7) Attempt to clarify the role that various types of colleges and~~
 18 ~~universities should play in addressing the need for remediation;~~

19 ~~(8) Review graduation rates of the state's colleges and universities~~
 20 ~~for the past six (6) years;~~

21 ~~(9) Develop a set of written recommendations for the General Assembly~~
 22 ~~that will improve remediation, retention, and graduation rates at the state's~~

24 ~~(10) Present the written recommendations of the task force to the~~

 31 SECTION 5. The enactment and adoption of this act shall not repeal,
 32 expressly or impliedly, the acts passed at the regular session of the 87th
 33 General Assembly. All such acts shall have full effect and, so far as those
 34 acts intentionally vary from or conflict with any provision contained in this
 35 act, those acts shall have the effect of subsequent acts and as amending or
 36 repealing the appropriate parts of the Arkansas Code of 1987. **APPROVED:**
