15 AN ACT FOR THE ARKANSAS MOTOR VEHICLE

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the Arkansas
24 Motor Vehicle Commission for the 2009-2010 fiscal year, the following maximum
25 number of regular employees whose salaries shall be governed by the
26 provisions of the Uniform Classification and Compensation Act (Arkansas Code
27 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
28 Provided, however, that any position to which a specific maximum annual
29 salary is set out herein in dollars, shall be exempt from the provisions of
30 said Uniform Classification and Compensation Act. All persons occupying
31 positions authorized herein are hereby governed by the provisions of the
32 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),
33 or its successor.

12 SECTION 2. APPROPRIATION. There is hereby appropriated, to the Arkansas
 13 Motor Vehicle Commission, to be payable from the Motor Vehicle Commission
 14 Fund, for personal services and operating expenses of the Arkansas Motor
 15 Vehicle Commission for the fiscal year ending June 30, 2010, the following:

29 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CONSUMER
 31 PROTECTION. Protecting the consumer is a critical purpose of the Arkansas
 32 Motor Vehicle Commission. Therefore, of the total amount appropriated under
 33 Section 2 of this Act for the operating expenses of the Arkansas Motor
 34 Vehicle Commission, seventeen thousand five hundred dollars (\$17,500) each
 35 fiscal year shall be allocated to consumer protection efforts. The Arkansas
 36 Motor Vehicle Commission will submit quarterly a written report to Arkansas

1 Legislative Council on their Consumer Protection efforts.

2 The Arkansas Motor Vehicle Commission will continue to develop additional
 3 programs and procedures that will expand consumer protection efforts.

4 The provisions of this section shall be in effect only from July 1,
 5 ~~2007~~ 2009 through June 30, ~~2009~~ 2010.

 7 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
 9 TRANSFER - MOTOR VEHICLE EDUCATION AND TRAINING. For the fiscal year ending
 10 June 30, 2008, and for each fiscal year thereafter, the Director of the
 11 Arkansas Motor Vehicle Commission may, from time to time as needed, certify
 12 to the Chief Fiscal Officer of the State the amount of funds necessary to
 13 transfer on his or her books and those of the State Treasurer and the Auditor
 14 of State, from the Motor Vehicle Commission Fund to the Department of
 15 Workforce Education Fund Account, to provide funds for expenses related to
 16 motor vehicle education and training. Fund transfer will be completed
 17 following quarterly review of program expenditures, including a review of the
 18 availability of program funding. In no event shall the amount of funds
 19 transferred under the provisions of this section exceed one hundred fifty
 20 thousand dollars (\$150,000) in any one fiscal year.

21
 22 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
 23 by this act shall be limited to the appropriation for such agency and funds
 24 made available by law for the support of such appropriations; and the
 25 restrictions of the State Procurement Law, the General Accounting and
 26 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 27 Procedures and Restrictions Act, or their successors, and other fiscal
 28 control laws of this State, where applicable, and regulations promulgated by
 29 the Department of Finance and Administration, as authorized by law, shall be
 30 strictly complied with in disbursement of said funds.

31
 32 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly
 33 that any funds disbursed under the authority of the appropriations contained
 34 in this act shall be in compliance with the stated reasons for which this act
 35 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 36 and Legislative Recommendations contained in the budget manuals prepared by

1 the Department of Finance and Administration, letters, or summarized oral
2 testimony in the official minutes of the Arkansas Legislative Council or
3 Joint Budget Committee which relate to its passage and adoption.

4
5 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General
6 Assembly, that the Constitution of the State of Arkansas prohibits the
7 appropriation of funds for more than a one (1) year period; that the
8 effectiveness of this Act on July 1, 2009 is essential to the operation of
9 the agency for which the appropriations in this Act are provided, and that in
10 the event of an extension of the Regular Session, the delay in the effective
11 date of this Act beyond July 1, 2009 could work irreparable harm upon the
12 proper administration and provision of essential governmental programs.
13 Therefore, an emergency is hereby declared to exist and this Act being
14 necessary for the immediate preservation of the public peace, health and
15 safety shall be in full force and effect from and after July 1, 2009.
