(A) No contract may be awarded nor 3 4 obligations otherwise incurred in relation to the project or projects 5 described herein in excess of the State Treasury funds actually available 6 therefor as provided by law. EMERGENCY CLAUSE. It is found and determined by the General 32 Assembly, that the Constitution of the State of Arkansas prohibits the 33 appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2009 is essential to the operation of 34 35 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective 36
