9 AN ACT TO PROVIDE THAT THE SPEAKER OF THE HOUSE  
10 OF REPRESENTATIVES MAY SELECT A DESIGNEE TO SERVE  
11 ON HIS OR HER BEHALF ON THE JOINT COMMITTEE ON  
12 LEGISLATIVE PRINTING REQUIREMENTS AND  
13 SPECIFICATIONS AND ON THE JOINT INTERIM COMMITTEE  
14 ON LEGISLATIVE FACILITIES; AND FOR OTHER  
15 PURPOSES.

18 TO PROVIDE THAT THE SPEAKER OF THE HOUSE  
19 MAY SELECT A DESIGNEE TO SERVE ON HIS OR  
20 HER BEHALF ON THE JOINT COMMITTEE ON

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

28 SECTION 1. Arkansas Code § 10-2-215, concerning compensation for  
29 committee chairs, is amended to add a new subsection to read as follows:

30 (c) The chair of a committee established by rule of the House of  
31 Representatives also may receive an allowance under subsection (a) of this  
32 section if authorized by rule of the House of Representatives.

34 SECTION 2. Arkansas Code § 10-3-602 is amended to read as follows:  
35 10-3-602. Creation – Composition.



1 There is established a joint interim committee of the General Assembly,  
2 consisting of the chair and vice chair of the respective efficiency  
3 committees of the House of Representatives and Senate, the Speaker of the  
4 House of Representatives or his or her designee, and the President Pro  
5 Tempore of the Senate, which committee shall be designated and be known as  
6 the Joint Committee on Legislative Printing Requirements and Specifications.

8 SECTION 2. Arkansas Code § 10-3-1101(a)(4), concerning membership on  
9 the Joint Interim Committee on Legislative Facilities, is amended to read as  
10 follows:

11 (4) The Speaker of the House of Representatives or his or her  
12 designee;
