8 AN ACT TO ESTABLISH THE EIGHTY-EIGHTH SESSION
9 PROJECTS ACCOUNT WITHIN THE GENERAL IMPROVEMENT FUND;
10 TO DEFINE THE MONIES TO BE AVAILABLE IN SUCH ACCOUNT;
11 AND TO DEFINE THE PURPOSES FOR WHICH MONIES MAY BE
12 MADE AVAILABLE FROM THE GENERAL IMPROVEMENT FUND SO
13 THAT ADDITIONAL FUNDS CAN BE MADE AVAILABLE FOR THE
14 STATE BUDGET; AND FOR OTHER PURPOSES.

18 THE DISTRIBUTION OF THE EIGHTY-EIGHTH
19 SESSION PROJECTS ACCOUNT OF THE GENERAL
20 IMPROVEMENT FUND TO PROVIDE ADDITIONAL
21 FUNDS FOR THE STATE BUDGET.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. This Act may be cited as the "General Improvement Distribution
27 Act of 2011".
28

29 SECTION 2. There is hereby created and established on the books of the
30 Chief Fiscal Officer of the State, the State Treasurer and the State Auditor,
31 the "88th Session Projects Account" within the "General Improvement Fund",
32 into which shall be transferred and credited the respective monies as
33 hereinafter provided in this Act, to be used for providing financing, in the
34 manner set forth herein, for the various projects and purposes enumerated in
35 this Act to be financed from said account.

36 Immediately upon the effective date of this Act, or as soon thereafter as is



1 practical, the State Treasurer shall transfer and credit to the "88th Session
2 Projects Account" of the "General Improvement Fund", upon certification of
3 the amounts thereof by the Chief Fiscal Officer of the State, the following:

4 (a) all unobligated and unallocated monies remaining in the "General
5 Improvement Fund" on June 30, 2011 which are not required to finance projects
6 to be financed there from pursuant to appropriations enacted by the 87th
7 General Assembly, or which have not been reappropriated or reallocated for
8 financing from the "General Improvement Fund" by the 88th General Assembly;

9 (b) any unobligated or unallocated funds remaining on July 2, 2011 in
10 the "General Revenue Allotment Reserve Fund" from monies accruing thereto
11 during the 2009-2011 fiscal biennium which are not required to finance
12 enactments of the 88th General Assembly that do not expire on June 30, 2011;

13 (c) interest earned on State Treasury fund balances as provided in
14 this subsection. For the period commencing on July 1, 2011, and ending June
15 30, 2013, the State Treasurer shall, after complying with provisions of

16 (1) Arkansas Code 27-70-204 for distributing interest income
17 earned from investment of average daily balances of the "State Highway and
18 Transportation Department Fund",

19 (2) Arkansas Code 15-41-110 for distributing interest earned from
20 investment of average daily balances of the "Game Protection Fund", and

21 (3) Arkansas Code 20-78-504 for the next one hundred thousand
22 dollars (\$100,000) of interest income received each fiscal year by the State
23 Treasurer for the "Arkansas Child Care Facilities Loan Guarantee Trust Fund",
24 credit to the "Budget Stabilization Trust Fund" or its successor fund, fifty
25 percent (50%) of the interest income received and credited to the "Securities
26 Reserve Fund", and credit to the "88th Session Projects Account" fifty
27 percent (50%) of the interest income received and credited to the "Securities
28 Reserve Fund" as certified by the Chief Fiscal Officer of the State, to
29 provide financing to the "88th Session Projects Account", until there has
30 been credited an amount, which when added to the other funds available for
31 such purposes will finance each of the projects or purposes hereinafter
32 enumerated;

33 (d) Those special revenues credited to the General Improvement
34 Fund from *estate taxes as set out in Arkansas Code 19-6-301(171)*;

35 (e) *The sum of ten million five hundred thousand dollars*
36 *(\$10,500,000), or so much thereof as is available remaining in the 87th*

1 *Session Projects Account of the General Improvement Fund from funds set aside*
2 *in (a)(1) of Section 3 of Act 1442 and Act 1443 of 2009.*

3
4 *SECTION 3. Of those moneys accruing to the 88th Session Projects*
5 *Account of the General Improvement Fund as set out in Section 2 of this Act,*
6 *the State Treasurer shall first set-aside twenty six million four hundred*
7 *thousand three hundred and twelve dollars (\$26,400,312). In the event the*
8 *amount of funds actually transferred to the 88th Session Projects Account by*
9 *Section 2 (e) of this Act is less than ten million five hundred thousand*
10 *dollars (\$10,500,000) the State Treasurer shall adjust the amount first set*
11 *aside to the amount less than ten million five hundred thousand dollars*
12 *(\$10,500,000) actually transferred. In no event shall the State Treasurer*
13 *decrease the amount first set aside by more than ten million five hundred*
14 *thousand dollars (\$10,500,000). Such funds set-aside and made available under*
15 *this section shall be used for any project or portion thereof enumerated*
16 *within subsection (a) or (d) so long as the projects enumerated in*
17 *subsections (a)(2) and (a)(3) are fully funded by June 30, 2013, but not to*
18 *exceed the amount set out in subsection (a) for the project. The Chief*
19 *Fiscal Officer of the State shall notify the Arkansas Legislative Council or*
20 *the Joint Budget Committee of the release of funds for projects enumerated in*
21 *subsection (a) at the same time that the Department of Finance and*
22 *Administration is notified.*

23 *(a)(1) For transfers, from time to time, to the various fund and fund*
24 *accounts in the Revenue Stabilization Law as amended, or for transfers, from*
25 *time to time, for projects in the Executive Discretionary Division (d), upon*
26 *approval by the Arkansas Legislative Council or Joint Budget Committee, a sum*
27 *not to exceed ten million five hundred thousand dollars (\$10,500,000), or so*
28 *much thereof as is transferred as authorized in Section 2 (e) of this Act;*

29 *(2) Department of Correction, for lease payments for Department Facilities,*
30 *\$13,000,000;*

31 *(3) Department of Education - General Education Division, APSCN, for*
32 *Repayment of Loan to Teacher Retirement System, \$2,900,312.*

33
34 *(b) Then the Treasurer of State shall first make monthly allocations on the*
35 *basis of eighty percent (80.00%) of the total available funds to the*
36 *Executive Discretionary Division as set out in subsection (d) and the*

1 remainder of the total available funds to the Legislative Division listed in
 2 subsection (c). The Legislative Division funds shall be used to provide
 3 funds to each project enumerated in subsection (c) of this section in
 4 proportion that each project's allocation bears to the total of the
 5 allocations of all projects enumerated in subsection (c). Additional funds
 6 that may be received by the General Improvement Fund after the projects in
 7 subsection (c) have been fully funded shall remain in the General Improvement
 8 Fund for such purpose as may be enacted by law, but shall not be a part of
 9 the 88th Session Projects Account. Funds made available to the Executive
 10 Discretionary Division may be used for any project or portion thereof
 11 enumerated within the Executive Discretionary Division but not to exceed the
 12 amount set out in subsection (d) for the project. The Chief Fiscal Officer of
 13 the State shall notify the Arkansas Legislative Council or Joint Budget
 14 Committee of the Governor's released funds for projects at the same time that
 15 the Department of Finance and Administration is notified.

15 *SECTION 4. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED*
 16 *SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. Senate and House bills as*
 17 *enacted by the 88th General Assembly in Regular Session are referenced in*
 18 *Item (c) of Section 3 of this Act for the purpose of distribution of funds.*

19

20 *SECTION 5. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED*
 21 *SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER PROVISION. In the*
 22 *event the Commissioner of State Lands determines that in order to meet the*
 23 *necessary financial obligations of the State Land Department, the*
 24 *Commissioner of State Lands may request upon certification, approval of the*
 25 *Governor and Chief Fiscal Officer of the State a fund transfer of up to three*
 26 *million dollars (\$3,000,000) from the 88th Session Projects Fund Account of*
 27 *the General Improvement Fund. Upon approval of the Governor and Chief Fiscal*
 28 *Officer of the State and prior review by the Arkansas Legislative Council or*
 29 *Joint Budget Committee, the Chief Fiscal Officer of the State shall transfer*
 30 *on his or her books and those of the State Treasurer and Auditor of State,*
 31 *equal amounts from the Executive Division and the Legislative Division of the*
 32 *88th Session Projects Account to the State Land Department in order to meet*
 33 *the Land Department's financial obligation. In no event shall more than*
 34 *three million dollars (\$3,000,000) be transferred from the 88th Session*
 35 *Projects Account to the State Land Department due to the provisions of this*
 36 *section.*

1
2 SECTION 6. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
3 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING TRANSFER.
4 Immediately upon the effective date of this act, the Chief Fiscal Officer of
5 the State shall transfer on his or her books and those of the State Treasurer
6 and the Auditor of the State any remaining unobligated funds from the
7 Executive Division of the 87th Session Projects Account of the General
8 Improvement Fund in subsection (d) of Section 3 of Acts 1442 and 1443 of 2009
9 to provide funding in addition to that set out in subsection (b) of Section 3
10 of this Act, for the 88th Session Projects Account of the General Improvement
11 Fund for the Executive Division as set out in subsection (d) of Section 3
12 herein.

13
14 SECTION 7. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR
15 PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. DEPARTMENT OF
16 CORRECTIONS TRANSFER. If the Chief Fiscal Officer of the State determines
17 that the Department of Correction does not have sufficient funds available to
18 pay the accrued straight time and overtime owed, upon approval of the
19 Governor, the Chief Fiscal Officer of the State may transfer on his or her
20 books and those of the State Treasurer and Auditor of State, up to one
21 million three hundred eighty six thousand dollars (\$1,386,000), with sixty
22 percent (60%) of the total amount transferred coming from funds to be
23 distributed to the Executive Division and forty percent (40%) of the total
24 amount transferred coming from funds to be distributed to the Legislative
25 Division of the 88th Session Projects Account of the General Improvement
26 Fund, to the Department of Correction Inmate Care and Custody Fund Account to
27 be used solely for the payment of accrued straight time and overtime. In no
28 event shall more than a total of one million three hundred eighty six
29 thousand dollars (\$1,386,000) be transferred due to the provisions of this
30 section.

31
32 SECTION 8. DISBURSEMENT OF FUNDS. (a) Expenditure of the funds authorized
33 by the Eighty-Eighth General Assembly in either the regular, fiscal or
34 extraordinary session from the 88th Session Projects Account shall be made
35 only upon documentation to the Chief Fiscal Officer of the State, in such
36 form as deemed necessary, that all criteria or pre-conditions established in

1 the appropriation act have been met or in the case of state agencies, and
2 that a Method of Finance has been filed with the Office of Accounting in the
3 Department of Finance and Administration, if required.

4 (b) Any matching funds as may be provided in law shall be certified to the
5 Chief Fiscal Officer of the State prior to the commencement of the project.

6 (c) Any recipient of the funds appropriated herein:

7 (1) may be required to file a compliance audit and

8 (2) is also subject to an audit by the Division of Legislative Audit in
9 order to determine that the use of the funds was in compliance with the
10 intent and appropriated purposes of the General Assembly.

11
12 *SECTION 9.* (a) Any enactment of the 88th General Assembly in either
13 regular, fiscal or extraordinary session appropriating, transferring or
14 allocating funds to be payable from the "General Improvement Fund", for which
15 a specific allocation of funds is specifically authorized in this Act, shall
16 be deemed to be payable from the "88th Session Projects Account" within the
17 "General Improvement Fund" unless a specific intent is otherwise provided by
18 law.

19 (b) Any enactment of the 88th General Assembly, meeting in either Regular,
20 Fiscal or Extraordinary Session, appropriating, allocating or transferring
21 funds payable from the General Improvement Fund which is not enumerated in
22 this Act shall not be financed from monies accruing to the 88th Session
23 Projects Account, unless otherwise provided by law and funds are specifically
24 transferred from the 87th Session Projects Account to the 88th Session
25 Projects Account to fund the appropriation for the project

26 (c) Monies reappropriated by the 88th General Assembly for projects for
27 which appropriations were made by the 87th General Assembly, which are not
28 enumerated in this Act and which are made payable from the "General
29 Improvement Fund", shall be payable from the "87th Session Projects Account"
30 of the "General Improvement Fund" and allowances shall be made therefore in
31 arriving at the uncommitted and unobligated balance of monies in the "General
32 Improvement Fund" before making transfers there from to the "88th Session
33 Projects Account", as authorized by this Act.

34
35 *SECTION 10.* Distribution of funds for constructing and equipping the
36 radiation therapy institutes specified herein, shall be contingent upon the

1 provision of matching funds, including those monies previously raised but not
2 previously used to match state funds, on a dollar by dollar basis on behalf
3 of each such radiation therapy institute.
4

5 *SECTION 11.* Department of Finance and Administration Disbursing Officer.
6 The Chief Fiscal Officer of the State may distribute funds to the projects in
7 the Legislative Division enumerated under Department of Finance and
8 Administration - Disbursing Officer on a basis other than monthly after prior
9 review of the proposed calendar for disbursements by the Legislative Council.
10

11 *SECTION 12.* This Act shall not be incorporated into the Arkansas Code nor
12 published separately as Special, Local and Temporary law.
13

14 *SECTION 13. EMERGENCY CLAUSE.* It is found and determined by the General
15 Assembly that it has considered and enacted appropriations for construction
16 projects and other programs to be financed from the accumulated balances and
17 reserve funds available in the State Treasury; that the total of the enacted
18 appropriations exceed the estimated available funding available for such
19 projects and that the immediate passage of this Act is necessary to establish
20 a method of providing for the orderly financing and a system of priority for
21 the financing of such projects. Therefore, an emergency is declared to exist
22 and this act being immediately necessary for the preservation of the public
23 peace, health and safety shall become effective on July 1, 2011.
