25	SECTION 1. Arkansas Code § 20-77-911, concerning rewards paid to	
26	persons providing information regarding medicaid fraud, is amended to rea	ıd as

31	(a) The court is authorized to pay a person sums, not exceeding to	en

34	information the person may have provided which led to the detecting and	
35	bringing to trial and punishment persons guilty of violating the Medicaio	1

- (b) Upon disposition of any civil action relating to violations of this subchapter in which a penalty is recovered, the Attorney General may petition the court on behalf of a person who may have provided information which led to the detecting and bringing to trial and punishment persons guilty of Medicaid fraud to reward the person in an amount commensurate with the quality of information determined by the court to have been provided, in accordance with the requirements of this subchapter.
- 8 (c)(1) If the Attorney General elects not to petition the court on 9 behalf of the person, the person may petition the court on his or her own 10 behalf.
- 11 (2) Neither the state nor any defendant within the action shall 12 be liable for expenses which that a person incurs in bringing an action under 13 this section.
 - (d) Employees or fiscal agents charged with the duty of referring or investigating cases of Medicaid fraud who are employed by or who contract with any governmental entity shall not be eligible to receive a reward under this section.

- SECTION 2. Arkansas Code § 5-55-113, concerning rewards paid to persons providing information regarding medicaid fraud, is amended to read as follows:
- 22 5-55-113. Reward for the detection and punishment of medicaid fraud 23 information.
 - (a) The court may pay a person such sums, not exceeding ten percent (10%) of the aggregate penalty recovered, or in any case not more than one hundred thousand dollars (\$100,000), as the court may deem just, for information the person may have provided which led to detecting and bringing to trial and punishment a person guilty of violating the medicaid fraud laws.
 - (b)(1) Upon the disposition of any criminal action relating to a violation of this subchapter in which a penalty is recovered, the Attorney General may petition the court on behalf of a person who may have provided information that led to detecting and bringing to trial and punishment a person guilty of medicaid fraud to award the person in an amount commensurate with the quality and usefulness of the information determined by the court to have been provided, in accordance with the requirements of this subchapter.
 - (2) If the Attorney General elects not to petition the court on

1	behalf of the person, the person may petition the court on his or her own
2	behalf.
3	(c) Neither the state nor any defendant within the action is liable
4	for expenses that a person incurs in bringing an action under this section.
5	(d) An employee or fiscal agents charged with the duty of referring or
6	investigating a case of medicaid fraud who are employed by or contract with
7	any governmental entity are not eligible to receive a reward under this

10	SECTION 3. EMERGENCY CLAUSE.
11	It is found and determined by the General Assembly of the State of
12	Arkansas that the statutes authorizing procedures for the recovery of false
13	or fraudulent Medicaid claims are in immediate need of this revision to
14	encourage citizens of the state to help recover public funds and Medicaid
15	moneys that have been wrongfully misappropriated and will otherwise be lost
16	forever; and that the provisions of this act are essential to successful
17	operations and activities of the Medicaid Fraud Control Unit of the Attorney
18	General's office and the Department of Human Services. Therefore, an
19	emergency is declared to exist and this act being immediately necessary for
20	the preservation of the public peace, health, and safety shall become
21	<u>effective on:</u>
22	(1) The date of its approval by the Governor;
23	(2) If the bill is neither approved nor vetoed by the Governor,
24	the expiration of the period of time during which the Governor may veto the
25	bill; or
26	(3) If the bill is vetoed by the Governor and the veto is
27	overridden, the date the last house overrides the veto.
