## For An Act To Be Entitled

11 AN ACT TO HONOR VETERANS OF THE UNITED STATES ARMED  
12 FORCES BY ALLOWING VETERAN STATUS DESIGNATION ON  
13 ARKANSAS DRIVER'S LICENSES AND IDENTIFICATION CARDS;  
14 TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

### Subtitle

17 THE NICK BACON REMEMBRANCE ACT: TO ALLOW  
18 A VETERAN DESIGNATION ON DRIVER'S  
19 LICENSES AND IDENTIFICATION CARDS; TO  
20 DECLARE AN EMERGENCY.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 SECTION 1. NOT TO BE CODIFIED. This act shall be known and may be  
27 cited as the "Nick Bacon Remembrance Act".  
28

29 SECTION 2. Arkansas Code Title 27, Chapter 16, Subchapter 8 is amended  
30 to add an additional section to read as follows:

31 27-16-812. Veteran designation.

32 (a)(1) A person may apply to the Office of Driver Services to obtain a  
33 veteran designation on a driver's license or identification card issued under  
34 this subchapter by providing:

35 (A) A United States Department of Defense discharge  
36 document, otherwise known as a DD Form 214, that shows a discharge status of



1 "honorable" or "general under honorable conditions" that establishes the  
2 person's service in the armed forces of the United States; and

3 (B) Payment of the fee for the driver's license or  
4 identification card authorized under this chapter.

5 (2) If the person is seeking a duplicate or substitute driver's  
6 license with the veteran designation and his or her driver's license has not  
7 expired, the fee shall be as provided under § 27-16-806.

8 (b) The Office of Driver Services may:

9 (1) Determine the appropriate placement of the veteran  
10 designation on the driver's licenses and identification cards authorized  
11 under this section; and

12 (2) Promulgate the necessary rules for the administration of  
13 this section.

14  
15 SECTION 3. EMERGENCY CLAUSE. It is found and determined by the  
16 General Assembly of the State of Arkansas that a person's status as a veteran  
17 can easily be included on a driver's license; that this information can be  
18 helpful for the veteran to secure benefits more easily; that having this  
19 information on driver's licenses can be helpful to law enforcement,  
20 especially when the veteran has recently returned from combat, as many of our  
21 young veterans have; and that this act is immediately necessary because it  
22 will streamline administrative procedures for veterans and assist law  
23 enforcement. Therefore, an emergency is declared to exist and this act being  
24 immediately necessary for the preservation of the public peace, health, and  
25 safety shall become effective on July 1, 2011.
