13 JUNE 30, 2011; AND FOR OTHER PURPOSES.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. APPROPRIATION - HOUSE EXPENSES. There is hereby
26 appropriated, to the Arkansas House of Representatives, to be payable from
27 the Constitutional Officers Fund, for necessary expenses of the Arkansas
28 House of Representatives for the fiscal year ending June 30, 2011, the
29 following:

2 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
4 TRANSFERS. If the Speaker of the House and the ~~Coordinator of House~~
5 ~~Legislative Services~~ Chief of Staff or his designee determine that any item
6 or portion thereof appropriated herein for a specific purpose is not needed
7 for such purposes, they may certify such fact to the State Auditor, and the
8 State Auditor shall cause transfer to be made from one item to another.

9
10 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USES OF
12 APPROPRIATION. The funds appropriated in this Act shall be used to defray
13 the expenses of the House of Representatives of the Legislative Session of
14 the ~~Eighty-seventh~~ Eighty-eighth General Assembly, and upon adjournment of
15 the Legislative Session, any unexpended balance of the funds appropriated in
16 this Act may be used to defray the necessary expenses of the operation of the
17 Office of the Speaker of the House of Representatives, the Office of the
18 Chief of Staff, the Office of the Coordinator of House Legislative Services,
19 the Office of Parliamentarian, the Chief Clerk's Office, House Constituency
20 Services Office and other reasonable and necessary expenses of the House of
21 Representatives of the ~~Eighty-seventh~~ Eighty-eighth General Assembly incurred
22 during the interim between the adjournment of the Legislative Session of the
23 ~~Eighty-seventh~~ Eighty-eighth General Assembly and July 1, ~~2010~~ 2011.

24 Additionally, if it is determined by the Speaker of the House that the
25 presence, assistance, oversight and expertise of any House member is needed
26 in the interim between the legislative sessions, and if it is determined by
27 the Speaker of the House that certain expenses and per diem of members of the
28 House should be paid by the House, such expenses and per diem at the rate
29 authorized for attending legislative sessions shall be paid from the funds
30 appropriated herein for Maintenance, Operations and Expenses.

32 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARY
34 LEVELS. The Speaker of the House of Representatives and the ~~Coordinator of~~
35 ~~House Legislative Services~~ Chief of Staff or his designee shall, during the
36 month of June, each fiscal year, meet and determine the actual salaries to be

1 paid each employee beginning the following July 1. Such salaries of the
2 employees will be based upon an evaluation of the performance of the
3 ~~Coordinator of House Legislative Services~~ Chief of Staff by the Speaker of
4 the House of Representatives and upon an evaluation of the performance of the
5 other employees by the ~~Coordinator of House Legislative Services~~ Chief of
6 Staff or his designee. ~~The Parliamentarian of the House of Representatives~~
7 ~~may be paid a per diem up to such amount as is authorized for members of the~~
8 ~~General Assembly each day the General Assembly is in legislative session.~~
9 ~~The Coordinator of House Legislative Services and the Parliamentarian may be~~
10 ~~provided an expense allowance up to such amount as is authorized for~~
11 ~~reimbursable expenses for members of the General Assembly. Such per diem~~
12 ~~shall be paid from the appropriation provided in Section 1 of this Act. The~~
13 ~~expense allowance and associated personal services matching costs, if any,~~
14 ~~are to be paid from the appropriations for Personal Services provided in the~~
15 ~~appropriation act for personal services and operating expenses for the~~
16 ~~Arkansas House of Representatives for the fiscal year.~~

17
18 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
19 Assembly, that the House of Representatives of the 88th General Assembly
20 convenes in regular session on January 10, 2011; that expenses of the session
21 begin immediately; and that the expenses are a just expense of the state
22 which must be paid at the time the services are provided. Therefore, an
23 emergency is hereby declared to exist and this Act being necessary for the
24 immediate preservation of the public peace, health and safety shall be in
25 full force and effect from and after the date of its passage and approval.
26 If the bill is neither approved nor vetoed by the Governor, it shall become
27 effective on the expiration of the period of time during which the Governor
28 may veto the bill. If the bill is vetoed by the Governor and the veto is
29 overridden, it shall become effective on the date the last house overrides
30 the veto.
