16 ARKANSAS MUNICIPAL POLICE ASSOCIATION TO
17 DESIGNATE A REPRESENTATIVE TO THE
18 ARKANSAS COMMISSION ON LAW ENFORCEMENT
19 STANDARDS AND TRAINING.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code § 12-9-103(b) and (c), concerning the
26 membership of the Arkansas Commission on Law Enforcement Standards and
27 Training, are amended to read as follows:

28 (b)(1)(A) Two (2) members of the commission shall be chiefs of police
29 of municipalities in Arkansas, two (2) members of the commission shall be
30 county sheriffs of counties in this state, one (1) member shall be an officer
31 of the Department of Arkansas State Police, two (2) members shall be
32 appointed to represent the public, and one (1) member shall be an educator in
33 the field of criminal justice.

34 (B) Each congressional district of the state ~~must~~ shall be
35 represented on the commission, with the remaining members to be appointed
36 from the state at large.



1 (2)(A) One (1) member shall not be actively engaged in or
2 retired from law enforcement.

3 (B) The member under subdivision (b)(2)(A) of this section
4 shall be:

5 (i) Sixty (60) years of age and shall represent the
6 elderly;

7 (ii) Appointed from the state at large subject to
8 confirmation by the Senate; and

9 (iii) A full voting member.

10 (3) The person who is elected as president of the Arkansas
11 Municipal Police Association or his or her designee shall be a full voting
12 member of the commission ~~during his or her term of office as president of the~~
13 ~~association, and his or her successors shall likewise serve as full voting~~
14 ~~members of the commission.~~

15 (c) ~~Except for the president of the Arkansas Municipal Police~~
16 ~~Association, members~~ Members shall be appointed for terms of seven (7) years
17 or until their successors are appointed and qualified.
