9 SERVICES AND OPERATING EXPENSES FOR THE  
10 DEPARTMENT OF EDUCATION - ARKANSAS STATE LIBRARY  
11 FOR THE FISCAL YEAR ENDING JUNE 30, 2012; AND FOR  
12 OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE DEPARTMENT OF EDUCATION -  
16 ARKANSAS STATE LIBRARY APPROPRIATION FOR  
17 THE 2011-2012 FISCAL YEAR.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the  
24 Department of Education - Arkansas State Library for the 2011-2012 fiscal  
25 year, the following maximum number of regular employees.

17 SECTION 2. EXTRA HELP - STATE OPERATIONS. There is hereby authorized,  
 18 for the Department of Education - Arkansas State Library - State Operations  
 19 for the 2011-2012 fiscal year, the following maximum number of part-time or  
 20 temporary employees, to be known as "Extra Help", payable from funds  
 21 appropriated herein for such purposes: six (6) temporary or part-time  
 22 employees, when needed, at rates of pay not to exceed those provided in the  
 23 Uniform Classification and Compensation Act, or its successor, or this act  
 24 for the appropriate classification.

25

26 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby  
 27 appropriated, to the Department of Education - Arkansas State Library, to be  
 28 payable from the State Library Fund Account, for personal services and  
 29 operating expenses of the Department of Education - Arkansas State Library -  
 30 State Operations for the fiscal year ending June 30, 2012, the following:

 11 authorized, for the Department of Education - Arkansas State Library -  
 12 Federal Operations for the 2011-2012 fiscal year, the following maximum  
 13 number of part-time or temporary employees, to be known as "Extra Help",  
 14 payable from funds appropriated herein for such purposes: six (6) temporary  
 15 or part-time employees, when needed, at rates of pay not to exceed those  
 16 provided in the Uniform Classification and Compensation Act, or its  
 17 successor, or this act for the appropriate classification.

18

19 SECTION 5. APPROPRIATION - FEDERAL OPERATIONS. There is hereby  
 20 appropriated, to the Department of Education - Arkansas State Library, to be  
 21 payable from the federal funds as designated by the Chief Fiscal Officer of  
 22 the State, for personal services and operating expenses of the Department of  
 23 Education - Arkansas State Library - Federal Operations for the fiscal year  
 24 ending June 30, 2012, the following:

30 SECTION 8. APPROPRIATION - GRANTS ADMINISTRATION - CASH. There is  
 31 hereby appropriated, to the Department of Education - Arkansas State Library,  
 32 to be payable from the cash fund deposited in the State Treasury as  
 33 determined by the Chief Fiscal Officer of the State, for personal services  
 34 and operating expenses and for grants to libraries by the Department of  
 35 Education - Arkansas State Library - Grants Administration - Cash for the  
 36 fiscal year ending June 30, 2012, the following:

15 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY  
 17 FORWARD. At the close of the fiscal year ending June 30, ~~2010~~ 2012, any  
 18 unexpended balance of monies provided from the State Library Fund Account for  
 19 Books and Subscriptions, as provided in Section 3 of this Act, shall be  
 20 transferred forward and made available for the same purpose for the fiscal  
 21 year ending June 30, ~~2011~~ 2013.

22 Any carry forward of unexpended balance of funding as authorized  
 23 herein, may be carried forward under the following conditions:

24 (1) Prior to June 30, ~~2010~~ 2012 the Agency shall by written  
 25 statement set forth its reason(s) for the need to carry forward said funding  
 26 to the Department of Finance and Administration Office of Budget;

27 (2) The Department of Finance and Administration Office of  
 28 Budget shall report to the Arkansas Legislative Council all amounts carried  
 29 forward by the September Arkansas Legislative Council or Joint Budget  
 30 Committee meeting which report shall include the name of the Agency, Board,  
 31 Commission or Institution and the amount of the funding carried forward, the  
 32 program name or line item, the funding source of that appropriation and a  
 33 copy of the written request set forth in (1) above;

34 (3) Each Agency, Board, Commission or Institution shall provide  
 35 a written report to the Arkansas Legislative Council or Joint Budget  
 36 Committee containing all information set forth in item (2) above, along with

1 a written statement as to the current status of the project, contract,  
2 purpose etc. for which the carry forward was originally requested no later  
3 than thirty (30) days prior to the time the Agency, Board, Commission or  
4 Institution presents its budget request to the Arkansas Legislative  
5 Council/Joint Budget Committee; and

6 (4) Thereupon, the Department of Finance and Administration  
7 shall include all information obtained in item (3) above in the budget  
8 manuals and/or a statement of non-compliance by the Agency, Board, Commission  
9 or Institution.

10  
11 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
12 authorized by this act shall be limited to the appropriation for such agency  
13 and funds made available by law for the support of such appropriations; and  
14 the restrictions of the State Procurement Law, the General Accounting and  
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
16 Procedures and Restrictions Act, or their successors, and other fiscal  
17 control laws of this State, where applicable, and regulations promulgated by  
18 the Department of Finance and Administration, as authorized by law, shall be  
19 strictly complied with in disbursement of said funds.

20  
21 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General  
22 Assembly that any funds disbursed under the authority of the appropriations  
23 contained in this act shall be in compliance with the stated reasons for  
24 which this act was adopted, as evidenced by the Agency Requests, Executive  
25 Recommendations and Legislative Recommendations contained in the budget  
26 manuals prepared by the Department of Finance and Administration, letters, or  
27 summarized oral testimony in the official minutes of the Arkansas Legislative  
28 Council or Joint Budget Committee which relate to its passage and adoption.

29  
30 SECTION 12. EMERGENCY CLAUSE. It is found and determined by the  
31 General Assembly, that the Constitution of the State of Arkansas prohibits  
32 the appropriation of funds for more than a one (1) year period; that the  
33 effectiveness of this Act on July 1, 2011 is essential to the operation of  
34 the agency for which the appropriations in this Act are provided, and that in  
35 the event of an extension of the legislative session, the delay in the  
36 effective date of this Act beyond July 1, 2011 could work irreparable harm

1 upon the proper administration and provision of essential governmental  
2 programs. Therefore, an emergency is hereby declared to exist and this Act  
3 being necessary for the immediate preservation of the public peace, health  
4 and safety shall be in full force and effect from and after July 1, 2011.
