21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. APPROPRIATION - EMERGENCY MEDICAL. There is hereby
24 appropriated, to the Office of the Treasurer of State, to be payable from the
25 Arkansas Citizens First Responder Safety Enhancement Fund, for personal
26 services, operating expenses and other expenses for the Arkansas Ambulance
27 Association under the provisions of Arkansas Code 19-6-802, for the fiscal
28 year ending June 30, 2012, the following:

34 SECTION 2. APPROPRIATION - LOCAL LAW ENFORCEMENT. There is hereby
35 appropriated, to the Office of the Treasurer of State, to be payable from the
36 Arkansas Citizens First Responder Safety Enhancement Fund, for personal



1 services, operating expenses and other expenses for the Arkansas Association
 2 of Chiefs of Police under the provisions of Arkansas Code 19-6-802, for the
 3 fiscal year ending June 30, 2012, the following:

13 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 14 authorized by this act shall be limited to the appropriation for such agency
 15 and funds made available by law for the support of such appropriations; and
 16 the restrictions of the State Procurement Law, the General Accounting and
 17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 18 Procedures and Restrictions Act, or their successors, and other fiscal
 19 control laws of this State, where applicable, and regulations promulgated by
 20 the Department of Finance and Administration, as authorized by law, shall be
 21 strictly complied with in disbursement of said funds.

22 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
 23 Assembly that any funds disbursed under the authority of the appropriations
 24 contained in this act shall be in compliance with the stated reasons for
 25 which this act was adopted, as evidenced by the Agency Requests, Executive
 26 Recommendations and Legislative Recommendations contained in the budget
 27 manuals prepared by the Department of Finance and Administration, letters, or
 28 summarized oral testimony in the official minutes of the Arkansas Legislative
 29 Council or Joint Budget Committee which relate to its passage and adoption.

30 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
 31 Assembly, that the Constitution of the State of Arkansas prohibits the
 32 appropriation of funds for more than a one (1) year period; that the
 33 effectiveness of this Act on July 1, 2011 is essential to the operation of
 34 the agency for which the appropriations in this Act are provided, and that in
 35 the event of an extension of the legislative session, the delay in the
 36 effective date of this Act beyond July 1, 2011 could work irreparable harm
upon the proper administration and provision of essential governmental
programs. Therefore, an emergency is hereby declared to exist and this Act

1 being necessary for the immediate preservation of the public peace, health
2 and safety shall be in full force and effect from and after July 1, 2011.
