21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. REGULAR SALARIES - HOUSE STAFF. There is hereby established
24 for the Arkansas House of Representatives for the 2011-2012 fiscal year, the
25 following maximum number of regular employees.

9 SECTION 2. EXTRA HELP. There is hereby authorized, for the Arkansas
 10 House of Representatives for the 2011-2012 fiscal year, the following maximum
 11 number of part-time or temporary employees, to be known as "Extra Help",
 12 payable from funds appropriated herein for such purposes: seven (7)
 13 temporary or part-time employees, when needed, at rates of pay not to exceed
 14 those provided in the Uniform Classification and Compensation Act, or its
 15 successor, or this act for the appropriate classification.

17 SECTION 3. APPROPRIATION - STAFF. There is hereby appropriated, to the
 18 Arkansas House of Representatives, to be payable from the State Central
 19 Services Fund, for personal services and operating expenses of the Arkansas
 20 House of Representatives and the staff of the Arkansas House of
 21 Representatives for the fiscal year ending June 30, 2012, the following:

SECTION 4. APPROPRIATION - INSTITUTE. There is hereby appropriated, to the Arkansas House of Representatives, to be payable from the Constitutional Officers Fund, for payment of per diem and mileage of members and newly elected members who attend the Institute of Legislative Procedure, House Legislative Orientation, and any other briefing meetings held prior to the convening of a Legislative Session of the General Assembly, the sum of\$200,000.

SECTION 5. APPROPRIATION - COMPUTERIZATION. There is hereby appropriated, to the Arkansas House of Representatives, to be payable from the State Central Services Fund, for expenses required in continuing the automation of the legislative process of the Arkansas House of Representatives for the fiscal year ending June 30, 2012, the sum of\$500,000.

SECTION 6. REGULAR SALARIES - MEMBER SERVICES. There is hereby established for the Arkansas House of Representatives - Member Services for the 2011-2012 fiscal year, the following maximum number of regular employees.

21 SECTION 11. APPROPRIATION - REAPPROPRIATION - CONSTITUTIONAL OFFICERS
 22 FUND. There is hereby appropriated, to the Arkansas House of Representatives,
 23 to be payable from the Constitutional Officers Fund, for the balance
 24 remaining on June 30, 2011 in the appropriations enacted to defray the
 25 necessary expenses of the House of Representatives of the Eighty-Eighth
 26 General Assembly, Section 2 of Act 1 of 2010, Sections 4 and 11 of Act 225 of
 27 2010 and Act 2 of 2011, there to be used for the same purposes for the
 28 Arkansas House of Representatives of the Eighty-Eighth General Assembly, in a
 29 sum in the aggregate not to exceed.....\$3,294,723.

30

31 SECTION 12. APPROPRIATION - REAPPROPRIATION - STATE CENTRAL SERVICES
 32 FUND. There is hereby appropriated, to the Arkansas House of Representatives,
 33 to be payable from the State Central Services Fund, for the balance remaining
 34 on June 30, 2011 in the appropriations enacted to defray the necessary
 35 expenses of the House of Representatives of the Eighty-Eighth General
 36 Assembly, Sections 3, 5, 7, 9, 10, and 12 of Act 225 of 2010, there to be

1 used for the same purposes for the Arkansas House of Representatives of the
 2 Eighty-Eighth General Assembly, in a sum in the aggregate not to
 3 exceed.....\$3,000,000.
 4

5 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USES OF
 7 FUNDS. The funds appropriated in this Act shall be used to defray the
 8 necessary expenses of the operation of the Office of the Speaker of the House
 9 of Representatives, the Office of the Chief of Staff, the Office of the
 10 Coordinator of House Legislative Services, the Office of Parliamentarian, the
 11 Chief Clerk's Office, House ~~Constituency~~ Member Services Office and other
 12 reasonable and necessary expenses of the House of Representatives of the
 13 General Assembly incurred during the fiscal year ending June 30, ~~2011~~ 2012.
 14 Any balance remaining on June 30, ~~2010~~ 2011 in the funds provided by this Act
 15 shall be made available for the fiscal year ending June 30, ~~2011~~ 2012 and for
 16 the same purposes.
 17

18 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 20 AUTHORITY. If the Speaker of the House and the ~~Coordinator of House~~
 21 ~~Legislative Services~~ Chief of Staff or his designee determine that any item
 22 or portion thereof appropriated herein for a specific purpose is not needed
 23 for such purpose, they may certify such fact to the State Auditor and the
 24 State Auditor shall cause a transfer to be made from one item to another.
 25

26 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARIES.
 28 In order that exceptionally well-qualified personnel may be recruited and
 29 retained, the House of Representatives may exceed the maximum salary levels
 30 by no more than twenty percent (20%) for no more than one-third (1/3) of the
 31 positions authorized in their operation appropriation act, may exceed the
 32 maximum salary levels for the purpose of merit adjustments for all positions,
 33 and may promote a maximum of two grades for no more than one-third (1/3) of
 34 the classified positions authorized in its operation appropriation act.
 35

36 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
2 AUDIO/VISUAL POLICY. The appropriations provided herein to produce audio or
3 video materials by or under the direction of the House of Representatives
4 shall not be used for the following:

5 (a) A person may not use audio or video materials produced by or under
6 the direction of the House of Representatives in political or
7 campaign advertising.

8 (b) A person may not use audio or video materials produced by or under
9 the direction of the House of Representatives for a commercial
10 purpose.

11 (1) In this section, "commercial purpose" means a purpose that
12 is intended to result in a profit or other tangible
13 benefit.

14 (c) The House Management Committee may give permission to an entity
15 to use the audio or video materials for public education
16 governmental broadcast which shall not conflict with subsection
17 (b).

18
19 SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
20 authorized by this act shall be limited to the appropriation for such agency
21 and funds made available by law for the support of such appropriations; and
22 the restrictions of the State Procurement Law, the General Accounting and
23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
24 Procedures and Restrictions Act, or their successors, and other fiscal
25 control laws of this State, where applicable, and regulations promulgated by
26 the Department of Finance and Administration, as authorized by law, shall be
27 strictly complied with in disbursement of said funds.

28
29 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General
30 Assembly that any funds disbursed under the authority of the appropriations
31 contained in this act shall be in compliance with the stated reasons for
32 which this act was adopted, as evidenced by the Agency Requests, Executive
33 Recommendations and Legislative Recommendations contained in the budget
34 manuals prepared by the Department of Finance and Administration, letters, or
35 summarized oral testimony in the official minutes of the Arkansas Legislative
36 Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 19. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2011 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2011 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2011.
