22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES. There is hereby established for the
25 Department of Finance and Administration - Division of Racing for the 2011-
26 2012 fiscal year, the following maximum number of regular employees.

6 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department
7 of Finance and Administration - Division of Racing for the 2011-2012 fiscal
8 year, the following maximum number of part-time or temporary employees, to be
9 known as "Extra Help", payable from funds appropriated herein for such
10 purposes: twenty-seven (27) temporary or part-time employees, when needed,
11 at rates of pay not to exceed those provided in the Uniform Classification
12 and Compensation Act, or its successor, or this act for the appropriate
13 classification.

15 SECTION 3. APPROPRIATION. There is hereby appropriated, to the
16 Department of Finance and Administration - Division of Racing, to be payable
17 from the Miscellaneous Agencies Fund Account, for personal services and
18 operating expenses of the Department of Finance and Administration - Division
19 of Racing for the fiscal year ending June 30, 2012, the following:

36 Department of Finance and Administration - Division of Racing, to be payable

1 from the cash fund deposited in the State Treasury as determined by the Chief
 2 Fiscal Officer of the State, for operating expenses associated with license
 3 applications for employees at Oaklawn and Southland Parks of the Department
 4 of Finance and Administration - Division of Racing for the fiscal year ending
 5 June 30, 2012, the following:

 18 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 20 HELP - DOG RACING. There is hereby authorized, for the Department of Finance
 21 and Administration - Division of Racing - Dog Racing, for the ~~2010-2011~~ 2011-
 22 2012 fiscal year, the maximum number of five (5) part-time or temporary
 23 employees, to be known as "Extra Help", payable from funds appropriated
 24 herein for such purposes, such employees shall be authorized to work over
 25 1,000 hours per year.

26 The provisions of this section shall be in effect only from July 1,
 27 ~~2010~~ 2011 through June 30, ~~2011~~ 2012.

 29 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RACING
 31 PASS RESTRICTIONS. The Director of the Department of Finance and
 32 Administration shall set a maximum number of racing passes to be printed and
 33 issued annually and it shall not be less than the number printed in 1990.

34 The provisions of this section shall be in effect only from July 1, ~~2010~~
 35 2011 through June 30, ~~2011~~ 2012.

SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA HELP - HORSE RACING. There is hereby authorized, for the Department of Finance and Administration - Division of Racing - Horse Racing, for the ~~2010-~~ 2011-2012 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes, such employees shall be authorized to work over 1,000 hours per year:

The provisions of this section shall be in effect only from July 1, ~~2010~~ 2011 through June 30, ~~2011~~ 2012.

SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

1 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this act shall be in compliance with the stated reasons for
4 which this act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.

9
10 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
11 General Assembly, that the Constitution of the State of Arkansas prohibits
12 the appropriation of funds for more than a one (1) year period; that the
13 effectiveness of this Act on July 1, 2011 is essential to the operation of
14 the agency for which the appropriations in this Act are provided, and that in
15 the event of an extension of the legislative session, the delay in the
16 effective date of this Act beyond July 1, 2011 could work irreparable harm
17 upon the proper administration and provision of essential governmental
18 programs. Therefore, an emergency is hereby declared to exist and this Act
19 being necessary for the immediate preservation of the public peace, health
20 and safety shall be in full force and effect from and after July 1, 2011.
