23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
26 appropriated, to the Department of Community Correction, to be payable from
27 the Department of Community Correction Fund Account, for operating expenses
28 of the Department of Community Correction which shall be supplemental and in
29 addition to those funds appropriated in Section 3 of Act 1105 of 2011, the

SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal Officer of the State shall transfer on his or her books and those of the State Treasurer and the Auditor of the State the sum of one million nine hundred ten thousand four hundred seventy-eight dollars (\$1,910,478) from the unobligated funds in the General Improvement Fund to the Department of Community Correction Fund Account to provide funds for the operating expenses of the Department of Community Correction - State Operations for evidence based practices, reduction of caseload assignments and support for drug courts.

SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. The funds transferred under the provisions of Section 2 of this Act shall be carried forward and made available for the same purpose for the fiscal year ending June 30, 2013.

SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for

1 which this act was adopted, as evidenced by the Agency Requests, Executive
2 Recommendations and Legislative Recommendations contained in the budget
3 manuals prepared by the Department of Finance and Administration, letters, or
4 summarized oral testimony in the official minutes of the Arkansas Legislative
5 Council or Joint Budget Committee which relate to its passage and adoption.

7 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General
8 Assembly, that funds provided by the General Assembly for the operations of
9 the Department of Community Correction are, due to unforeseen circumstances,
10 insufficient for the Department of Community Correction to continue to
11 provide essential governmental services; that the provisions of this act will
12 provide the necessary monies for the Department of Community Correction to
13 continue such services; and that a delay in the effective date of this Act
14 could work irreparable harm upon the proper administration and provision of
15 essential governmental programs. Therefore, an emergency is hereby declared
16 to exist and this Act being necessary for the immediate preservation of the
17 public peace, health and safety shall be in full force and effect from and
18 after the date of its passage and approval.

19 If the bill is neither approved nor vetoed by the Governor, it shall
20 become effective on the expiration of the period of time during which the
21 Governor may veto the bill. If the bill is vetoed by the Governor and the
22 veto is overridden, it shall become effective on the date the last house
23 overrides the veto.
