15 ARKANSAS VIDEO SERVICE ACT APPROPRIATION
16 FOR THE 2012-2013 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATION - ARKANSAS VIDEO SERVICE ACT. There is hereby
23 appropriated, to the Secretary of State, to be payable from the Arkansas
24 Video Service Fund, for the review and issue of certificates of franchise
25 authority of the Arkansas Video Service Act for the fiscal year ending June
26 30, 2013, the sum of.....\$50,000.

28 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
29 authorized by this act shall be limited to the appropriation for such agency
30 and funds made available by law for the support of such appropriations; and
31 the restrictions of the State Procurement Law, the General Accounting and
32 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
33 Procedures and Restrictions Act, or their successors, and other fiscal
34 control laws of this State, where applicable, and regulations promulgated by
35 the Department of Finance and Administration, as authorized by law, shall be
36 strictly complied with in disbursement of said funds.

2 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
3 Assembly that any funds disbursed under the authority of the appropriations
4 contained in this act shall be in compliance with the stated reasons for
5 which this act was adopted, as evidenced by the Agency Requests, Executive
6 Recommendations and Legislative Recommendations contained in the budget
7 manuals prepared by the Department of Finance and Administration, letters, or
8 summarized oral testimony in the official minutes of the Arkansas Legislative
9 Council or Joint Budget Committee which relate to its passage and adoption.
10

11 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
12 Assembly, that the Constitution of the State of Arkansas prohibits the
13 appropriation of funds for more than a one (1) year period; that the
14 effectiveness of this Act on the date of its passage and approval is
15 essential to the operation of the agency for which the appropriations in this
16 Act are provided, and that in the event of an extension of the legislative
17 session, the delay in the effective date of this Act beyond the date of its
18 passage and approval could work irreparable harm upon the proper
19 administration and provision of essential governmental programs. Therefore,
20 an emergency is hereby declared to exist and this Act being necessary for the
21 immediate preservation of the public peace, health and safety shall be in
22 full force and effect from and after the date of its passage and approval.
