20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Arkansas Crime Information Center for the 2013-2014 fiscal year, the
24 following maximum number of regular employees.

4 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USE OF
 6 CONTINGENCY APPROPRIATION AND FUNDING. In the event additional appropriation
 7 becomes necessary that is not authorized or contemplated in Section 2 of this
 8 Act and circumstances make it necessary for the Arkansas Crime Information
 9 Center to request additional appropriation to carry out the objectives of the
 10 Agency, the Contingency Appropriation authorized herein may be used for
 11 regular salaries, personal services matching and maintenance and general
 12 operation line item appropriations authorized for such programs in this Act.
 13 Funding for the Contingency Appropriation authorized herein may be
 14 transferred to the appropriate fund or fund account from such excess funds as
 15 the Director of the Arkansas Crime Information Center may determine are
 16 available from criminal background check fees deposited on behalf of the
 17 Arkansas Crime Information Center. Use of the contingency appropriation and
 18 funding authorized in this Act shall be approved by the Chief Fiscal Officer
 19 of the State and the Arkansas Legislative Council or Joint Budget Committee.

20 Determining the maximum number of employees and the maximum amount of
 21 appropriation and general revenue funding for a state agency each fiscal year
 22 is the prerogative of the General Assembly. This is usually accomplished by
 23 delineating such maximums in the appropriation act(s) for a state agency and
 24 the general revenue allocations authorized for each fund and fund account by
 25 amendment to the Revenue Stabilization law. Further, the General Assembly
 26 has determined that the Arkansas Crime Information Center may operate more
 27 efficiently if some flexibility is provided to the Arkansas Crime Information
 28 Center authorizing broad powers under this Section. Therefore, it is both
 29 necessary and appropriate that the General Assembly maintain oversight by
 30 requiring prior approval of the Legislative Council or Joint Budget Committee
 31 as provided by this section. The requirement of approval by the Legislative
 32 Council or Joint Budget Committee is not a severable part of this section.
 33 If the requirement of approval by the Legislative Council or Joint Budget
 34 Committee is ruled unconstitutional by a court of competent jurisdiction,
 35 this entire section is void.

36

1 SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 2 authorized by this act shall be limited to the appropriation for such agency
 3 and funds made available by law for the support of such appropriations; and
 4 the restrictions of the State Procurement Law, the General Accounting and
 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 6 Procedures and Restrictions Act, or their successors, and other fiscal
 7 control laws of this State, where applicable, and regulations promulgated by
 8 the Department of Finance and Administration, as authorized by law, shall be
 9 strictly complied with in disbursement of said funds.

10
 11 SECTION 12. LEGISLATIVE INTENT. It is the intent of the General
 12 Assembly that any funds disbursed under the authority of the appropriations
 13 contained in this act shall be in compliance with the stated reasons for
 14 which this act was adopted, as evidenced by the Agency Requests, Executive
 15 Recommendations and Legislative Recommendations contained in the budget
 16 manuals prepared by the Department of Finance and Administration, letters, or
 17 summarized oral testimony in the official minutes of the Arkansas Legislative
 18 Council or Joint Budget Committee which relate to its passage and adoption.

19
 20 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the
 21 General Assembly, that the Constitution of the State of Arkansas prohibits
 22 the appropriation of funds for more than a one (1) year period; that the
 23 effectiveness of this Act on July 1, 2013 is essential to the operation of
 24 the agency for which the appropriations in this Act are provided, and that in
 25 the event of an extension of the legislative session, the delay in the
 26 effective date of this Act beyond July 1, 2013 could work irreparable harm
 27 upon the proper administration and provision of essential governmental
 28 programs. Therefore, an emergency is hereby declared to exist and this Act
 29 being necessary for the immediate preservation of the public peace, health
 30 and safety shall be in full force and effect from and after July 1, 2013.
