19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is
22 amended to add a new section to read as follows:

23 27-24-1411. Pancreatic Cancer Awareness.

24 (a) The Director of the Department of Finance and Administration shall
25 issue a special license plate for Pancreatic Cancer Awareness in the manner
26 and subject to the conditions provided for under this subchapter.

27 (b) The special Pancreatic Cancer Awareness motor vehicle license
28 plate shall be:

29 (1)(A) Designed by pancreatic cancer advocates in the state.

30 (B) The design shall be submitted for design approval by
31 the director under rules promulgated by the director; and

32 (2) Numbered consecutively.

33 (c) The procedures concerning costs for issuance under § 27-24-
34 1404(c)(1)(A) shall apply.

35 (d) The Department of Finance and Administration shall issue a special
36 license plate under this section upon payment of:



1 (1) The fee required by law for registration of the motor
2 vehicle;

3 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use
4 contribution.

5 (B) The design-use contribution shall be remitted monthly
6 to the Pancreatic Cancer Action Network; and

7 (3)(A) A handling and administrative fee of ten dollars
8 (\$10.00).

9 (B) The handling and administrative fee shall be:

10 (i) Deposited into the State Central Services Fund
11 for the benefit of the Revenue Division of the Department of Finance and
12 Administration; and

13 (ii) Credited to the division as supplemental and in
14 addition to all other funds that may be deposited for the benefit of the
15 division.

16 (C) The handling and administrative fee shall not be
17 considered or credited to the division as direct revenue.

18 (e)(1) A special license plate issued under this section may be
19 renewed annually or replaced under the procedures set out in § 27-24-1405.

20 (2) However, the division shall remit the fees collected under §
21 27-24-1405(b)(2) on a monthly basis to the fund.

23 SECTION 2. EFFECTIVE DATE. This act shall be effective on and after
24 January 1, 2014.
