3 BEHAVIORAL HEALTH SERVICES - ALLOCATION RESTRICTION AND TRANSFER PROVISION.  
4 Of the amounts allocated in the BEHAVIORAL HEALTH SERVICES - ALLOCATION

27 appropriated for State Assistance in the Behavioral Health Services -  
28 Community Mental Health Centers appropriation in this Act, and as a condition

30 (1) Meet minimum standards of performance in the delivery of Mental Health

12 Every community support program shall use a coordinated case management  
13 system and shall provide or assure access to services for persons with long-  
14 term, severe mental illness who reside within the respective catchment area  
15 of the Center. At a minimum, each community support program shall provide  
16 assessment, diagnosis, identification of persons in need of services, case  
17 management, crisis intervention, psychiatric treatment including medication

 12 such staff will come from the receipt of professional income in the care of  
 13 patients and/or funds received from federal agencies, foundations and other  
 14 private sponsors in the support of research. Provided that any such allowance  
 15 shall not exceed, for any employee, an amount equal to two and one half times

32 BEHAVIORAL HEALTH SERVICES - VOCATIONAL TRAINEES. The Division of Behavioral

 35 separate from the currently authorized regular vocational trainee positions.  
 36 The positions authorized herein shall not be incorporated into the present

14 individual. This will allow the Division to offer weekend option shifts to  
15 nursing personnel without increasing the number of positions.

21 BEHAVIORAL HEALTH SERVICES - STATE HOSPITAL CONTINGENCY POSITIONS. If the  
22 Department of Human Services determines, and after prior review by the  
23 Legislative Council, it shall be determined that it is in the best interest  
24 of the State of Arkansas to discontinue a management contract with a private  
25 provider and it is deemed necessary to utilize Department staff to provide  
26 the required services, the Director of the Department of Human Services may

8 HEALTH CENTER. (A) The Department of Human Services shall not close the  
9 Arkansas Health Center that provides skilled nursing through specialized  
10 services and programs.

11 (B) The Department of Human Services shall continue to accept clients for  
12 whom it has determined that skilled nursing and specialized services are  
13 needed at the Arkansas Health Center.

17 indigent patients which the Community Mental Health Center has determined to  
18 be necessary after prompt screening by the Community Mental Health Center.  
19 Payment for patients screened and approved by the Community Mental Health  
20 Center who receive care at these inpatient facilities shall be provided to  
21 the inpatient facilities at the contract rate unless the funds available for  
22 this purpose have been exhausted. Available funding as determined by the  
23 Director of the Department of Human Services shall be apportioned on a per

29 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ACUTE  
31 MENTAL HEALTH SERVICES – PER CAPITA - LEGISLATIVE FINDINGS AND INTENT. The  
32 General Assembly recognizes that the state encouraged the treatment of  
33 mentally ill residents within community-based settings over two decades ago  
34 and has taken various approaches to funding since then. The General Assembly  
35 also recognizes that there are inherent problems within the current public  
36 mental health system that create disincentives for proper treatment and care.

1 The purpose of the Acute Mental Health Services – Per Capita appropriation is  
2 to provide an appropriation for acute mental health services to be utilized  
3 within community-based settings for the treatment and care of medically  
4 indigent persons 18 years of age and older and involuntary commitments to the  
5 public mental health system. The appropriation for acute mental health  
6 services provided in this Act shall only be used for Community Mental Health  
7 Centers licensed and certified by the Division of Behavioral Health of the  
8 Department of Human Services for use within community-based settings and  
9 facilities.

11 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

14 IMPROVEMENTS AND EQUIPMENT. The Division of Behavioral Health Services is  
15 authorized to use administrative operating account for capital improvements  
16 to the physical plant, and for the purchase of capital equipment, and for the  
17 operation of the Arkansas Health Center, operated by the Department of Human  
18 Services, Division of Behavioral Health Services. The funds shall be held by  
19 the Department of Human Services, Division of Behavioral Health Services,  
20 from the proceeds of the sale of timber and hay that may be harvested from  
21 land owned by the Division of Behavioral Health Services. All funds deposited  
22 and all expenses shall be tracked separately. The harvesting of timber and

 2 MENTAL HEALTH SERVICES EMERGENCY RESERVE FUND. Of the total amount  
 3 appropriated for Acute Mental Health Services - Per Capita, two hundred fifty  
 4 thousand dollars (\$250,000) for the fiscal year ending June 30, ~~2013~~ 2014  
 5 shall first be allocated and made available to the Little Rock Community  
 6 Mental Health Center for Acute Mental Health Services. The remaining balance  
 7 appropriated for the fiscal year shall be allocated and made available to the  
 8 community mental health centers within community-based settings on a per-  
 9 capita basis.

 11 *SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*

 13 *RATES OF PAY AND EMPLOYMENT WORK DAYS. For employees hired on or after July*  
 14 *1, 2013, at the Arkansas State Hospital in the classifications listed below,*  
 15 *the Division of Behavioral Health Director shall implement salary adjustments*  
 16 *utilizing the approved pay grid for teachers employed by the Arkansas Schools*  
 17 *for the Blind and Deaf.*

18 *To achieve the salary adjustments, the Division of Behavioral Health is*  
 19 *authorized to pay special rates of pay for classifications at the Arkansas*  
 20 *State Hospital listed below:*

 28 *of the State. The Division of Behavioral Health shall in addition to the*

8 classifications listed above as of June 30, 2013, have the one-time option of  
9 adopting this language or continuing to operate under the same salary, leave  
10 and benefit plans they are currently receiving. Employees must make their  
11 decision by June 30, 2013.

12 Accrued annual and holiday leave, up to 240 hours, as of June 30,  
13 2013, will be paid out to current employees choosing to adopt this plan. Any  
14 additional accrued annual and holiday leave will be forfeited. Accrued sick  
15 leave, as of June 30, 2013, shall be retained on file and shall be exhausted  
16 before any newly accrued sick leave may be taken.

17 All employees affected by this section shall be eligible to receive  
18 hazardous duty pay for time worked in eligible areas.

19 The provisions of this section shall be in effect only from July 1,  
20 2013 through June 30, 2014.

21  
22 SECTION 30. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
23 authorized by this act shall be limited to the appropriation for such agency  
24 and funds made available by law for the support of such appropriations; and  
25 the restrictions of the State Procurement Law, the General Accounting and  
26 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
27 Procedures and Restrictions Act, or their successors, and other fiscal  
28 control laws of this State, where applicable, and regulations promulgated by  
29 the Department of Finance and Administration, as authorized by law, shall be  
30 strictly complied with in disbursement of said funds.

31  
32 SECTION 31. LEGISLATIVE INTENT. It is the intent of the General  
33 Assembly that any funds disbursed under the authority of the appropriations  
34 contained in this act shall be in compliance with the stated reasons for  
35 which this act was adopted, as evidenced by the Agency Requests, Executive  
36 Recommendations and Legislative Recommendations contained in the budget

1 manuals prepared by the Department of Finance and Administration, letters, or  
2 summarized oral testimony in the official minutes of the Arkansas Legislative  
3 Council or Joint Budget Committee which relate to its passage and adoption.  
4

5 SECTION 32. EMERGENCY CLAUSE. It is found and determined by the  
6 General Assembly, that the Constitution of the State of Arkansas prohibits  
7 the appropriation of funds for more than a one (1) year period; that the  
8 effectiveness of this Act on July 1, 2013 is essential to the operation of  
9 the agency for which the appropriations in this Act are provided, and that in  
10 the event of an extension of the legislative session, the delay in the  
11 effective date of this Act beyond July 1, 2013 could work irreparable harm  
12 upon the proper administration and provision of essential governmental  
13 programs. Therefore, an emergency is hereby declared to exist and this Act  
14 being necessary for the immediate preservation of the public peace, health  
15 and safety shall be in full force and effect from and after July 1, 2013.
