16 AFFAIRS APPROPRIATION FOR THE 2013-2014

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Department of Veterans' Affairs for the 2013-2014 fiscal year, the following
24 maximum number of regular employees.

15 SECTION 3. EXTRA HELP - VETERANS' HOME - FAYETTEVILLE. There is hereby
 16 authorized, for the Department of Veterans' Affairs - Veterans' Home -
 17 Fayetteville for the 2013-2014 fiscal year, the following maximum number of
 18 part-time or temporary employees, to be known as "Extra Help", payable from
 19 funds appropriated herein for such purposes: seven (7) temporary or part-
 20 time employees, when needed, at rates of pay not to exceed those provided in
 21 the Uniform Classification and Compensation Act, or its successor, or this
 22 act for the appropriate classification.

24 SECTION 4. APPROPRIATION - VETERANS' HOME - FAYETTEVILLE. There is
 25 hereby appropriated, to the Department of Veterans' Affairs, to be payable

1 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRAINING
3 CONFERENCES. The funds appropriated herein for Aid to County Veterans'
4 Service Offices may also be used by the Department of Veterans' Affairs to
5 pay expenses of County Veterans' Service Officers for attending regional or
6 statewide training conferences approved by the Department of Veterans'
7 Affairs and designed to provide better trained and qualified Veterans'
8 Service Officers in the various counties. Any such expenses paid by the
9 Department of Veterans' Affairs from funds appropriated herein shall be on
10 the same reimbursement basis as the reimbursement of state employees for
11 expenses incurred in attending their official business. Provided, no County
12 Veterans' Service Officer shall be entitled to receive reimbursement for
13 expenses incurred in attending more than two (2) approved conferences per
14 year.

15 The provisions of this section shall be in effect only from July 1, ~~2012~~
16 2013 through June 30, ~~2013~~ 2014.

17
18 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
20 LIABILITY INSURANCE APPROPRIATION RESTRICTION. In no event shall the
21 Department of Veterans' Affairs expend or transfer any appropriation or funds
22 for the purchase of malpractice liability insurance for the benefit of a non-
23 governmental entity.

24 The provisions of this section shall be in effect only from July 1, ~~2012~~
25 2013 through June 30, ~~2013~~ 2014.

26
27 SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
28 authorized by this act shall be limited to the appropriation for such agency
29 and funds made available by law for the support of such appropriations; and
30 the restrictions of the State Procurement Law, the General Accounting and
31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
32 Procedures and Restrictions Act, or their successors, and other fiscal
33 control laws of this State, where applicable, and regulations promulgated by
34 the Department of Finance and Administration, as authorized by law, shall be
35 strictly complied with in disbursement of said funds.

1 SECTION 12. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this act shall be in compliance with the stated reasons for
4 which this act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.
9

10 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the
11 General Assembly, that the Constitution of the State of Arkansas prohibits
12 the appropriation of funds for more than a one (1) year period; that the
13 effectiveness of this Act on July 1, 2013 is essential to the operation of
14 the agency for which the appropriations in this Act are provided, and that in
15 the event of an extension of the legislative session, the delay in the
16 effective date of this Act beyond July 1, 2013 could work irreparable harm
17 upon the proper administration and provision of essential governmental
18 programs. Therefore, an emergency is hereby declared to exist and this Act
19 being necessary for the immediate preservation of the public peace, health
20 and safety shall be in full force and effect from and after July 1, 2013.
