8 AN ACT TO ESTABLISH THE EIGHTY-NINTH SESSION PROJECTS
9 ACCOUNT WITHIN THE GENERAL IMPROVEMENT FUND; TO
10 DEFINE THE MONIES TO BE AVAILABLE IN SUCH ACCOUNT;
11 AND TO DEFINE THE PURPOSES FOR WHICH MONIES MAY BE
12 MADE AVAILABLE FROM THE GENERAL IMPROVEMENT FUND SO
13 THAT ADDITIONAL FUNDS CAN BE MADE AVAILABLE FOR THE
14 STATE BUDGET; AND FOR OTHER PURPOSES.

17 **Subtitle**

18 THE DISTRIBUTION OF THE EIGHTY-NINTH
19 SESSION PROJECTS ACCOUNT OF THE GENERAL
20 IMPROVEMENT FUND TO PROVIDE ADDITIONAL
21 FUNDS FOR THE STATE BUDGET.
22

23
24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. This Act may be cited as the "General Improvement
27 Distribution Act of 2013".
28

29 SECTION 2. There is hereby created and established on the books of the
30 Chief Fiscal Officer of the State, the State Treasurer and the State Auditor,
31 the "89th Session Projects Account" within the "General Improvement Fund",
32 into which shall be transferred and credited the respective monies as
33 hereinafter provided in this Act, to be used for providing financing, in the
34 manner set forth herein, for the various projects and purposes enumerated the
35 manner set forth herein, for the various projects and purposes enumerated in
36 this Act to be financed from said account.



1 Immediately upon the effective date of this Act, or as soon thereafter as is
2 practical, the State Treasurer shall transfer and credit to the "89th Session
3 Projects Account" of the "General Improvement Fund", upon certification of
4 the amounts thereof by the Chief Fiscal Officer of the State, the following:

5 (a) all unobligated and unallocated monies remaining in the "General
6 Improvement Fund" on June 30, 2013 which are not required to finance projects
7 to be financed there from pursuant to appropriations enacted by the 88th
8 General Assembly, or which have not been reappropriated or reallocated for
9 financing from the "General Improvement Fund" by the 89th General Assembly;

10 (b) any unobligated or unallocated funds remaining on July 2, 2013,
11 including all General Revenue Funds recovered from remaining fund balances in
12 the "General Revenue Allotment Reserve Fund" from monies accruing thereto
13 during the 2011-2013 fiscal biennium which are not required to finance
14 enactments of the 89th General Assembly that do not expire on June 30, 2013;

15 (c) interest earned on State Treasury fund balances as provided in
16 this subsection. For the period commencing on July 1, 2013, and ending June
17 30, 2015, the State Treasurer shall, after complying with provisions of

18 (1) Arkansas Code 27-70-204 for distributing interest income
19 earned from investment of average daily balances of the "State Highway and
20 Transportation Department Fund",

21 (2) Arkansas Code 15-41-110 for distributing interest earned from
22 investment of average daily balances of the "Game Protection Fund", and

23 (3) Arkansas Code 20-78-504 for the next one hundred thousand
24 dollars (\$100,000) of interest income received each fiscal year by the State
25 Treasurer for the "Arkansas Child Care Facilities Loan Guarantee Trust Fund",
26 credit to the "Budget Stabilization Trust Fund" or its successor fund, fifty
27 percent (50%) of the interest income received and credited to the "Securities
28 Reserve Fund", and credit to the "89th Session Projects Account" fifty
29 percent (50%) of the interest income received and credited to the "Securities
30 Reserve Fund" as certified by the Chief Fiscal Officer of the State, to
31 provide financing to the "89th Session Projects Account", until there has
32 been credited an amount, which when added to the other funds available for
33 such purposes will finance each of the projects or purposes hereinafter
34 enumerated;

35 (d) Those special revenues credited to the General Improvement
36 *Fund from estate taxes as set out in Arkansas Code 19-6-301(171);*

1 (e) Any available balance remaining in the 88th Session Projects
2 Account of the General Improvement Fund from funds set aside in (a)(1) and
3 (a)(2) of Section 3 of Act 1096 and Act 1117 of 2011, and Section 17 of Act
4 1095 and Act 1115 of 2011 to be made available and distributed as authorized
5 in Section 3(a)(2) herein.

6
7 SECTION 3. Of those moneys accruing to the 89th Session Projects
8 Account of the General Improvement Fund as set out in Section 2 of this Act,
9 the State Treasurer shall first set-aside one hundred eighty one million four
10 hundred eighty five thousand five hundred and fifty one dollars
11 (\$181,485,551), and any previous set aside remaining balance as made
12 available by Section 2(e), so much as may be available in the set side in
13 authorized in Section 3(b) of this Act, and a protected set aside amount not
14 to exceed fifteen million nine hundred eighty three thousand two hundred and
15 twenty four dollars (\$15,983,224) as set aside in (a)(7). Such funds set-
16 aside as enumerated in subsection (a)(1) through (a)(26) shall be fully
17 funded by June 30, 2015. Funds made available for (a)(1), (a)(2) and (d) may
18 be released in full or in portion thereof as enumerated, but shall not exceed
19 the maximum amount set out for the project. The Chief Fiscal Officer of the
20 State shall notify the Arkansas Legislative Council or the Joint Budget
21 Committee of the release of funds for projects enumerated in subsection (a)
22 and (d) at the same time that the Department of Finance and Administration is
23 notified.

13 (7)(A) An amount not to exceed fifteen million nine hundred eighty
14 three thousand two hundred and twenty four dollars (\$15,983,224) is to be a
15 "protected set aside" in the 89th Session Projects Account of the General
16 Improvement Fund which shall be transferred to the Medicaid Expansion Program
17 Account of the Tobacco Settlement Program Fund in the event and in the amount
18 that funds are not received by the State as authorized by the transfer
19 through the settlement agreement in the nearly decade old dispute between
20 Arkansas and the tobacco companies that signed the Master Settlement
21 Agreement as authorized in the Fund Transfer Provision - Medicaid Program in
22 Section 20 of HB1219 of 2013 as enacted by the 89th General Assembly.

23 (B) Further, if funds or a portion of the funds are received and
24 transferred as authorized in the Fund Transfer Provision - Medicaid Program
25 in Section 20 of HB1219 of 2013 as enacted by the 89th General Assembly any
26 remaining funds in the protected set aside not distributed in (a)7(A) shall
27 be distributed as authorized in Section 3(b) herein. If Section 3(b) is
28 fully funded any remaining funds shall be transferred to and remain in the
29 unobligated balances of the General Improvement Fund until otherwise
30 authorized by the General Assembly;

11 (b) Then the Treasurer of State shall first make monthly allocations on
12 the basis of fifty nine and three tenths percent (59.30%) of the total
13 available funds to the Executive Discretionary Division as set out in
14 subsection (d) and the remainder of the total available funds to the
15 Legislative Division listed in subsection (c). The Legislative Division
16 funds shall be used to provide funds to each project enumerated in subsection
17 (c) of this section in proportion that each project's allocation bears to the
18 total of the allocations of all projects enumerated in subsection (c).
19 Additional funds that may be received by the General Improvement Fund after
20 the projects in subsection (c) have been fully funded shall first be
21 transferred in an amount not to exceed ten million dollars (\$10,000,000) to
22 the set aside authorized in Section 3(a)(2) herein. Then any additional
23 funds shall remain in the General Improvement Fund for such purpose as may be
24 enacted by law, but shall not be a part of the 89th Session Projects Account.

25 Funds made available to the Executive Discretionary Division may be
26 used for any project or portion thereof enumerated within the Executive
27 Discretionary Division but not to exceed the amount set out in subsection (d)
28 for the project. The Chief Fiscal Officer of the State shall notify the
29 Arkansas Legislative Council or Joint Budget Committee of the Governor's
30 released funds for projects at the same time that the Department of Finance
31 and Administration is notified.

28 SECTION 4. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR

29 PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXECUTIVE DIVISION

30 FUNDING TRANSFER. Immediately upon the effective date of this act, the Chief

31 Fiscal Officer of the State shall transfer on his or her books and those of

32 the State Treasurer and the Auditor of the State any remaining unobligated

33 funds from the Executive Division of the 88th Session Projects Account of the

34 General Improvement Fund in subsection (d) of Section 3 of Acts 1096 and 1117

35 of 2011 to provide funding in addition to that set out in subsection (b) of

36 Section 3 of this Act, for the 89th Session Projects Account of the General

1 Improvement Fund for the Executive Division as set out in subsection (d) of
2 Section 3 herein.

3
4 SECTION 5. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
5 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND TRANSFER STATE LAND
6 DEPARTMENT. Immediately upon the effective date of this act, or as soon
7 thereafter as is practicable, the Chief Fiscal Officer of the State shall
8 transfer on his or her books and those of the State Treasurer and Auditor of
9 State the sum of one million dollars (\$1,000,000) from the cash funds of the
10 State Land Department to the 89th Session Projects Account of the General
11 Improvement Fund.

12
13 SECTION 6. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
14 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND TRANSFER. Immediately
15 upon the effective date of this act, the Chief Fiscal Officer of the State
16 shall transfer on his or her books and those of the State Treasurer and
17 Auditor of State the sum of ten million four hundred eighty eight dollars
18 three hundred and seventy nine dollars (\$10,488,379) from the Red River
19 Waterways Project Trust Fund to the 89th Session Projects Account of the
20 General Improvement Fund.

21
22 SECTION 7. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
23 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SENATE AND HOUSE BILL
24 REFERENCES. All Senate and House bills referenced in this Act are effective
25 as enacted by the 89th General Assembly in the 2013 Regular Session.

26
27 SECTION 8. DISBURSEMENT OF FUNDS. (a) Expenditure of the funds
28 authorized by the Eighty-Ninth General Assembly in either the regular, fiscal
29 or extraordinary session from the 89th Session Projects Account shall be made
30 only upon documentation to the Chief Fiscal Officer of the State, in such
31 form as deemed necessary, that all criteria or pre-conditions established in
32 the appropriation act have been met or in the case of state agencies, and
33 that a Method of Finance has been filed with the Office of Accounting in the
34 Department of Finance and Administration, if required.

35 (b) Any matching funds as may be provided in law shall be certified to the
36 Chief Fiscal Officer of the State prior to the commencement of the project.

1 (c) Any recipient of the funds appropriated herein:

2 (1) may be required to file a compliance audit and

3 (2) is also subject to an audit by the Division of Legislative Audit in
4 order to determine that the use of the funds was in compliance with the
5 intent and appropriated purposes of the General Assembly.

6

7 SECTION 9. (a) Any enactment of the 89th General Assembly in either
8 regular, fiscal or extraordinary session appropriating, transferring or
9 allocating funds to be payable from the "General Improvement Fund", for which
10 a specific allocation of funds is specifically authorized in this Act, shall
11 be deemed to be payable from the "89th Session Projects Account" within the
12 "General Improvement Fund" unless a specific intent is otherwise provided by
13 law.

14 (b) Any enactment of the 89th General Assembly, meeting in either Regular,
15 Fiscal or Extraordinary Session, appropriating, allocating or transferring
16 funds payable from the General Improvement Fund which is not enumerated in
17 this Act shall not be financed from monies accruing to the 89th Session
18 Projects Account, unless otherwise provided by law and funds are specifically
19 transferred from the 88th Session Projects Account to the 89th Session
20 Projects Account to fund the appropriation for the project

21 (c) Monies reappropriated by the 89th General Assembly for projects for
22 which appropriations were made by the 88th General Assembly, which are not
23 enumerated in this Act and which are made payable from the "General
24 Improvement Fund", shall be payable from the "88th Session Projects Account"
25 of the "General Improvement Fund" and allowances shall be made therefore in
26 arriving at the uncommitted and unobligated balance of monies in the "General
27 Improvement Fund" before making transfers there from to the "89th Session
28 Projects Account", as authorized by this Act.

29

30 SECTION 10. Distribution of funds for constructing and equipping the
31 radiation therapy institutes specified herein, shall be contingent upon the
32 provision of matching funds, including those monies previously raised but not
33 previously used to match state funds, on a dollar by dollar basis on behalf
34 of each such radiation therapy institute.

35

36 SECTION 11. Department of Finance and Administration Disbursing

1 Officer. The Chief Fiscal Officer of the State may distribute funds to the
2 projects in the Legislative Division enumerated under Department of Finance
3 and Administration - Disbursing Officer on a basis other than monthly after
4 prior review of the proposed calendar for disbursements by the Legislative
5 Council.

6
7 SECTION 12. This Act shall not be incorporated into the Arkansas Code
8 nor published separately as Special, Local and Temporary law.

9
10 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the General
11 Assembly that it has considered and enacted appropriations for construction
12 projects and other programs to be financed from the accumulated balances and
13 reserve funds available in the State Treasury; that the total of the enacted
14 appropriations exceed the estimated available funding available for such
15 projects and that the immediate passage of this Act is necessary to establish
16 a method of providing for the orderly financing and a system of priority for
17 the financing of such projects. Therefore, an emergency is declared to exist
18 and this act being immediately necessary for the preservation of the public
19 peace, health and safety shall become effective on July 1, 2013.
